AN ACT relating to health care; enacting provisions governing the certification and regulation of certified registered nurse anesthetists; authorizing a certified registered nurse anesthetist to order, prescribe, possess and administer controlled substances, poisons, dangerous drugs and devices under certain circumstances; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law provides for the certification of certified registered nurse  
2 anesthetists, who are registered nurses who: (1) have completed a nationally  
3 accredited program in the science of anesthesia; and (2) administer anesthetic  
4 agents to a person under the care of a licensed physician, a licensed dentist or a  
5 licensed podiatric physician. (NRS 632.014) **Section 2** of this bill requires the State  
6 Board of Nursing to issue a certificate of registration to practice as a certified  
7 registered nurse anesthetist to a registered nurse who meets the requirements  
8 prescribed by existing law for such certification and any additional requirements  
9 prescribed by the Board. **Section 2** also requires the Board to adopt regulations  
10 governing certified registered nurse anesthetists.

11 Existing law authorizes a registered nurse to possess and administer controlled  
12 substances and dangerous drugs under certain circumstances. (NRS 453.375,  
13 454.213) **Sections 3, 5, 10 and 16** of this bill additionally authorize a certified  
14 registered nurse anesthetist, under the supervision of a physician licensed to  
15 practice medicine or osteopathic medicine in this State, to order, prescribe, possess  
16 and administer controlled substances, poisons, dangerous drugs and devices to treat  
17 a person under the care of a licensed physician in a critical access hospital before,  
18 during and after surgery or childbirth. **Sections 6-9 and 11-15** of this bill make  
19 additional changes necessary to authorize a certified registered nurse anesthetist to  
20 order, prescribe, possess and administer controlled substances, poisons, dangerous



21 drugs and devices in such circumstances. A certified registered nurse anesthetist  
22 who unlawfully possesses, prescribes or administers a controlled substance,  
23 dangerous drug or poison would be subject to discipline and criminal and civil  
24 penalties to the same extent as other practitioners who unlawfully possess,  
25 prescribe or administer such drugs. (NRS 453.236, 453.305, 453.326, 453.3363,  
26 453.553, 454.170, 454.356)  
27 **Section 4** of this bill makes a conforming change to remove a provision now  
28 duplicated in **section 2**.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 632 of NRS is hereby amended by adding  
2 thereto the provisions set forth as sections 2 and 3 of this act.  
3 **Sec. 2. 1. *The Board shall issue a certificate of registration***  
4 ***to practice as a certified registered nurse anesthetist to an***  
5 ***applicant who:***  
6 ***(a) Has successfully completed a nationally accredited***  
7 ***program in the science of anesthesia; and***  
8 ***(b) Meets any additional requirements prescribed by the Board***  
9 ***pursuant to subsection 2.***  
10 **2. *The Board shall adopt regulations to carry out the***  
11 ***provisions of this section and section 3 of this act, including,***  
12 ***without limitation, regulations:***  
13 ***(a) Specifying any additional training, education and***  
14 ***experience necessary for certification as a certified registered***  
15 ***nurse anesthetist;***  
16 ***(b) Delineating the authorized scope of practice of a certified***  
17 ***registered nurse anesthetist; and***  
18 ***(c) Establishing the procedure to apply for certification as a***  
19 ***certified registered nurse anesthetist.***  
20 **Sec. 3. 1. *A certified registered nurse anesthetist may:***  
21 ***(a) Under the supervision of a physician licensed pursuant to***  
22 ***chapter 630 or 633 of NRS, order, prescribe, possess and***  
23 ***administer controlled substances, poisons, dangerous drugs and***  
24 ***devices to treat a patient under the care of a licensed physician in***  
25 ***a critical access hospital in preparation for surgery or childbirth,***  
26 ***during surgery or childbirth and while a patient recovers from***  
27 ***surgery or childbirth.***  
28 ***(b) Possess and administer controlled substances, poisons,***  
29 ***dangerous drugs and devices in other circumstances under which***  
30 ***a registered nurse is authorized to possess and administer***  
31 ***controlled substances, poisons, dangerous drugs and devices.***  
32 **2. *A certified registered nurse anesthetist shall not order or***  
33 ***prescribe a controlled substance, poison, dangerous drug or device***  
34 ***except as authorized by paragraph (a) of subsection 1.***

3 **the Secretary of Health and Human Services pursuant to 42**

10 ~~—2. Is] is~~ certified by the Board **pursuant to section 2 of this act**  
11 to administer anesthetic agents to a person under the care of a  
12 licensed physician, a licensed dentist or a licensed podiatric  
13 physician.

16       1. A physician, dentist, veterinarian or podiatric physician who

20 respect to or administer drugs in the course of professional practice  
21 or research in this State;

41 *nurse anesthetist* or veterinarian, or his or her agent, to a pharmacist  
42 or indirectly by means of an order signed by the practitioner or an  
43 electronic transmission from the practitioner to a pharmacist; or

44 (b) A chart order written for an inpatient specifying drugs which  
45 he or she is to take home upon his or her discharge.



1 2. The term does not include a chart order written for an  
2 inpatient for use while he or she is an inpatient.

4 453.226 1. Every practitioner or other person who dispenses  
5 any controlled substance within this State or who proposes to  
6 engage in the dispensing of any controlled substance within this  
7 State shall obtain biennially a registration issued by the Board in  
8 accordance with its regulations. A person must present proof that he  
9 or she is authorized to access the database of the program  
10 established pursuant to NRS 453.162 before the Board may issue or  
11 renew a registration.

12 2. A person registered by the Board in accordance with the  
13 provisions of NRS 453.011 to 453.552, inclusive, *and section 6 of*  
14 *this act* to dispense or conduct research with controlled substances  
15 may possess, dispense or conduct research with those substances to  
16 the extent authorized by the registration and in conformity with the  
17 other provisions of those sections.

19 lawfully possess and distribute controlled substances pursuant to the

4 453.336 1. Except as otherwise provided in subsection 6, a  
5 person shall not knowingly or intentionally possess a controlled  
6 substance, unless the substance was obtained directly from, or  
7 pursuant to, a prescription or order of a physician, physician  
8 assistant licensed pursuant to chapter 630 or 633 of NRS, dentist,  
9 podiatric physician, optometrist, advanced practice registered nurse,  
10 *certified registered nurse anesthetist* or veterinarian while acting in  
11 the course of his or her professional practice, or except as otherwise  
12 authorized by the provisions of NRS 453.005 to 453.552, inclusive  
13 **and section 6 of this act.**

14 2. Except as otherwise provided in subsections 3, 4 and 5 and  
15 in NRS 453.3363, and unless a greater penalty is provided in NRS  
16 212.160, 453.3385 or 453.339, a person who violates this section:

17 (a) For a first or second offense, if the controlled substance is  
18 listed in schedule I or II and the quantity possessed is less than 14

43 the controlled substance is listed in schedule III, IV or V and the

1 category B felony by imprisonment in the state prison for a  
2 minimum term of not less than 1 year and a maximum term of not  
3 more than 10 years and by a fine of not more than \$50,000.

4 (e) If the controlled substance is listed in schedule I or II and the  
5 quantity possessed is 42 grams or more, but less than 100 grams, is  
6 guilty of high-level possession of a controlled substance and shall be  
7 punished for a category B felony by imprisonment in the state prison  
8 for a minimum term of not less than 2 years and a maximum term of  
9 not more than 15 years and by a fine of not more than \$50,000.

10 3. Unless a greater penalty is provided in NRS 212.160,  
11 453.337 or 453.3385, a person who is convicted of the possession of  
12 flunitrazepam or gamma-hydroxybutyrate, or any substance for  
13 which flunitrazepam or gamma-hydroxybutyrate is an immediate  
14 precursor, is guilty of a category B felony and shall be punished by  
15 imprisonment in the state prison for a minimum term of not less  
16 than 1 year and a maximum term of not more than 6 years.

17 4. Unless a greater penalty is provided pursuant to NRS  
18 212.160, a person who is convicted of the possession of 1 ounce or  
19 less of marijuana is guilty of a misdemeanor and shall be punished  
20 by:

21 (a) Performing not more than 24 hours of community service;

22 (b) Attending the live meeting described in paragraph (a) of  
23 subsection 2 of NRS 484C.530 and complying with any other  
24 requirements set forth in that section; or

25 (c) Being required to undergo an evaluation in accordance with

33 provided in NRS 193.130.

34 6. It is not a violation of this section if a person possesses a  
35 trace amount of a controlled substance and that trace amount is in or  
36 on a hypodermic device obtained from a sterile hypodermic device  
37 program pursuant to NRS 439.985 to 439.994, inclusive.

38 7. The court may grant probation to or suspend the sentence of  
39 a person convicted of violating this section.

40 8. If a person fulfills the terms and conditions imposed for a  
41 violation of subsection 4, the court shall, without a hearing, order  
42 sealed all documents, papers and exhibits in that person's record,  
43 minute book entries and entries on dockets, and other documents  
44 relating to the case in the custody of such other agencies and  
45 officers as are named in the court's order. The court shall cause a





1 copy of the order to be sent to each agency or officer named in the  
2 order. Each such agency or officer shall notify the court in writing

13 453.256 and 453.3611 to 453.3648, inclusive, a physician, physician  
14 assistant, dentist, advanced practice registered nurse, *certified*  
15 *registered nurse anesthetist* or podiatric physician may prescribe or  
16 administer controlled substances only for a legitimate medical  
17 purpose and in the usual course of his or her professional practice,  
18 and he or she shall not prescribe, administer or dispense a controlled  
19 substance listed in schedule II for himself or herself, his or her  
20 spouse or his or her children except in cases of emergency.

21 2. A veterinarian, in the course of his or her professional  
22 practice only, and not for use by a human being, may prescribe,  
23 possess and administer controlled substances, and the veterinarian

25 the direction and supervision of the veterinarian.

26 3. A euthanasia technician, within the scope of his or her  
27 license, and not for use by a human being, may possess and

30 prescription if the pharmacist has reason to believe that it was not  
31 issued in the usual course of the professional practice of a physician,  
32 physician assistant, dentist, advanced practice registered nurse,  
33 *certified registered nurse anesthetist*, podiatric physician or  
34 veterinarian.

35 5. Any person who has obtained from a physician, physician  
36 assistant, dentist, advanced practice registered nurse, *certified*  
37 *registered nurse anesthetist*, podiatric physician or veterinarian any  
38 controlled substance for administration to a patient during the  
39 absence of the physician, physician assistant, dentist, advanced  
40 practice registered nurse, *certified registered nurse anesthetist*,  
41 podiatric physician or veterinarian shall return to him or her any  
42 unused portion of the substance when it is no longer required by the  
43 patient.

44 6. A manufacturer, wholesale supplier or other person legally  
45 able to furnish or sell any controlled substance listed in schedule II



1 shall not provide samples of such a controlled substance to  
2 registrants.

3 7. A salesperson of any manufacturer or wholesaler of  
4 pharmaceuticals shall not possess, transport or furnish any  
5 controlled substance listed in schedule II.

6 8. A person shall not dispense a controlled substance in  
7 violation of a regulation adopted by the Board.

8 **Sec. 15.** NRS 453.391 is hereby amended to read as follows:

9 453.391 A person shall not:

10 1. Unlawfully take, obtain or attempt to take or obtain a  
11 controlled substance or a prescription for a controlled substance  
12 from a manufacturer, wholesaler, pharmacist, physician, physician  
13 assistant, dentist, advanced practice registered nurse, *certified*  
14 *registered nurse anesthetist*, veterinarian or any other person  
15 authorized to administer, dispense or possess controlled substances.

16 2. While undergoing treatment and being supplied with any  
17 controlled substance or a prescription for any controlled substance  
18 from one practitioner, knowingly obtain any controlled substance or  
19 a prescription for a controlled substance from another practitioner
