SUMMARY—Revises provisions governing cultural competency training. (BDR 40-820)

AN ACT relating to healthcare; revising provisions relating to the requirement that certain medical facilities conduct training of agents and employees in cultural competency; requiring the Office of Minority Health and Equity of the Department of Health and Human Services to establish, maintain and distribute a list of courses and programs relating to cultural competency that certain medical facilities are required to use to conduct training of certain agents and employees; increasing the number of hours of instruction relating to cultural competency that certain mental health professionals are required to complete; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law provides that the State Board of Health shall require, by  
2 regulation, a medical facility, facility for the dependent and certain other facilities  
3 to conduct training relating specifically to cultural competency for any agent or  
4 employee of the facility so that such an agent or employee may better understand  
5 patients or residents who have different cultural backgrounds, including, without  
6 limitation, patients or residents who are: (1) from various racial and ethnic  
7 backgrounds; (2) from various religious backgrounds; (3) persons with various  
8 sexual orientations and gender identities or expressions; (4) children and senior  
9 citizens; (5) persons with a mental or physical disability; and (6) part of any other  
10 population that such an agent or employee may need to better understand. Such  
11 training relating to cultural competency must be provided through a course or



12 program that is approved by the Department of Health and Human Services. (NRS  
13 449.103) **Section 1** of this bill eliminates the requirement for the Board to adopt  
14 such regulations and provides instead that such facilities are required to conduct  
15 such training. **Section 1** further: (1) provides that the courses and programs on  
16 cultural competency must be approved by the Office of Minority Health and Equity  
17 of the Department of Health and Human Services; and (2) requires the Office to  
18 establish and maintain a list of such courses and programs and ensure that the list is  
19 distributed to each facility required to conduct the training on cultural competency.

20 Existing law requires, as a prerequisite for the renewal of a license, a physician,  
21 physician assistant, nurse, psychologist, marriage and family therapist, clinical  
22 professional counselor, social worker or behavior analyst to complete at least 2  
23 hours of instruction relating to cultural competency and diversity, equity and  
24 inclusion. (NRS 630.253, 632.343, 633.471, 641.220, 641A.260, 641B.280,  
25 641D.360) Existing law requires, as a prerequisite for the renewal of a license or  
26 certificate, a clinical alcohol and drug counselor or problem gambling counselor to  
27 complete at least 1 hour of instruction relating to cultural competency and diversity,  
28 equity and inclusion. (NRS 641C.450) **Sections 2-9** of this bill instead require such  
29 persons to complete at least 6 hours of instruction relating to cultural competency  
30 and diversity, equity and inclusion.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN

1 **Section 1.** NRS 449.103 is hereby amended to read as follows:

2 449.103 1. To enable an agent or employee of a medical

19 (e) Persons with a mental or physical disability; and  
20 (f) Part of any other population that such an agent or employee  
21 may need to better understand, as determined by the Board.

22 2. The training relating specifically to cultural competency

25 ~~pursuant to NRS 449.0303 to be licensed]~~ pursuant to subsection 1



1 must be provided through a course or program that is approved by  
2 the *Office of Minority Health and Equity of the* Department of

4 **3. *The Office of Minority Health and Equity shall:***

5 *(a) Establish and maintain a list of the courses and programs*  
6 *that are approved for training relating to cultural competency*  
7 *pursuant to subsection 2; and*

8 *(b) Ensure that the list established and maintained pursuant to*  
9 *paragraph (a) is distributed to each medical facility, facility for the*  
10 *dependent or other facility which is required to conduct training*  
11 *relating specifically to cultural competency pursuant to*  
12 *subsection 1.*

13 **Sec. 2.** NRS 630.253 is hereby amended to read as follows:

14 630.253 1. The Board shall, as a prerequisite for the:

15 (a) Renewal of a license as a physician assistant; or

16 (b) Biennial registration of the holder of a license to practice  
17 medicine,

18 ↪ require each holder to submit evidence of compliance with the  
19 requirements for continuing education as set forth in regulations  
20 adopted by the Board.

21 2. These requirements:

22 (a) May provide for the completion of one or more courses of  
23 instruction relating to risk management in the performance of

25 (b) Must provide for the completion of a course of instruction,

41 4. The Board shall encourage each holder of a license who  
42 treats or cares for persons who are more than 60 years of age to  
43 receive, as a portion of their continuing education, education in  
44 geriatrics and gerontology, including such topics as:



1 (a) The skills and knowledge that the licensee needs to address  
2 aging issues;

3 (b) Approaches to providing health care to older persons,  
4 including both didactic and clinical approaches;

5 (c) The biological, behavioral, social and emotional aspects of  
6 the aging process; and

7 (d) The importance of maintenance of function and  
8 independence for older persons.

9 5. The Board shall encourage each holder of a license to  
10 practice medicine to receive, as a portion of his or her continuing  
11 education, training concerning methods for educating patients about  
12 how to effectively manage medications, including, without  
13 limitation, the ability of the patient to request to have the symptom  
14 or purpose for which a drug is prescribed included on the label  
15 attached to the container of the drug.

16 6. The Board shall require each holder of a license to practice  
17 medicine to receive as a portion of his or her continuing education at  
18 least 2 hours of instruction every 4 years on evidence-based suicide  
19 prevention and awareness, which may include, without limitation,  
20 instruction concerning:

21 (a) The skills and knowledge that the licensee needs to detect  
22 behaviors that may lead to suicide, including, without limitation,  
23 post-traumatic stress disorder;

24 (b) Approaches to engaging other professionals in suicide  
25 intervention; and

26 (c) The detection of suicidal thoughts and ideations and the  
27 prevention of suicide.

28 7. The Board shall encourage each holder of a license to  
29 practice medicine or as a physician assistant to receive, as a portion  
30 of his or her continuing education, training and education in the  
31 diagnosis of rare diseases, including, without limitation:

32 (a) Recognizing the symptoms of pediatric cancer; and

33 (b) Interpreting family history to determine whether such  
34 symptoms indicate a normal childhood illness or a condition that  
35 requires additional examination.

36 8. A holder of a license to practice medicine may not substitute  
37 the continuing education credits relating to suicide prevention and  
38 awareness required by this section for the purposes of satisfying an  
39 equivalent requirement for continuing education in ethics.

40 9. Except as otherwise provided in NRS 630.2535, a holder of  
41 a license to practice medicine may substitute not more than 2 hours  
42 of continuing education credits in pain management, care for  
43 persons with an addictive disorder or the screening, brief  
44 intervention and referral to treatment approach to substance use



1 disorder for the purposes of satisfying an equivalent requirement for  
2 continuing education in ethics.

3 10. As used in this section:

4 (a) "Act of terrorism" has the meaning ascribed to it in  
5 NRS 202.4415.

6 (b) "Biological agent" has the meaning ascribed to it in  
7 NRS 202.442.

8 (c) "Chemical agent" has the meaning ascribed to it in  
9 NRS 202.4425.

10 (d) "Radioactive agent" has the meaning ascribed to it in  
11 NRS 202.4437.

12 (e) "Weapon of mass destruction" has the meaning ascribed to it  
13 in NRS 202.4445.

14 **Sec. 3.** NRS 632.343 is hereby amended to read as follows:

15 632.343 1. The Board shall not renew any license issued  
16 under this chapter until the licensee has submitted proof satisfactory  
17 to the Board of completion, during the 2-year period before renewal  
18 of the license, of 30 hours in a program of continuing education  
19 approved by the Board in accordance with regulations adopted by  
20 the Board. Except as otherwise provided in subsection 3, the  
21 licensee is exempt from this provision for the first biennial period  
22 after graduation from:

23 (a) An accredited school of professional nursing;

24 (b) An accredited school of practical nursing;

25 (c) An approved school of professional nursing in the process of  
26 obtaining accreditation; or

27 (d) An approved school of practical nursing in the process of  
28 obtaining accreditation.

29 2. The Board shall review all courses offered to nurses for the  
30 completion of the requirement set forth in subsection 1. The Board  
31 may approve nursing and other courses which are directly related to  
32 the practice of nursing as well as others which bear a reasonable  
33 relationship to current developments in the field of nursing or any  
34 special area of practice in which a licensee engages. These may  
35 include academic studies, workshops, extension studies, home study  
36 and other courses.

37 3. The program of continuing education required by subsection

5 relating to the medical consequences of an act of terrorism that  
6 involves the use of a weapon of mass destruction. The course must  
7 provide at least 4 hours of instruction that includes instruction in the  
8 following subjects:

9 (1) An overview of acts of terrorism and weapons of mass  
10 destruction;

11 (2) Personal protective equipment required for acts of  
12 terrorism;

13 (3) Common symptoms and methods of treatment associated  
14 with exposure to, or injuries caused by, chemical, biological,  
15 radioactive and nuclear agents;

7 required by paragraph (b) of subsection 3.

8 5. The Board shall encourage each licensee who treats or cares  
9 for persons who are more than 60 years of age to receive, as a  
10 portion of their continuing education, education in geriatrics and  
11 gerontology, including such topics as:

12 (a) The skills and knowledge that the licensee needs to address  
13 aging issues;

14 (b) Approaches to providing health care to older persons,  
15 including both didactic and clinical approaches;

16 (c) The biological, behavioral, social and emotional aspects of  
17 the aging process; and

18 (d) The importance of maintenance of function and  
19 independence for older persons.

20 6. The Board shall require each person licensed as an advanced  
21 practice registered nurse to receive as a portion of his or her  
22 continuing education at least 2 hours of instruction every 4 years on  
23 evidence-based suicide prevention and awareness or another course  
24 of instruction on suicide prevention and awareness that is approved  
25 by the Board which the Board has determined to be effective and  
26 appropriate.

27 7. The Board shall encourage each person licensed as an  
28 advanced practice registered nurse to receive, as a portion of his or  
29 her continuing education, training and education in the diagnosis of  
30 rare diseases, including, without limitation:

31 (a) Recognizing the symptoms of pediatric cancer; and

**Sec. 4.** NRS 633.471 is hereby amended to read as follows:

633.471 1. Except as otherwise provided in subsection 14 and NRS 633.491, every holder of a license, except a physician assistant, issued under this chapter, except a temporary or a special license, may renew the license on or before January 1 of each calendar year after its issuance by:

(a) Applying for renewal on forms provided by the Board;

(b) Paying the annual license renewal fee specified in this chapter;

(c) Submitting a list of all actions filed or claims submitted to arbitration or mediation for malpractice or negligence against the holder during the previous year;

(d) Subject to subsection 13, submitting evidence to the Board that in the year preceding the application for renewal the holder has attended courses or programs of continuing education approved by the Board in accordance with regulations adopted by the Board totaling a number of hours established by the Board which must not be less than 35 hours nor more than that set in the requirements for continuing medical education of the American Osteopathic Association; and

(e) Submitting all information required to complete the renewal.

2. The Secretary of the Board shall notify each licensee of the requirements for renewal not less than 30 days before the date of renewal.

3. The Board shall request submission of verified evidence of completion of the required number of hours of continuing medical education annually from no fewer than one-third of the applicants for renewal of a license to practice osteopathic medicine or a license to practice as a physician assistant. Subject to subsection 13, upon a request from the Board, an applicant for renewal of a license to practice osteopathic medicine or a license to practice as a physician assistant shall submit verified evidence satisfactory to the Board that in the year preceding the application for renewal the applicant attended courses or programs of continuing medical education approved by the Board totaling the number of hours established by the Board.

4. The Board shall require each holder of a license to practice osteopathic medicine to complete a course of instruction within 2 years after initial licensure that provides at least 2 hours of instruction on evidence-based suicide prevention and awareness as described in subsection 9.

5. The Board shall encourage each holder of a license to practice osteopathic medicine to receive, as a portion of his or her continuing education, training concerning methods for educating patients about how to effectively manage medications, including,



1 without limitation, the ability of the patient to request to have the  
2 symptom or purpose for which a drug is prescribed included on the  
3 label attached to the container of the drug.

4 6. The Board shall encourage each holder of a license to  
5 practice osteopathic medicine or as a physician assistant to receive,  
6 as a portion of his or her continuing education, training and  
7 education in the diagnosis of rare diseases, including, without  
8 limitation:

9 (a) Recognizing the symptoms of pediatric cancer; and

10 (b) Interpreting family history to determine whether such  
11 symptoms indicate a normal childhood illness or a condition that  
12 requires additional examination.

13 7. The Board shall require, as part of the continuing education  
14 requirements approved by the Board, the biennial completion by a  
15 holder of a license to practice osteopathic medicine of at least 2  
16 hours of continuing education credits in ethics, pain management,  
17 care of persons with addictive disorders or the screening, brief  
18 intervention and referral to treatment approach to substance use

20 8. The continuing education requirements approved by the

22 or physician assistant to receive credit toward the total amount of  
23 continuing education required by the Board for the completion of a  
24 course of instruction relating to genetic counseling and genetic  
25 testing.

26 9. The Board shall require each holder of a license to practice  
27 osteopathic medicine to receive as a portion of his or her continuing  
28 education at least 2 hours of instruction every 4 years on evidence-  
29 based suicide prevention and awareness which may include, without  
30 limitation, instruction concerning:

31 (a) The skills and knowledge that the licensee needs to detect  
32 behaviors that may lead to suicide, including, without limitation,  
33 post-traumatic stress disorder;

4 assistant practicing under the supervision of a psychiatrist to  
5 biennially complete one or more courses of instruction that provide

7 diversity, equity and inclusion. Such instruction:

8 (a) May include the training provided pursuant to NRS 449.103,  
9 where applicable.

10 (b) Must be based upon a range of research from diverse  
11 sources.

12 (c) Must address persons of different cultural backgrounds,  
13 including, without limitation:

14 (1) Persons from various gender, racial and ethnic

43 (b) Pay the biennial fee for the renewal of a license;



1 (c) Submit evidence to the Board of completion of the

5 2. Upon renewing his or her license, a psychologist shall
