

ASSEMBLY BILL NO. 403—COMMITTEE ON  
HEALTH AND HUMAN SERVICES

SUMMARY—Revises provisions governing halfway houses for persons recovering from alcohol or other substance use disorders. (BDR 40-1057)

AN ACT relating to medical facilities; removing a halfway house for persons recovering from alcohol or other substance use disorders from the definition of a facility for the dependent; revising terminology used to refer to such facilities; removing the requirement that such a facility be licensed and regulated as a facility for the dependent; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

Existing law: (1) requires a facility for the dependent to be licensed by the Division of Public and Behavioral Health of the Department of Health and Human Services; (2) imposes certain duties on a facility for the dependent concerning treatment of patients; (3) requires agents and employees of a facility for the dependent to receive cultural competency training; (4) prohibits a facility for the dependent from using a misleading name; and (5) exempts a facility for the dependent from a requirement that imposes certain safeguards relating to smoking from a requirement to equip every door to an exit corridor which serves 30 or more occupants with a device which closes the door. (NRS 449.030, 449.101-449.104, 449.204, 449A.100-449A.118, 477.120) Existing law requires a halfway house for persons recovering from alcohol or other substance use disorders to be licensed as a facility for the dependent and otherwise follow the laws and regulations governing facilities for the dependent. (NRS 449.0045, 449.030) Existing law also requires a facility for the education, prevention and treatment of persons with alcohol or other substance use disorders, including a halfway house for persons recovering from alcohol or other substance use disorders, to be certified by the Division. (NRS 458.025) **Section 1** of this bill removes the designation of a halfway house for persons recovering from alcohol or substance use disorders as a facility for the dependent, thereby: (1) removing the requirement that such a halfway house be



20 licensed by the Division while preserving the requirement that such a halfway  
21 house be certified by the Division; and (2) excluding such a halfway house from the  
22 duties, requirements, prohibitions and exemptions that apply to a facility for the  
23 dependent. **Section 3** of this bill makes a conforming change to remove a  
24 requirement that the Division post on the Internet information concerning the  
25 licensing status and quality of halfway houses for persons recovering from alcohol  
26 or other substance use disorders. **Section 5** of this bill makes a conforming change  
27 to remove a reference to a halfway house for persons recovering from alcohol or  
28 other substance use disorders as a type of facility for the dependent. **Sections 2 and**  
29 **6-9** of this bill replace the term “halfway house for persons recovering from alcohol  
30 or other substance use disorders” with the term “recovery house for persons  
31 recovering from alcohol or other substance use disorders.” **Section 4** of this bill  
32 preserves certain immunity from liability for volunteers of a recovery house for  
33 persons recovering from alcohol or other substance use disorders.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN

1 **Section 1.** NRS 449.0045 is hereby amended to read as

14 **Sec. 4.** NRS 41.485 is hereby amended to read as follows:

15 41.485 1. Except as otherwise provided in subsection 2, a  
16 volunteer of a charitable organization is immune from liability for  
17 civil damages as a result of an act or omission:

18 (a) Of an agent of the charitable organization; or

19 (b) Concerning services the volunteer performs for the  
20 charitable organization that are not supervisory in nature and are not  
21 part of any duties or responsibilities the volunteer may have as an  
22 officer, director or trustee of the charitable organization, unless the  
23 act is intentional, willful, wanton or malicious.

24 2. This section does not restrict the liability of a charitable  
25 organization for the acts or omissions of a volunteer performing  
26 services on its behalf.

27 3. As used in this section:

28 (a) "Agent" means an officer, director, trustee or employee,  
29 whether or not compensated, or a volunteer;

30 (b) "Charitable organization" means a nonprofit corporation,

36 (c) *"Recovery house for persons recovering from alcohol or*  
37 *other substance use disorders" has the meaning ascribed to it in*

39 (d) "Volunteer" means an officer, director, trustee or other  
40 person who performs services without compensation, other than  
41 reimbursement for actual and necessary expenses on behalf of or to  
42 benefit a charitable organization.

2       129.050 1. Except as otherwise provided in NRS 449A.551

6       (b) If unable to give express consent, shall be deemed to

34 regulating or imposing any requirement with respect to such a  
35 facility, home, house or institution.

36 3. The governing body of a city is not required to include a  
37 term set forth in subsection 1 in the ordinance if:

38 (a) A facility, home, house or institution of the type  
39 corresponding to the term does not exist in the city; or

40 (b) The city’s ordinances do not otherwise, by whatever name,  
41 refer to a facility, home, house or institution of the type  
42 corresponding to the term.

43 **Sec. 8.** NRS 278.02374 is hereby amended to read as follows:

7 *living for released offenders.*

8 **Sec. 9.** The Legislative Counsel shall:

9 1. In preparing the Nevada Revised Statutes, use the authority  
10 set forth in subsection 10 of NRS 220.120 to substitute  
11 appropriately the term “recovery house for persons recovering from  
12 alcohol and other substance use disorders” for the term “halfway  
13 house for persons recovering from alcohol and other substance use  
14 disorders.”

15 2. In preparing supplements to the Nevada Administrative  
16 Code, substitute appropriately the term “recovery house for persons  
17 recovering from alcohol and other substance use disorders” for the  
18 term “halfway house for persons recovering from alcohol and other  
19 substance use disorders.”

20 **Sec. 10.** This act becomes effective on July 1, 2023.
