AN ACT making appropriations for various purposes relating to health, education and employment; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** 1. There is hereby appropriated from the State
- 2     General Fund to the Interim Finance Committee the sum of
- 3     \$750,000 for allocation to the International Gaming Institute of the
- 4     University of Nevada, Las Vegas, for the “Expanding the
- 5     Leaderverse” initiative to increase the diversity of the leadership in
- 6     the gaming industry.
- 7     2. Allocation of the money appropriated by subsection 1 is
- 8     contingent upon matching money being obtained by the
- 9     International Gaming Institute, including, without limitation, gifts,
- 10    grants and donations to the International Gaming Institute from
- 11    private and public sources of money other than the appropriation
- 12    made by subsection 1. The Interim Finance Committee shall not
- 13    direct the transfer of any portion of money from the appropriation
- 14    made by subsection 1 until the International Gaming Institute
- 15    submits to the Committee proof satisfactory to the Committee that
- 16    matching money in an equivalent amount has been committed.
- 17    3. Any remaining balance of the appropriation made by
- 18    subsection 1 must not be committed for expenditure after June 30,



1 2025, by the entity to which the appropriation is made or any entity  
2 to which money from the appropriation is granted or otherwise  
3 transferred in any manner, and any portion of the appropriated  
4 money remaining must not be spent for any purpose after  
5 September 19, 2025, by either the entity to which the money was  
6 appropriated or the entity to which the money was subsequently  
7 granted or transferred, and must be reverted to the State General  
8 Fund on or before September 19, 2025.

9 **Sec. 2.** 1. There is hereby appropriated from the State  
10 General Fund to United Way of Northern Nevada the sum of  
11 \$1,200,000 for its activities related to public health, education and  
12 improving economic mobility.

13 2. Upon acceptance of the money appropriated by subsection 1,  
14 United Way of Northern Nevada agrees to:

15 (a) Prepare and transmit a report to the Interim Finance  
16 Committee on or before December 20, 2024, that describes each  
17 expenditure made from the money appropriated by subsection 1  
18 from the date on which the money was received by United Way of  
19 Northern Nevada through December 1, 2024;

20 (b) Prepare and transmit a final report to the Interim Finance  
21 Committee on or before September 19, 2025, that describes each  
22 expenditure made from the money appropriated by subsection 1  
23 from the date on which the money was received by United Way of  
24 Northern Nevada through June 30, 2025; and

25 (c) Upon request of the Legislative Commission, make available  
26 to the Legislative Auditor any of the books, accounts, claims,  
27 reports, vouchers or other records of information, confidential or  
28 otherwise, of United Way of Northern Nevada, regardless of their  
29 form or location, that the Legislative Auditor deems necessary to  
30 conduct an audit of the use of the money appropriated by  
31 subsection 1.

32 3. Any remaining balance of the appropriation made by  
33 subsection 1 must not be committed for expenditure after June 30,  
34 2025, by the entity to which the appropriation is made or any entity  
35 to which money from the appropriation is granted or otherwise  
36 transferred in any manner, and any portion of the appropriated  
37 money remaining must not be spent for any purpose after  
38 September 19, 2025, by either the entity to which the money was  
39 appropriated or the entity to which the money was subsequently  
40 granted or transferred, and must be reverted to the State General  
41 Fund on or before September 19, 2025.

42 **Sec. 3.** 1. There is hereby appropriated from the State  
43 General Fund to the Foundation for an Independent Tomorrow the  
44 sum of \$2,000,000 for its activities related to vocational training, job  
45 preparation, education and employment services.



1 2. Upon acceptance of the money appropriated by subsection 1,  
2 the Foundation for an Independent Tomorrow agrees to:

3 (a) Prepare and transmit a report to the Interim Finance  
4 Committee on or before December 20, 2024, that describes each  
5 expenditure made from the money appropriated by subsection 1  
6 from the date on which the money was received by the Foundation  
7 for an Independent Tomorrow through December 1, 2024;

8 (b) Prepare and transmit a final report to the Interim Finance  
9 Committee on or before September 19, 2025, that describes each  
10 expenditure made from the money appropriated by subsection 1  
11 from the date on which the money was received by the Foundation  
12 for an Independent Tomorrow through June 30, 2025; and

13 (c) Upon request of the Legislative Commission, make available  
14 to the Legislative Auditor any of the books, accounts, claims,  
15 reports, vouchers or other records of information, confidential or  
16 otherwise, of the Foundation for an Independent Tomorrow,  
17 regardless of their form or location, that the Legislative Auditor  
18 deems necessary to conduct an audit of the use of the money  
19 appropriated by subsection 1.

20 3. Any remaining balance of the appropriation made by  
21 subsection 1 must not be committed for expenditure after June 30,  
22 2025, by the entity to which the appropriation is made or any entity  
23 to which money from the appropriation is granted or otherwise  
24 transferred in any manner, and any portion of the appropriated  
25 money remaining must not be spent for any purpose after  
26 September 19, 2025, by either the entity to which the money was  
27 appropriated or the entity to which the money was subsequently  
28 granted or transferred, and must be reverted to the State General  
29 Fund on or before September 19, 2025.

30 **Sec. 4.** This act becomes effective upon passage and approval.
