

ASSEMBLY BILL NO. 525—COMMITTEE ON WAYS AND MEANS

Referred to Committee on Ways and Means

AN ACT making appropriations for various purposes relating to health, education, employment and other community services; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     **Section 1.** 1. There is hereby appropriated from the State  
2 General Fund to the Interim Finance Committee the sum of  
3 \$500,000 for allocation to the International Gaming Institute of the  
4 University of Nevada, Las Vegas, for the “Expanding the  
5 Leaderverse” initiative to increase the diversity of the leadership in  
6 the gaming industry.  
7     2. Allocation of the money appropriated by subsection 1 is  
8 contingent upon matching money being obtained by the  
9 International Gaming Institute, including, without limitation, gifts,  
10 grants and donations to the International Gaming Institute from  
11 private and public sources of money other than the appropriation  
12 made by subsection 1. The Interim Finance Committee shall not  
13 direct the transfer of any portion of money from the appropriation  
14 made by subsection 1 until the International Gaming Institute  
15 submits to the Committee proof satisfactory to the Committee that  
16 matching money in an equivalent amount has been committed.



1     **Sec. 1.5.** There is hereby appropriated from the State General  
2 Fund to the Interim Finance Committee the sum of \$2,500,000 for  
3 allocation to the nonprofit corporation formed to establish an art  
4 museum in Las Vegas, Nevada, upon a showing to the Committee:

5         1. That the corporation has been incorporated under the laws of  
6 this State as a nonprofit corporation; and

7         2. That the purpose of the corporation is to establish an art  
8 museum in Las Vegas, Nevada.

9     **Sec. 2.** There is hereby appropriated from the State General  
10 Fund to United Way of Northern Nevada the sum of \$1,200,000 for  
11 its activities related to public health, education and improving  
12 economic mobility.

13     **Sec. 3.** There is hereby appropriated from the State General  
14 Fund to the Foundation for an Independent Tomorrow the sum of  
15 \$2,000,000 for its activities related to vocational training, job  
16 preparation, education and employment services.

17     **Sec. 4.** There is hereby appropriated from the State General  
18 Fund to the Culinary Academy of Las Vegas the sum of  
19 \$15,000,000 for its capital improvement plan.

20     **Sec. 5.** There is hereby appropriated from the State General  
21 Fund to A Source of Joy Theatricals, Inc. the sum of \$1,000,000 for  
22 the Legacy Theatre Project.

23     **Sec. 6.** There is hereby appropriated from the State General  
24 Fund to the Food Bank of Northern Nevada the sum of \$2,000,000  
25 to address food insecurities of residents of this State.

26     **Sec. 7.** There is hereby appropriated from the State General  
27 Fund to the Three Square Food Bank the sum of \$2,000,000 to  
28 address food insecurities of residents of this State.

29     **Sec. 8.** There is hereby appropriated from the State General  
30 Fund to Boys Town Nevada the sum of \$250,000 for its programs  
31 and services.

32     **Sec. 9.** There is hereby appropriated from the State General  
33 Fund to Foster Kinship the sum of \$750,000 for the Kinship  
34 Navigator Program.

35     **Sec. 10.** There is hereby appropriated from the State General  
36 Fund to HopeLink of Southern Nevada the sum of \$2,000,000 for  
37 wraparound services for families at risk of homelessness.

38     **Sec. 11.** There is hereby appropriated from the State General  
39 Fund to Catholic Charities of Southern Nevada the sum of  
40 \$2,000,000 for the Meals on Wheels Program.

41     **Sec. 12.** There is hereby appropriated from the State General  
42 Fund to the Candlelighters Childhood Cancer Foundation of Nevada  
43 the sum of \$1,000,000 for the provision of assistance to children  
44 affected by cancer and their families.



1     **Sec. 13.** There is hereby appropriated from the State General  
2 Fund to Legal Aid Center of Southern Nevada the sum of \$250,000  
3 for programs and services relating to tenants' rights.

4     **Sec. 14.** There is hereby appropriated from the State General  
5 Fund to the United Way of Southern Nevada the sum of \$1,200,000  
6 for its activities related to public health, education and improving  
7 economic mobility.

8     **Sec. 15.** There is hereby appropriated from the State General  
9 Fund to Goodwill of Southern Nevada the sum of \$1,500,000 for  
10 transforming workforce development initiatives.

11    **Sec. 16.** There is hereby appropriated from the State General  
12 Fund to the Special Olympics Nevada the sum of \$250,000 for its  
13 programs.

14    **Sec. 17.** There is hereby appropriated from the State General  
15 Fund to Friends in Service Helping the sum of \$3,000,000 for a  
16 capital improvement project.

17    **Sec. 18.** There is hereby appropriated from the State General  
18 Fund to the United Labor Agency of Nevada, Inc. the sum of  
19 \$500,000 for providing community services.

20    **Sec. 19.** There is hereby appropriated from the State General  
21 Fund to the Community Health Alliance the sum of \$4,500,000 for a  
22 capital improvement project.

23    **Sec. 20.** There is hereby appropriated from the State General  
24 Fund to Chicanos Por La Causa Nevada, Inc. the sum of \$10,000 for  
25 economic empowerment of low-income persons.

26    **Sec. 21.** There is hereby appropriated from the State General  
27 Fund to the Latino Youth Leadership Foundation the sum of  
28 \$10,000 to assist high school pupils with leadership training and  
29 development.

30    **Sec. 22.** There is hereby appropriated from the State General  
31 Fund to the Nevada Latino Bar Association the sum of \$10,000 to  
32 provide assistance for preparation for the admission test for law  
33 school.

34    **Sec. 23.** There is hereby appropriated from the State General  
35 Fund to Project 150 the sum of \$10,000 to provide support to  
36 homeless, displaced and disadvantaged high school pupils.

37    **Sec. 24.** There is hereby appropriated from the State General  
38 Fund to the South-Asian Women's Alliance of Nevada the sum of  
39 \$10,000 to bridge the gap between South-Asian communities and  
40 resources in Southern Nevada.

41    **Sec. 25.** There is hereby appropriated from the State General  
42 Fund to Leaders in Training the sum of \$250,000 for educational  
43 training, support and programming for first-generation college  
44 students.



1     **Sec. 26.** There is hereby appropriated from the State General  
2 Fund to the Uplift Foundation of Nevada the sum of \$10,000 for its  
3 programs and services.

4     **Sec. 27.** There is hereby appropriated from the State General  
5 Fund to The Foundation Christian Center the sum of \$10,000 for its  
6 food programs.

7     **Sec. 28.** There is hereby appropriated from the State General  
8 Fund to King of Jewels the sum of \$10,000 for its programs.

9     **Sec. 29.** There is hereby appropriated from the State General  
10 Fund to The Cupcake Girls the sum of \$ 10,000 for services for  
11 persons affected by sex trafficking.

12     **Sec. 30.** There is hereby appropriated from the State General  
13 Fund to HELP of Southern Nevada the sum of \$25,000 for the  
14 Shannon West Homeless Youth Center.

15     **Sec. 31.** There is hereby appropriated from the State General  
16 Fund to T.U.L.I.P.S. (Teaching and Uniting Ladies to Inspire  
17 Positive Success) the sum of \$25,000 for its programs.

18     **Sec. 32.** There is hereby appropriated from the State General  
19 Fund to Gentleman By Choice Community Development  
20 Corporation the sum of \$25,000 for its programs.

21     **Sec. 33.** There is hereby appropriated from the State General  
22 Fund to Spread the Word Nevada the sum of \$500,000 for providing  
23 books to advance childhood literacy.

24     **Sec. 34.** There is hereby appropriated from the State General  
25 Fund to Northern Nevada HOPES the sum of \$2,000,000 for  
26 providing primary and behavioral health care services.

27     **Sec. 35.** There is hereby appropriated from the State General  
28 Fund to the Pioneer Center for the Performing Arts the sum of  
29 \$1,000,000 for a renovation project.

30     **Sec. 36.** There is hereby appropriated from the State General  
31 Fund to Nevada Partners, Inc. the sum of \$1,000,000 to assist with  
32 its summer and educational program.

33     **Sec. 37.** There is hereby appropriated from the State General  
34 Fund to the Nevada Small Business Development Center the sum of  
35 \$1,000,000 for its programs.

36     **Sec. 38.** There is hereby appropriated from the State General  
37 Fund to the Nevada State Prison Preservation Society the sum of  
38 \$1,000,000 for a capital improvement project.

39     **Sec. 39.** There is hereby appropriated from the State General  
40 Fund to the Boys & Girls Clubs of Southern Nevada the sum of  
41 \$250,000 for its programs.

42     **Sec. 40.** There is hereby appropriated from the State General  
43 Fund to the Boys & Girls Club of Truckee Meadows the sum of  
44 \$250,000 for its programs.



1     **Sec. 41.** There is hereby appropriated from the State General  
2 Fund to Opportunity Village the sum of \$250,000 for its programs  
3 and services.

4     **Sec. 42.** There is hereby appropriated from the State General  
5 Fund to the Urban Chamber Community Development Corporation  
6 the sum of \$100,000 for its Nevada Small Business Development  
7 Center.

8     **Sec. 43.** There is hereby appropriated from the State General  
9 Fund to The Neon Museum the sum of \$1,000,000 for a capital  
10 improvement project.

11    **Sec. 44.** There is hereby appropriated from the State General  
12 Fund to the Economic Opportunity Board of Clark County the sum  
13 of \$100,000 for its programs.

14    **Sec. 45.** There is hereby appropriated from the State General  
15 Fund to the Nevada Partnership for Homeless Youth the sum of  
16 \$50,000 for its programs.

17    **Sec. 46.** There is hereby appropriated from the State General  
18 Fund to the Vision Theatrical Foundation, Inc. the sum of \$10,000  
19 for its programs.

20    **Sec. 47.** There is hereby appropriated from the State General  
21 Fund to Communities in Schools of Nevada the sum of \$1,000,000  
22 for its programs.

23    **Sec. 48.** There is hereby appropriated from the State General  
24 Fund to the Greater Youth Sports Association the sum of \$5,000 for  
25 its programs.

26    **Sec. 49.** There is hereby appropriated from the State General  
27 Fund to the Obodo Collective the sum of \$10,000 for its programs.

28    **Sec. 50.** There is hereby appropriated from the State General  
29 Fund to U.S. VETS - Las Vegas the sum of \$25,000 for its activities  
30 to assist in the successful transition of military veterans and their  
31 families.

32    **Sec. 51.** There is hereby appropriated from the State General  
33 Fund to the National Alliance on Mental Illness (NAMI) Southern  
34 Nevada the sum of \$25,000 for providing mental health support  
35 groups, classes, presentations and other resources without charge.

36    **Sec. 52.** There is hereby appropriated from the State General  
37 Fund to the Arriba Las Vegas Worker Center the sum of \$10,000 for  
38 its activities to develop, educate and empower worker and migrant  
39 communities.

40    **Sec. 53.** There is hereby appropriated from the State General  
41 Fund to Puentes the sum of \$10,000 for its programs and services.

42    **Sec. 53.3.** There is hereby appropriated from the State General  
43 Fund to The Arc Nevada the sum of \$250,000 for its programs and  
44 services.



1     **Sec. 53.7.** There is hereby appropriated from the State General  
2 Fund to the College of Southern Nevada the sum of \$4,500,000 for  
3 its Center For Excellence in Public Safety.

4     **Sec. 54.** There is hereby appropriated from the State General  
5 Fund to Teach for America the sum of \$25,000 for its programs.

6     **Sec. 55.** Upon acceptance of the money appropriated by this  
7 act, the entity that accepts the money agrees to:

8         1. Prepare and transmit a report to the Interim Finance  
9 Committee on or before December 20, 2024, that describes each  
10 expenditure made from the money appropriated by this act from the  
11 date on which the money was received by the entity through  
12 December 1, 2024;

13         2. Prepare and transmit a final report to the Interim Finance  
14 Committee on or before September 19, 2025, that describes each  
15 expenditure made from the money appropriated by this act from the  
16 date on which the money was received by the entity through  
17 June 30, 2025; and

18         3. Upon request of the Legislative Commission, make available  
19 to the Legislative Auditor any of the books, accounts, claims,  
20 reports, vouchers or other records of information, confidential or  
21 otherwise, of the entity, regardless of their form or location, that the  
22 Legislative Auditor deems necessary to conduct an audit of the use  
23 of the money appropriated by this act.

24     **Sec. 56.** Any remaining balance of the appropriations made by  
25 sections 1 to 54, inclusive, of this act must not be committed for  
26 expenditure after June 30, 2025, by the entity to which the  
27 appropriation is made or any entity to which money from the  
28 appropriation is granted or otherwise transferred in any manner, and  
29 any portion of the appropriated money remaining must not be spent  
30 for any purpose after September 19, 2025, by either the entity to  
31 which the money was appropriated or the entity to which the money  
32 was subsequently granted or transferred, and must be reverted to the  
33 State General Fund on or before September 19, 2025.

34     **Sec. 57.** This act becomes effective upon passage and  
35 approval.
