SUMMARY—Revises provisions relating to emergency medical services. (BDR 40-511)

AN ACT relating to emergency medical services; ratifying the Recognition of Emergency Medical Services Personnel Licensure Interstate Compact; making an appropriation; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law generally provides for the certification and regulation of advanced  
2 emergency medical technicians, emergency medical technicians and paramedics in this State.  
3 (Chapter 450B of NRS) **Section 2** of this bill ratifies the Recognition of Emergency Medical  
4 Services Personnel Licensure Interstate Compact. The Compact authorizes: (1) emergency  
5 medical service personnel who are certified in this State to perform their professional duties in  
6 any other state that has ratified the Compact; and (2) emergency medical service personnel  
7 who are certified in another state that has ratified the Compact to perform their professional  
8 duties in this State. **Sections 1, 3-7 and 9-21** of this bill make various changes to clarify that a  
9 person who is authorized to practice as an emergency medical technician, advanced  
10 emergency medical technician or paramedic under the Compact, including by serving as an  
11 attendant on an ambulance or air ambulance: (1) is not prohibited from doing so because he or  
12 she is not licensed or certified in this State; and (2) is legally equivalent to an emergency  
13 medical technician, advanced emergency medical technician or paramedic who is certified in  
14 this State for certain purposes. **Section 8** of this bill provides that a person who is authorized  
15 to practice as an emergency medical technician, advanced emergency medical technician or  
16 paramedic under the Compact is not eligible for an endorsement to provide community  
17 paramedic services. **Section 21.5 of this bill makes an appropriation to the Division of  
18 Public and Behavioral Health of the Department of Health and Human Services to cover  
19 certain fees related to the coordinated database established under the Compact.**

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 441A.195 is hereby amended to read as follows:  
2 441A.195 1. Except as otherwise provided in NRS 259.047, a law  
3 enforcement officer, correctional officer, emergency medical attendant, firefighter,

1 county coroner or medical examiner or any of their employees or volunteers, any  
2 other person who is employed by or is a volunteer for an agency of criminal justice  
3 or any other public employee or volunteer for a public agency who, in the course of  
4 his or her official duties, comes into contact with human blood or bodily fluids, or  
5 the employer of such a person or the public agency for which the person volunteers,  
6 may petition a court for an order requiring the testing of a person or decedent for  
7 exposure to a communicable disease if:

8 (a) The officer, emergency medical attendant, firefighter, county coroner or  
9 medical examiner or their employee or volunteer, other person employed by or  
10 volunteering for an agency of criminal justice or other public employee or volunteer  
11 for a public agency was likely exposed to a communicable disease; and

12 (b) Testing of the person or decedent is necessary to determine the appropriate  
13 treatment for the officer, emergency medical attendant, firefighter, county coroner,  
14 medical examiner, employee or volunteer.

15 2. When possible, before filing a petition pursuant to subsection 1, the person,  
16 employer or public agency for which the person volunteers, and who is petitioning  
17 shall submit information concerning the likely exposure to a communicable disease  
18 to the designated health care officer for the employer or public agency or, if there is  
19 no designated health care officer, the person designated by the employer or public  
20 agency to document and verify likely exposure to communicable diseases, for  
21 verification that there was substantial exposure. Each designated health care officer  
22 or person designated by an employer or public agency to document and verify  
23 likely exposure to communicable diseases shall establish guidelines based on  
24 current scientific information to determine substantial exposure.

25 3. A court shall promptly hear a petition filed pursuant to subsection 1 and  
26 determine whether there is probable cause to believe that a likely transfer of blood  
27 or other bodily fluids occurred between the person who filed the petition or on  
28 whose behalf the petition was filed and the person or decedent who likely exposed  
29 him or her to a communicable disease. If the court determines that such probable  
30 cause exists, the court shall:

31 (a) Order the person who likely exposed the petitioner, or the person on whose  
32 behalf the petition was filed, to a communicable disease to submit two appropriate  
33 specimens to a local hospital or medical laboratory for testing for exposure to a  
34 communicable disease; or

35 (b) Order that two appropriate specimens be taken from the decedent who  
36 likely exposed the petitioner, or the person on whose behalf the petition was filed,  
37 to a communicable disease and be submitted to a local hospital or medical  
38 laboratory for testing for exposure to the communicable disease.

39 ➤ The local hospital or medical laboratory shall perform the test in accordance  
40 with generally accepted medical practices and shall disclose the results of the test in  
41 the manner set forth in NRS 629.069.

42 4. If a judge or a justice of the peace enters an order pursuant to this section,  
43 the judge or justice of the peace may authorize the designated health care officer or  
44 the person designated by the employer or public agency to document and verify  
45 likely exposure to a communicable disease to sign the name of the judge or justice  
46 of the peace on a duplicate order. Such a duplicate order shall be deemed to be an  
47 order of the court. As soon as practicable after the duplicate order is signed, the  
48 duplicate order must be returned to the judge or justice of the peace who authorized  
49 the signing of it and must indicate on its face the judge or justice of the peace to  
50 whom it is to be returned. The judge or justice of the peace, upon receiving the  
51 returned order, shall endorse the order with his or her name and enter the date on  
52 which the order was returned. Any failure of the judge or justice of the peace to  
53 make such an endorsement and entry does not in and of itself invalidate the order.

1           5. Except as otherwise provided in NRS 629.069, all records submitted to the  
2 court in connection with a petition filed pursuant to this section and any  
3 proceedings concerning the petition are confidential and the judge or justice of the  
4 peace shall order the records and any record of the proceedings to be sealed and to  
5 be opened for inspection only upon an order of the court for good cause shown.

6           6. A court may establish rules to allow a judge or justice of the peace to  
7 conduct a hearing or issue an order pursuant to this section by electronic or  
8 telephonic means.

9           7. The employer of a person or the public agency for which the person  
10 volunteers, who files a petition or on whose behalf a petition is filed pursuant to this  
11 section or the insurer of the employer or public agency, shall pay the cost of  
12 performing the test pursuant to subsection 3.

13           8. As used in this section:

14           (a) "Agency of criminal justice" has the meaning ascribed to it in NRS  
15 179A.030.

16           (b) "Emergency medical attendant" means a person ~~licensed~~ who is:

17           (1) *Licensed* as an attendant or certified as an emergency medical  
18 technician, advanced emergency medical technician or paramedic pursuant to  
19 chapter 450B of NRS ~~§~~; or

20           (2) *Authorized to practice as an emergency medical technician, advanced*  
21 *emergency medical technician or paramedic in this State under the Recognition*  
22 *of Emergency Medical Services Personnel Licensure Interstate Compact ratified*  
23 *by section 2 of this act.*

24           **Sec. 2.** Chapter 450B of NRS is hereby amended by adding thereto a new  
25 section to read as follows:

26           *The Recognition of Emergency Medical Services Personnel Licensure*  
27 *Interstate Compact is hereby ratified and entered into with all other jurisdictions*  
28 *legally joining the Compact, in substantially the form set forth in this section:*

## 30           **RECOGNITION OF EMERGENCY MEDICAL SERVICES PERSONNEL** 31           **LICENSURE INTERSTATE COMPACT**

### 32           **SECTION 1. PURPOSE**

33  
34  
35           *In order to protect the public through verification of competency and ensure*  
36 *accountability for patient care related activities all states license emergency*  
37 *medical services (EMS) personnel, such as emergency medical technicians*  
38 *(EMTs), advanced EMTs and paramedics. This Compact is intended to facilitate*  
39 *the day-to-day movement of EMS personnel across state boundaries in the*  
40 *performance of their EMS duties as assigned by an appropriate authority and*  
41 *authorize state EMS offices to afford immediate legal recognition to EMS*  
42 *personnel licensed in a member state. This Compact recognizes that states have a*  
43 *vested interest in protecting the public's health and safety through their licensing*  
44 *and regulation of EMS personnel and that such state regulation shared among*  
45 *the member states will best protect public health and safety. This Compact is*  
46 *designed to achieve the following purposes and objectives:*

47           1. *Increase public access to EMS personnel;*

48           2. *Enhance the states' ability to protect the public's health and safety,*  
49 *especially patient safety;*

50           3. *Encourage the cooperation of member states in the areas of EMS*  
51 *personnel licensure and regulation;*

52           4. *Support licensing of military members who are separating from an active*  
53 *duty tour and their spouses;*



1 *implements, interprets, or prescribes a policy or provision of the Compact, or is*  
2 *an organizational, procedural or practice requirement of the Commission and*  
3 *has the force and effect of statutory law in a member state and includes the*  
4 *amendment, repeal or suspension of an existing rule.*

5 *P. "Scope of practice" means defined parameters of various duties or*  
6 *services that may be provided by an individual with specific credentials. Whether*  
7 *regulated by rule, statute or court decision, it tends to represent the limits of*  
8 *services an individual may perform.*

9 *Q. "Significant investigatory information" means:*

10 *1. Investigative information that a state EMS authority, after a*  
11 *preliminary inquiry that includes notification and an opportunity to respond if*  
12 *required by state law, has reason to believe, if proved true, would result in the*  
13 *imposition of an adverse action on a license or privilege to practice; or*

14 *2. Investigative information that indicates that the individual represents*  
15 *an immediate threat to public health and safety regardless of whether the*  
16 *individual has been notified and had an opportunity to respond.*

17 *R. "State" means any state, commonwealth, district or territory of the*  
18 *United States.*

19 *S. "State EMS authority" means the board, office or other agency with the*  
20 *legislative mandate to license EMS personnel.*

### 21 22 **SECTION 3. HOME STATE LICENSURE**

23  
24 *A. Any member state in which an individual holds a current license shall be*  
25 *deemed a home state for purposes of this Compact.*

26 *B. Any member state may require an individual to obtain and retain a*  
27 *license to be authorized to practice in the member state under circumstances not*  
28 *authorized by the privilege to practice under the terms of this Compact.*

29 *C. A home state's license authorizes an individual to practice in a remote*  
30 *state under the privilege to practice only if the home state:*

31 *1. Currently requires the use of the National Registry of Emergency*  
32 *Medical Technicians (NREMT) examination as a condition of issuing initial*  
33 *licenses at the EMT and paramedic levels;*

34 *2. Has a mechanism in place for receiving and investigating complaints*  
35 *about individuals;*

36 *3. Notifies the Commission, in compliance with the terms herein, of any*  
37 *adverse action or significant investigatory information regarding an individual;*

38 *4. Not later than 5 years after activation of the Compact, requires a*  
39 *criminal background check of all applicants for initial licensure, including the*  
40 *use of the results of fingerprint or other biometric data checks compliant with the*  
41 *requirements of the Federal Bureau of Investigation with the exception of federal*  
42 *employees who have suitability determination in accordance with 5 C.F.R. §*  
43 *731.202 and submit documentation of such as promulgated in the rules of the*  
44 *Commission; and*

45 *5. Complies with the rules of the Commission.*

### 46 47 **SECTION 4. COMPACT PRIVILEGE TO PRACTICE**

48  
49 *A. Member states shall recognize the privilege to practice of an individual*  
50 *licensed in another member state that is in conformance with Section 3.*

51 *B. To exercise the privilege to practice under the terms and provisions of*  
52 *this Compact, an individual must:*

53 *1. Be at least 18 years of age;*

1           2. Possess a current unrestricted license in a member state as an EMT,  
2 AEMT, paramedic or state recognized and licensed level with a scope of practice  
3 and authority between EMT and paramedic; and

4           3. Practice under the supervision of a medical director.  
5           C. An individual providing patient care in a remote state under the privilege  
6 to practice shall function within the scope of practice authorized by the home  
7 state unless and until modified by an appropriate authority in the remote state as  
8 may be defined in the rules of the Commission.

9           D. Except as provided in Section 4, subsection C, an individual practicing  
10 in a remote state will be subject to the remote state's authority and laws. A remote  
11 state may, in accordance with due process and that state's laws, restrict, suspend  
12 or revoke an individual's privilege to practice in the remote state and may take  
13 any other necessary actions to protect the health and safety of its citizens. If a  
14 remote state takes action it shall promptly notify the home state and the  
15 Commission.

16           E. If an individual's license in any home state is restricted or suspended,  
17 the individual shall not be eligible to practice in a remote state under the privilege  
18 to practice until the individual's home state license is restored.

19           F. If an individual's privilege to practice in any remote state is restricted,  
20 suspended or revoked the individual shall not be eligible to practice in any remote  
21 state until the individual's privilege to practice is restored.

#### 22           SECTION 5. CONDITIONS OF PRACTICE IN A REMOTE STATE

23           An individual may practice in a remote state under a privilege to practice only  
24 in the performance of the individual's EMS duties as assigned by an appropriate  
25 authority, as defined in the rules of the Commission, and under the following  
26 circumstances:

27           1. The individual originates a patient transport in a home state and  
28 transports the patient to a remote state;

29           2. The individual originates in the home state and enters a remote state to  
30 pick up a patient and provide care and transport of the patient to the home state;

31           3. The individual enters a remote state to provide patient care and/or  
32 transport within that remote state;

33           4. The individual enters a remote state to pick up a patient and provide care  
34 and transport to a third member state; and

35           5. Other conditions as determined by rules promulgated by the Commission.  
36  
37  
38

#### 39           SECTION 6. RELATIONSHIP TO EMERGENCY MANAGEMENT 40 ASSISTANCE COMPACT

41           Upon a member state's governor's declaration of a state of emergency or  
42 disaster that activates the Emergency Management Assistance Compact (EMAC),  
43 all relevant terms and provisions of EMAC shall apply, and to the extent any  
44 terms or provisions of this Compact conflict with EMAC, the terms of EMAC  
45 shall prevail with respect to any individual practicing in the remote state in  
46 response to such declaration.  
47  
48

#### 49           SECTION 7. VETERANS, SERVICE MEMBERS SEPARATING FROM 50 ACTIVE DUTY MILITARY, AND THEIR SPOUSES

51           A. Member states shall consider a veteran, active military service member  
52 and member of the National Guard and Reserves separating from an active duty  
53



1 *tour, and a spouse thereof, who holds a current valid and unrestricted NREMT*  
2 *certification at or above the level of the state license being sought as satisfying*  
3 *the minimum training and examination requirements for such licensure.*

4 *B. Member states shall expedite the processing of licensure applications*  
5 *submitted by veterans, active military service members, and members of the*  
6 *National Guard and Reserves separating from an active duty tour, and their*  
7 *spouses.*

8 *C. All individuals functioning with a privilege to practice under this Section*  
9 *remain subject to the adverse actions provisions of Section 8.*

#### 10 **SECTION 8. ADVERSE ACTIONS**

11 *A. A home state shall have exclusive power to impose adverse action against*  
12 *an individual's license issued by the home state.*

13 *B. If an individual's license in any home state is restricted or suspended,*  
14 *the individual shall not be eligible to practice in a remote state under the privilege*  
15 *to practice until the individual's home state license is restored.*

16 *1. All home state adverse action orders shall include a statement that the*  
17 *individual's Compact privileges are inactive. The order may allow the individual*  
18 *to practice in remote states with prior written authorization from both the home*  
19 *state and remote state's EMS authority.*

20 *2. An individual currently subject to adverse action in the home state*  
21 *shall not practice in any remote state without prior written authorization from*  
22 *both the home state and remote state's EMS authority.*

23 *C. A member state shall report adverse actions and any occurrences that the*  
24 *individual's Compact privileges are restricted, suspended or revoked to the*  
25 *Commission in accordance with the rules of the Commission.*

26 *D. A remote state may take adverse action on an individual's privilege to*  
27 *practice within that state.*

28 *E. Any member state may take adverse action against an individual's*  
29 *privilege to practice in that state based on the factual findings of another member*  
30 *state, so long as each state follows its own procedures for imposing such adverse*  
31 *action.*

32 *F. A home state's EMS authority shall investigate and take appropriate*  
33 *action with respect to reported conduct in a remote state as it would if such*  
34 *conduct had occurred within the home state. In such cases, the home state's law*  
35 *shall control in determining the appropriate adverse action.*

36 *G. Nothing in this Compact shall override a member state's decision that*  
37 *participation in an alternative program may be used in lieu of adverse action and*  
38 *that such participation shall remain nonpublic if required by the member state's*  
39 *laws. Member states must require individuals who enter any alternative programs*  
40 *to agree not to practice in any other member state during the term of the*  
41 *alternative program without prior authorization from such other member state.*  
42

#### 43 **SECTION 9. ADDITIONAL POWERS INVESTED IN A MEMBER STATE'S** 44 **EMS AUTHORITY**

45 *A member state's EMS authority, in addition to any other powers granted*  
46 *under state law, is authorized under this Compact to:*

47 *1. Issue subpoenas for both hearings and investigations that require the*  
48 *attendance and testimony of witnesses and the production of evidence. Subpoenas*  
49 *issued by a member state's EMS authority for the attendance and testimony of*  
50 *witnesses and/or the production of evidence from another member state, shall be*  
51  
52  
53

1 *enforced in the remote state by any court of competent jurisdiction, according to*  
2 *that court's practice and procedure in considering subpoenas issued in its own*  
3 *proceedings. The issuing state EMS authority shall pay any witness fees, travel*  
4 *expenses, mileage and other fees required by the service statutes of the state*  
5 *where the witnesses and/or evidence are located; and*

6 *2. Issue cease and desist orders to restrict, suspend or revoke an*  
7 *individual's privilege to practice in the state.*

8  
9 **SECTION 10. ESTABLISHMENT OF THE INTERSTATE COMMISSION**  
10 **FOR EMS PERSONNEL PRACTICE**

11  
12 *A. The Compact states hereby create and establish a joint public agency*  
13 *known as the Interstate Commission for EMS Personnel Practice.*

14 *1. The Commission is a body politic and an instrumentality of the*  
15 *Compact states.*

16 *2. Venue is proper and judicial proceedings by or against the*  
17 *Commission shall be brought solely and exclusively in a court of competent*  
18 *jurisdiction where the principal office of the Commission is located. The*  
19 *Commission may waive venue and jurisdictional defenses to the extent it adopts*  
20 *or consents to participate in alternative dispute resolution proceedings.*

21 *3. Nothing in this Compact shall be construed to be a waiver of sovereign*  
22 *immunity.*

23 **B. Membership, Voting and Meetings**

24 *1. Each member state shall have and be limited to one delegate. The*  
25 *responsible official of the state EMS authority or his or her designee shall be the*  
26 *delegate to this Compact for each member state. Any delegate may be removed or*  
27 *suspended from office as provided by the law of the state from which the delegate*  
28 *is appointed. Any vacancy occurring in the Commission shall be filled in*  
29 *accordance with the laws of the member state in which the vacancy exists. In the*  
30 *event that more than one board, office or other agency with the legislative*  
31 *mandate to license EMS personnel at and above the level of EMT exists, the*  
32 *governor of the state will determine which entity will be responsible for assigning*  
33 *the delegate.*

34 *2. Each delegate shall be entitled to one vote with regard to the*  
35 *promulgation of rules and creation of bylaws and shall otherwise have an*  
36 *opportunity to participate in the business and affairs of the Commission. A*  
37 *delegate shall vote in person or by such other means as provided in the bylaws.*  
38 *The bylaws may provide for delegates' participation in meetings by telephone or*  
39 *other means of communication.*

40 *3. The Commission shall meet at least once during each calendar year.*  
41 *Additional meetings shall be held as set forth in the bylaws.*

42 *4. All meetings shall be open to the public, and public notice of meetings*  
43 *shall be given in the same manner as required under the rulemaking provisions*  
44 *in Section 12.*

45 *5. The Commission may convene in a closed, nonpublic meeting if the*  
46 *Commission must discuss:*

47 *a. Noncompliance of a member state with its obligations under the*  
48 *Compact;*

49 *b. The employment, compensation, discipline or other personnel*  
50 *matters, practices or procedures related to specific employees or other matters*  
51 *related to the Commission's internal personnel practices and procedures;*

52 *c. Current, threatened or reasonably anticipated litigation;*

1 *d. Negotiation of contracts for the purchase or sale of goods, services*  
2 *or real estate;*

3 *e. Accusing any person of a crime or formally censuring any person;*

4 *f. Disclosure of trade secrets or commercial or financial information*  
5 *that is privileged or confidential;*

6 *g. Disclosure of information of a personal nature where disclosure*  
7 *would constitute a clearly unwarranted invasion of personal privacy;*

8 *h. Disclosure of investigatory records compiled for law enforcement*  
9 *purposes;*

10 *i. Disclosure of information related to any investigatory reports*  
11 *prepared by or on behalf of or for use of the Commission or other committee*  
12 *charged with responsibility of investigation or determination of compliance issues*  
13 *pursuant to the Compact; or*

14 *j. Matters specifically exempted from disclosure by federal or*  
15 *member state statute.*

16 *6. If a meeting, or portion of a meeting, is closed pursuant to this*  
17 *provision, the Commission's legal counsel or designee shall certify that the*  
18 *meeting may be closed and shall reference each relevant exempting provision.*  
19 *The Commission shall keep minutes that fully and clearly describe all matters*  
20 *discussed in a meeting and shall provide a full and accurate summary of actions*  
21 *taken, and the reasons therefore, including a description of the views expressed.*  
22 *All documents considered in connection with an action shall be identified in such*  
23 *minutes. All minutes and documents of a closed meeting shall remain under seal,*  
24 *subject to release by a majority vote of the Commission or order of a court of*  
25 *competent jurisdiction.*

26 *C. The Commission shall, by a majority vote of the delegates, prescribe*  
27 *bylaws and/or rules to govern its conduct as may be necessary or appropriate to*  
28 *carry out the purposes and exercise the powers of the Compact, including, but not*  
29 *limited to, bylaws and/or rules:*

30 *1. Establishing the fiscal year of the Commission;*

31 *2. Providing reasonable standards and procedures;*

32 *a. For the establishment and meetings of other committees; and*

33 *b. Governing any general or specific delegation of any authority or*  
34 *function of the Commission;*

35 *3. Providing reasonable procedures for calling and conducting meetings*  
36 *of the Commission, ensuring reasonable advance notice of all meetings and*  
37 *providing an opportunity for attendance of such meetings by interested parties,*  
38 *with enumerated exceptions designed to protect the public's interest, the privacy*  
39 *of individuals and proprietary information, including trade secrets. The*  
40 *Commission may meet in closed session only after a majority of the membership*  
41 *votes to close a meeting in whole or in part. As soon as practicable, the*  
42 *Commission must make public a copy of the vote to close the meeting revealing*  
43 *the vote of each member with no proxy votes allowed;*

44 *4. Establishing the titles, duties and authority, and reasonable*  
45 *procedures for the election of the officers of the Commission;*

46 *5. Providing reasonable standards and procedures for the establishment*  
47 *of the personnel policies and programs of the Commission. Notwithstanding any*  
48 *civil service or other similar laws of any member state, the bylaws shall*  
49 *exclusively govern the personnel policies and programs of the Commission;*

50 *6. Promulgating a code of ethics to address permissible and prohibited*  
51 *activities of Commission members and employees; and*

52 *7. Providing a mechanism for winding up the operations of the*  
53 *Commission and the equitable disposition of any surplus funds that may exist*

1 *after the termination of the Compact after the payment and/or reserving of all of*  
2 *its debts and obligations.*

3 *D. The Commission shall publish its bylaws and file a copy thereof, and a*  
4 *copy of any amendment thereto, with the appropriate agency or officer in each of*  
5 *the member states, if any.*

6 *E. The Commission shall maintain its financial records in accordance with*  
7 *the bylaws.*

8 *F. The Commission shall meet and take such actions as are consistent with*  
9 *the provisions of this Compact and the bylaws.*

10 *G. The Commission shall have the following powers:*

11 *1. The authority to promulgate uniform rules to facilitate and coordinate*  
12 *implementation and administration of this Compact. The rules shall have the*  
13 *force and effect of law and shall be binding in all member states;*

14 *2. To bring and prosecute legal proceedings or actions in the name of the*  
15 *Commission, provided that the standing of any state EMS authority or other*  
16 *regulatory body responsible for EMS personnel licensure to sue or be sued under*  
17 *applicable law shall not be affected;*

18 *3. To purchase and maintain insurance and bonds;*

19 *4. To borrow, accept or contract for services of personnel, including, but*  
20 *not limited to, employees of a member state;*

21 *5. To hire employees, elect or appoint officers, fix compensation, define*  
22 *duties, grant such individuals appropriate authority to carry out the purposes of*  
23 *the Compact, and to establish the Commission's personnel policies and programs*  
24 *relating to conflicts of interest, qualifications of personnel and other related*  
25 *personnel matters;*

26 *6. To accept any and all appropriate donations and grants of money,*  
27 *equipment, supplies, materials and services, and to receive, utilize and dispose of*  
28 *the same, provided that at all times the Commission shall strive to avoid any*  
29 *appearance of impropriety and/or conflict of interest;*

30 *7. To lease, purchase, accept appropriate gifts or donations of, or*  
31 *otherwise to own, hold, improve or use, any property, real, personal or mixed,*  
32 *provided that at all times the Commission shall strive to avoid any appearance of*  
33 *impropriety;*

34 *8. To sell, convey, mortgage, pledge, lease, exchange, abandon or*  
35 *otherwise dispose of any property, real, personal or mixed;*

36 *9. To establish a budget and make expenditures;*

37 *10. To borrow money;*

38 *11. To appoint committees, including advisory committees comprised of*  
39 *members, state regulators, state legislators or their representatives, and consumer*  
40 *representatives, and such other interested persons as may be designated in this*  
41 *Compact and the bylaws;*

42 *12. To provide and receive information from, and to cooperate with, law*  
43 *enforcement agencies;*

44 *13. To adopt and use an official seal; and*

45 *14. To perform such other functions as may be necessary or appropriate*  
46 *to achieve the purposes of this Compact consistent with the state regulation of*  
47 *EMS personnel licensure and practice.*

48 *H. Financing of the Commission*

49 *1. The Commission shall pay, or provide for the payment of, the*  
50 *reasonable expenses of its establishment, organization and ongoing activities.*

51 *2. The Commission may accept any and all appropriate revenue sources,*  
52 *donations and grants of money, equipment, supplies, materials and services.*

1           3. *The Commission may levy on and collect an annual assessment from*  
2 *each member state or impose fees on other parties to cover the cost of the*  
3 *operations and activities of the Commission and its staff, which must be in a total*  
4 *amount sufficient to cover its annual budget as approved each year for which*  
5 *revenue is not provided by other sources. The aggregate annual assessment*  
6 *amount shall be allocated based upon a formula to be determined by the*  
7 *Commission, which shall promulgate a rule binding upon all member states.*

8           4. *The Commission shall not incur obligations of any kind prior to*  
9 *securing the funds adequate to meet the same, nor shall the Commission pledge*  
10 *the credit of any of the member states, except by and with the authority of the*  
11 *member state.*

12           5. *The Commission shall keep accurate accounts of all receipts and*  
13 *disbursements. The receipts and disbursements of the Commission shall be*  
14 *subject to the audit and accounting procedures established under its bylaws.*  
15 *However, all receipts and disbursements of funds handled by the Commission*  
16 *shall be audited yearly by a certified or licensed public accountant, and the report*  
17 *of the audit shall be included in and become part of the annual report of the*  
18 *Commission.*

19           I. *Qualified Immunity, Defense and Indemnification*

20           1. *The members, officers, executive director, employees and*  
21 *representatives of the Commission shall be immune from suit and liability, either*  
22 *personally or in their official capacity, for any claim for damage to or loss of*  
23 *property or personal injury or other civil liability caused by or arising out of any*  
24 *actual or alleged act, error or omission that occurred, or that the person against*  
25 *whom the claim is made had a reasonable basis for believing occurred within the*  
26 *scope of Commission employment, duties or responsibilities, provided that*  
27 *nothing in this paragraph shall be construed to protect any such person from suit*  
28 *and/or liability for any damage, loss, injury or liability caused by the intentional*  
29 *or willful or wanton misconduct of that person.*

30           2. *The Commission shall defend any member, officer, executive director,*  
31 *employee or representative of the Commission in any civil action seeking to*  
32 *impose liability arising out of any actual or alleged act, error or omission that*  
33 *occurred within the scope of Commission employment, duties or responsibilities,*  
34 *or that the person against whom the claim is made had a reasonable basis for*  
35 *believing occurred within the scope of Commission employment, duties or*  
36 *responsibilities, provided that nothing herein shall be construed to prohibit that*  
37 *person from retaining his or her own counsel, and provided further, that the*  
38 *actual or alleged act, error or omission did not result from that person's*  
39 *intentional or willful or wanton misconduct.*

40           3. *The Commission shall indemnify and hold harmless any member,*  
41 *officer, executive director, employee or representative of the Commission for the*  
42 *amount of any settlement or judgment obtained against that person arising out of*  
43 *any actual or alleged act, error or omission that occurred within the scope of*  
44 *Commission employment, duties or responsibilities, or that such person had a*  
45 *reasonable basis for believing occurred within the scope of Commission*  
46 *employment, duties or responsibilities, provided that the actual or alleged act,*  
47 *error or omission did not result from the intentional or willful or wanton*  
48 *misconduct of that person.*

49  
50           SECTION 11. COORDINATED DATABASE

51  
52           A. *The Commission shall provide for the development and maintenance of*  
53 *a coordinated database and reporting system containing licensure, adverse action*

1 *and significant investigatory information on all licensed individuals in member*  
2 *states.*

3 *B. Notwithstanding any other provision of state law to the contrary, a*  
4 *member state shall submit a uniform data set to the coordinated database on all*  
5 *individuals to whom this Compact is applicable as required by the rules of the*  
6 *Commission, including:*

- 7 *1. Identifying information;*
- 8 *2. Licensure data;*
- 9 *3. Significant investigatory information;*
- 10 *4. Adverse actions against an individual's license;*
- 11 *5. An indicator that an individual's privilege to practice is restricted,*  
12 *suspended or revoked;*
- 13 *6. Nonconfidential information related to alternative program*  
14 *participation;*
- 15 *7. Any denial of application for licensure and the reasons for such*  
16 *denial; and*
- 17 *8. Other information that may facilitate the administration of this*  
18 *Compact, as determined by the rules of the Commission.*

19 *C. The coordinated database administrator shall promptly notify all*  
20 *member states of any adverse action taken against, or significant investigative*  
21 *information on, any individual in a member state.*

22 *D. Member states contributing information to the coordinated database may*  
23 *designate information that may not be shared with the public without the express*  
24 *permission of the contributing state.*

25 *E. Any information submitted to the coordinated database that is*  
26 *subsequently required to be expunged by the laws of the member state*  
27 *contributing the information shall be removed from the coordinated database.*  
28

## 29 **SECTION 12. RULEMAKING**

30  
31 *A. The Commission shall exercise its rulemaking powers pursuant to the*  
32 *criteria set forth in this Section and the rules adopted thereunder. Rules and*  
33 *amendments shall become binding as of the date specified in each rule or*  
34 *amendment.*

35 *B. If a majority of the legislatures of the member states rejects a rule, by*  
36 *enactment of a statute or resolution in the same manner used to adopt the*  
37 *Compact, then such rule shall have no further force and effect in any member*  
38 *state.*

39 *C. Rules or amendments to the rules shall be adopted at a regular or special*  
40 *meeting of the Commission.*

41 *D. Prior to promulgation and adoption of a final rule or rules by the*  
42 *Commission, and at least 60 days in advance of the meeting at which the rule will*  
43 *be considered and voted upon, the Commission shall file a Notice of Proposed*  
44 *Rulemaking:*

- 45 *1. On the website of the Commission; and*
- 46 *2. On the website of each member state EMS authority or the publication*  
47 *in which each state would otherwise publish proposed rules.*

48 *E. The Notice of Proposed Rulemaking shall include:*

- 49 *1. The proposed time, date and location of the meeting in which the rule*  
50 *will be considered and voted upon;*
- 51 *2. The text of the proposed rule or amendment and the reason for the*  
52 *proposed rule;*

1           3. A request for comments on the proposed rule from any interested  
2 person; and

3           4. The manner in which interested persons may submit notice to the  
4 Commission of their intention to attend the public hearing and any written  
5 comments.

6           F. Prior to adoption of a proposed rule, the Commission shall allow persons  
7 to submit written data, facts, opinions and arguments, which shall be made  
8 available to the public.

9           G. The Commission shall grant an opportunity for a public hearing before  
10 it adopts a rule or amendment if a hearing is requested by:

11           1. At least 25 persons;

12           2. A governmental subdivision or agency; or

13           3. An association having at least 25 members.

14           H. If a hearing is held on the proposed rule or amendment, the Commission  
15 shall publish the place, time and date of the scheduled public hearing.

16           1. All persons wishing to be heard at the hearing shall notify the  
17 executive director of the Commission or other designated member in writing of  
18 their desire to appear and testify at the hearing not less than 5 business days  
19 before the scheduled date of the hearing.

20           2. Hearings shall be conducted in a manner providing each person who  
21 wishes to comment a fair and reasonable opportunity to comment orally or in  
22 writing.

23           3. No transcript of the hearing is required, unless a written request for a  
24 transcript is made, in which case the person requesting the transcript shall bear  
25 the cost of producing the transcript. A recording may be made in lieu of a  
26 transcript under the same terms and conditions as a transcript. This subsection  
27 shall not preclude the Commission from making a transcript or recording of the  
28 hearing if it so chooses.

29           4. Nothing in this Section shall be construed as requiring a separate  
30 hearing on each rule. Rules may be grouped for the convenience of the  
31 Commission at hearings required by this Section.

32           I. Following the scheduled hearing date, or by the close of business on the  
33 scheduled hearing date if the hearing was not held, the Commission shall  
34 consider all written and oral comments received.

35           J. The Commission shall, by majority vote of all members, take final action  
36 on the proposed rule and shall determine the effective date of the rule, if any,  
37 based on the rulemaking record and the full text of the rule.

38           K. If no written notice of intent to attend the public hearing by interested  
39 parties is received, the Commission may proceed with promulgation of the  
40 proposed rule without a public hearing.

41           L. Upon determination that an emergency exists, the Commission may  
42 consider and adopt an emergency rule without prior notice, opportunity for  
43 comment or hearing, provided that the usual rulemaking procedures provided in  
44 the Compact and in this Section shall be retroactively applied to the rule as soon  
45 as reasonably possible, in no event later than 90 days after the effective date of  
46 the rule. For the purposes of this provision, an emergency rule is one that must  
47 be adopted immediately in order to:

48           1. Meet an imminent threat to public health, safety or welfare;

49           2. Prevent a loss of Commission member state funds;

50           3. Meet a deadline for the promulgation of an administrative rule that is  
51 established by federal law or rule; or

52           4. Protect public health and safety.



1        *M. The Commission or an authorized committee of the Commission may*  
2 *direct revisions to a previously adopted rule or amendment for purposes of*  
3 *correcting typographical errors, errors in format, errors in consistency or*  
4 *grammatical errors. Public notice of any revisions shall be posted on the website*  
5 *of the Commission. The revision shall be subject to challenge by any person for a*  
6 *period of 30 days after posting. The revision may be challenged only on grounds*  
7 *that the revision results in a material change to a rule. A challenge shall be made*  
8 *in writing and delivered to the chair of the Commission prior to the end of the*  
9 *notice period. If no challenge is made, the revision will take effect without further*  
10 *action. If the revision is challenged, the revision may not take effect without the*  
11 *approval of the Commission.*

### 12                    **SECTION 13. OVERSIGHT, DISPUTE RESOLUTION AND** 13 **ENFORCEMENT**

#### 14            **A. Oversight**

15  
16        *1. The executive, legislative and judicial branches of state government in*  
17 *each member state shall enforce this Compact and take all actions necessary and*  
18 *appropriate to effectuate the Compact's purposes and intent. The provisions of*  
19 *this Compact and the rules promulgated hereunder shall have standing as*  
20 *statutory law.*

21        *2. All courts shall take judicial notice of the Compact and the rules in*  
22 *any judicial or administrative proceeding in a member state pertaining to the*  
23 *subject matter of this Compact which may affect the powers, responsibilities or*  
24 *actions of the Commission.*

25        *3. The Commission shall be entitled to receive service of process in any*  
26 *such proceeding, and shall have standing to intervene in such a proceeding for*  
27 *all purposes. Failure to provide service of process to the Commission shall render*  
28 *a judgment or order void as to the Commission, this Compact or promulgated*  
29 *rules.*

#### 30            **B. Default, Technical Assistance and Termination**

31        *1. If the Commission determines that a member state has defaulted in the*  
32 *performance of its obligations or responsibilities under this Compact or the*  
33 *promulgated rules, the Commission shall:*

34            *a. Provide written notice to the defaulting state and other member*  
35 *states of the nature of the default, the proposed means of curing the default*  
36 *and/or any other action to be taken by the Commission; and*

37            *b. Provide remedial training and specific technical assistance*  
38 *regarding the default.*

39        *2. If a state in default fails to cure the default, the defaulting state may be*  
40 *terminated from the Compact upon an affirmative vote of a majority of the*  
41 *member states, and all rights, privileges and benefits conferred by this Compact*  
42 *may be terminated on the effective date of termination. A cure of the default does*  
43 *not relieve the offending state of obligations or liabilities incurred during the*  
44 *period of default.*

45        *3. Termination of membership in the Compact shall be imposed only*  
46 *after all other means of securing compliance have been exhausted. Notice of*  
47 *intent to suspend or terminate shall be given by the Commission to the governor*  
48 *and the majority and minority leaders of the defaulting state's legislature, and*  
49 *each of the member states.*

50        *4. A state that has been terminated is responsible for all assessments,*  
51 *obligations and liabilities incurred through the effective date of termination,*  
52 *including obligations that extend beyond the effective date of termination.*  
53



1           5. *The Commission shall not bear any costs related to a state that is*  
2 *found to be in default or that has been terminated from the Compact, unless*  
3 *agreed upon in writing between the Commission and the defaulting state.*

4           6. *The defaulting state may appeal the action of the Commission by*  
5 *petitioning the United States District Court for the District of Columbia or the*  
6 *federal district where the Commission has its principal offices. The prevailing*  
7 *member shall be awarded all costs of such litigation, including reasonable*  
8 *attorney's fees.*

9           C. *Dispute Resolution*

10           1. *Upon request by a member state, the Commission shall attempt to*  
11 *resolve disputes related to the Compact that arise among member states and*  
12 *between member and nonmember states.*

13           2. *The Commission shall promulgate a rule providing for both mediation*  
14 *and binding dispute resolution for disputes as appropriate.*

15           D. *Enforcement*

16           1. *The Commission, in the reasonable exercise of its discretion, shall*  
17 *enforce the provisions and rules of this Compact.*

18           2. *By majority vote, the Commission may initiate legal action in the*  
19 *United States District Court for the District of Columbia or the federal district*  
20 *where the Commission has its principal offices against a member state in default*  
21 *to enforce compliance with the provisions of the Compact and its promulgated*  
22 *rules and bylaws. The relief sought may include both injunctive relief and*  
23 *damages. In the event judicial enforcement is necessary, the prevailing member*  
24 *shall be awarded all costs of such litigation, including reasonable attorney's fees.*

25           3. *The remedies herein shall not be the exclusive remedies of the*  
26 *Commission. The Commission may pursue any other remedies available under*  
27 *federal or state law.*

28  
29           **SECTION 14. DATE OF IMPLEMENTATION OF THE INTERSTATE**  
30 **COMMISSION FOR EMS PERSONNEL PRACTICE AND ASSOCIATED**  
31 **RULES, WITHDRAWAL AND AMENDMENT**  
32

33           A. *The Compact shall come into effect on the date on which the Compact*  
34 *statute is enacted into law in the tenth member state. The provisions, which*  
35 *become effective at that time, shall be limited to the powers granted to the*  
36 *Commission relating to assembly and the promulgation of rules. Thereafter, the*  
37 *Commission shall meet and exercise rulemaking powers necessary to the*  
38 *implementation and administration of the Compact.*

39           B. *Any state that joins the Compact subsequent to the Commission's initial*  
40 *adoption of the rules shall be subject to the rules as they exist on the date on*  
41 *which the Compact becomes law in that state. Any rule that has been previously*  
42 *adopted by the Commission shall have the full force and effect of law on the day*  
43 *the Compact becomes law in that state.*

44           C. *Any member state may withdraw from this Compact by enacting a statute*  
45 *repealing the same.*

46           1. *A member state's withdrawal shall not take effect until 6 months after*  
47 *enactment of the repealing statute.*

48           2. *Withdrawal shall not affect the continuing requirement of the*  
49 *withdrawing state's EMS authority to comply with the investigative and adverse*  
50 *action reporting requirements of this act prior to the effective date of withdrawal.*

51           D. *Nothing contained in this Compact shall be construed to invalidate or*  
52 *prevent any EMS personnel licensure agreement or other cooperative*

1 *arrangement between a member state and a nonmember state that does not*  
2 *conflict with the provisions of this Compact.*

3 *E. This Compact may be amended by the member states. No amendment to*  
4 *this Compact shall become effective and binding upon any member state until it*  
5 *is enacted into the laws of all member states.*

## 6 7 **SECTION 15. CONSTRUCTION AND SEVERABILITY**

8  
9 *This Compact shall be liberally construed so as to effectuate the purposes*  
10 *thereof. If this Compact shall be held contrary to the constitution of any state*  
11 *member thereto, the Compact shall remain in full force and effect as to the*  
12 *remaining member states. Nothing in this Compact supersedes state law or rules*  
13 *related to licensure of EMS agencies.*

14 **Sec. 3.** NRS 450B.025 is hereby amended to read as follows:

15 450B.025 “Advanced emergency medical technician” means a person  
16 ~~certified~~ who is:

17 1. *Certified* by the health officer as having satisfactorily completed a program  
18 of training for certification as an advanced emergency medical technician pursuant  
19 to NRS 450B.191 ~~+~~; or

20 2. *Practicing as an advanced emergency medical technician in this State*  
21 *under the Recognition of Emergency Medical Services Personnel Licensure*  
22 *Interstate Compact ratified by section 2 of this act.*

23 **Sec. 4.** NRS 450B.065 is hereby amended to read as follows:

24 450B.065 “Emergency medical technician” means a person ~~certified~~ who is:

25 1. *Certified* by the health officer as having satisfactorily completed a program  
26 of training for certification as an emergency medical technician pursuant to NRS  
27 450B.1905 ~~+~~; or

28 2. *Practicing as an emergency medical technician in this State under the*  
29 *Recognition of Emergency Medical Services Personnel Licensure Interstate*  
30 *Compact ratified by section 2 of this act.*

31 **Sec. 5.** NRS 450B.095 is hereby amended to read as follows:

32 450B.095 “Paramedic” means a person ~~certified~~ who is:

33 1. *Certified* by the health officer as having satisfactorily completed a program  
34 of training for certification as a paramedic pursuant to NRS 450B.195 ~~+~~; or

35 2. *Practicing as a paramedic in this State under the Recognition of*  
36 *Emergency Medical Services Personnel Licensure Interstate Compact ratified by*  
37 *section 2 of this act.*

38 **Sec. 6.** NRS 450B.191 is hereby amended to read as follows:

39 450B.191 1. A program of training for certification as an advanced  
40 emergency medical technician must be supervised by a licensed physician and  
41 approved by the health authority.

42 2. A program of training for certification as an advanced emergency medical

9 6. Except as authorized by subsection 7 of NRS 450B.160 ***☞ and the***  
10 ***Recognition of Emergency Medical Services Personnel Licensure Interstate***  
11 ***Compact ratified by section 2 of this act***, an attendant or firefighter shall not  
12 perform, and the owner, operator, director or chief officer of an ambulance or a fire-  
13 fighting agency shall not offer, emergency care as an advanced emergency medical  
14 technician without fulfilling the requirements established by the board.

15 **Sec. 7.** NRS 450B.195 is hereby amended to read as follows:

16 450B.195 1. Only a certified emergency medical technician with experience

37 perform, and the owner, operator, director or chief officer of an ambulance or a fire-

39 the requirements established by the board.

 49 **granted or otherwise transferred in any manner, and any portion of the**  
 50 **appropriated money remaining must not be spent for any purpose after**  
 51 **September 20, 2024, and September 19, 2025, respectively, by either the entity**  
 52 **to which the money was appropriated or the entity to which the money was**  
 53 **subsequently granted or transferred, and must be reverted to the State**

1 General Fund on or before September 20, 2024, and September 19, 2025,  
2 respectively.

3 **Sec. 22.** The provisions of NRS 354.599 do not apply to any additional  
4 expenses of a local government that are related to the provisions of this act.

5 **Sec. 23.** 1. This section becomes effective upon passage and approval.

6 2. Section 21.5 of this act becomes effective on July 1, 2023.

7 3. Sections 1 to ~~22~~ 21, inclusive, and 22 of this act become effective:

8 (a) Upon passage and approval for the purpose of adopting any regulations and  
9 performing any other preparatory administrative tasks that are necessary to carry  
10 out the provisions of this act; and

11 (b) On October 1, 2023, for all other purposes.
