AN ACT relating to health care; revising provisions relating to the requirement that certain medical facilities conduct training of certain agents and employees in cultural competency; requiring the Office of Minority Health and Equity of the Department of Health and Human Services to establish, maintain and distribute a list of courses and programs relating to cultural competency that certain medical facilities are required to use to conduct training of certain agents and employees; increasing the number of hours of instruction relating to cultural competency that certain health care professionals are required to complete; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law provides that the State Board of Health shall require, by regulation, a  
2 medical facility, facility for the dependent and certain other facilities to conduct training  
3 relating specifically to cultural competency for any agent or employee of the facility so that  
4 such an agent or employee may better understand patients or residents who have different  
5 cultural backgrounds, including, without limitation, patients or residents who are: (1) from  
6 various racial and ethnic backgrounds; (2) from various religious backgrounds; (3) persons  
7 with various sexual orientations and gender identities or expressions; (4) children and senior  
8 citizens; (5) persons with a mental or physical disability; and (6) part of any other population  
9 that such an agent or employee may need to better understand. Such training relating to  
10 cultural competency must be provided through a course or program that is approved by the  
11 Department of Health and Human Services. (NRS 449.103) **Section 1** of this bill: (1) requires  
12 the Board to set forth by regulation the frequency with which such a facility is required to  
13 conduct the training relating to cultural competency; and (2) creates an exception to the  
14 requirement to provide such training if an agent or employee of the facility has successfully  
15 completed a course or program of cultural competency as part of the continuing education  
16 requirements for the agent or employee to renew his or her professional license, registration or  
17 certificate, as applicable. Section 1 further limits the requirement to receive training

18 relating to cultural competency to agents and employees who: (1) provide clinical,  
 19 administrative or support services and regularly have direct patient contact as part of  
 20 their regular job duties; or (2) oversee such agents or employees. Section 1 further  
 21 requires the Office of Minority Health and Equity of the Department of Health and Human  
 22 Services to: (1) establish and maintain a list of courses and programs on cultural competency  
 23 that are approved for training relating to cultural competency; (2) make the most current list  
 24 available on the Internet website of the Office; and (3) ensure that the list is distributed to each  
 25 facility required to conduct the training on cultural competency. Finally, **section 1:** (1)  
 26 authorizes a facility to apply to the Department to provide a course or program on cultural  
 27 competency that is not already approved by the Department; and (2) requires the Department  
 28 to report annually to certain joint interim committees of the Legislature the average length of  
 29 time within which the Department approved a course or program of training in the  
 30 immediately preceding year.

31 Existing law requires, as a prerequisite for the renewal of a license, a nurse, psychologist,  
 32 marriage and family therapist, clinical professional counselor, social worker or behavior  
 33 analyst to complete at least 2 hours of instruction relating to cultural competency and  
 34 diversity, equity and inclusion. (NRS 632.343, 641.220, 641A.260, 641B.280, 641D.360)  
 35 Existing law requires, as a prerequisite for the renewal of a license or certificate, an alcohol  
 36 and drug counselor or problem gambling counselor to complete at least 1 hour of instruction  
 37 relating to cultural competency and diversity, equity and inclusion. (NRS 641C.450) **Section**  
 38 **3** of this bill requires a nurse to complete at least 4 hours of such instruction. **Sections 5-7**  
 39 of this bill require a psychologist, marriage and family therapist, clinical professional counselor  
 40 or social worker to complete at least 6 hours of instruction relating to cultural competency and  
 41 diversity, equity and inclusion. **Section 8** of this bill requires an alcohol and drug counselor or  
 42 problem gambling counselor to complete at least 3 hours of instruction relating to cultural  
 43 competency and diversity, equity and inclusion. **Section 9** of this bill requires a behavior  
 44 analyst to complete at least 6 hours of instruction relating to cultural competency and  
 45 diversity, equity and inclusion.

1 **Section 1.** NRS 449.103 is hereby amended to read as follows:

2 449.103 1. ~~[(2)]~~ *Except as otherwise provided in subsection ~~[(2)]~~ 3,* to  
 3 enable an agent or employee of a medical facility, facility for the dependent or  
 4 facility which is otherwise required by regulations adopted by the Board pursuant to

- 19 (f) Part of any other population that such an agent or employee may need to
- 20 better understand, as determined by the Board.

8     (a) Provides clinical, administrative or support services and has direct patient  
9 contact at least once each week on average as a part of his or her regular job

13 *required to provide training relating specifically to cultural competency to an*

3       632.343 1. The Board shall not renew any license issued under this chapter  
4       until the licensee has submitted proof satisfactory to the Board of completion,  
5       during the 2-year period before renewal of the license, of 30 hours in a program of  
6       continuing education approved by the Board in accordance with regulations  
7       adopted by the Board. Except as otherwise provided in subsection 3, the licensee is  
8       exempt from this provision for the first biennial period after graduation from:

9       (a) An accredited school of professional nursing;

10       (b) An accredited school of practical nursing;

11       (c) An approved school of professional nursing in the process of obtaining  
12       accreditation; or

13       (d) An approved school of practical nursing in the process of obtaining  
14       accreditation.

15       2. The Board shall review all courses offered to nurses for the completion of  
16       the requirement set forth in subsection 1. The Board may approve nursing and other

28       education required by subsection 1 for the completion of a course of instruction  
29       relating to genetic counseling and genetic testing.

30       (b) For each person licensed pursuant to this chapter, a course of instruction, to  
31       be completed within 2 years after initial licensure, relating to the medical  
32       consequences of an act of terrorism that involves the use of a weapon of mass  
33       destruction. The course must provide at least 4 hours of instruction that includes  
34       instruction in the following subjects:

35       (1) An overview of acts of terrorism and weapons of mass destruction;

36       (2) Personal protective equipment required for acts of terrorism;

37       (3) Common symptoms and methods of treatment associated with exposure  
38       to, or injuries caused by, chemical, biological, radioactive and nuclear agents;

39       (4) Syndromic surveillance and reporting procedures for acts of terrorism  
40       that involve biological agents; and

41       (5) An overview of the information available on, and the use of, the Health  
42       Alert Network.

43       (c) For each person licensed pursuant to this chapter, one or more courses of  
44       instruction that provide at least ~~2~~ 4 hours of instruction relating to cultural  
45       competency and diversity, equity and inclusion to be completed biennially. Such  
46       instruction:

47       (1) May include the training provided pursuant to NRS 449.103, where  
48       applicable.

49       (2) Must be based upon a range of research from diverse sources.

50       (3) Must address persons of different cultural backgrounds, including,  
51       without limitation:

52       (I) Persons from various gender, racial and ethnic backgrounds;

53       (II) Persons from various religious backgrounds;

1 (III) Lesbian, gay, bisexual, transgender and questioning persons;

2 (IV) Children and senior citizens;

3 (V) Veterans;

4 (VI) Persons with a mental illness;

5 (VII) Persons with an intellectual disability, developmental disability  
6 or physical disability; and

11 hours of training in the screening, brief intervention and referral to treatment  
12 approach to substance use disorder to be completed within 2 years after initial  
13 licensure.

14 4. The Board may determine whether to include in a program of continuing  
15 education courses of instruction relating to the medical consequences of an act of  
16 terrorism that involves the use of a weapon of mass destruction in addition to the  
17 course of instruction required by paragraph (b) of subsection 3.

18 5. The Board shall encourage each licensee who treats or cares for persons  
19 who are more than 60 years of age to receive, as a portion of their continuing  
20 education, education in geriatrics and gerontology, including such topics as:

21 (a) The skills and knowledge that the licensee needs to address aging issues;

22 (b) Approaches to providing health care to older persons, including both  
23 didactic and clinical approaches;

24 (c) The biological, behavioral, social and emotional aspects of the aging  
25 process; and

26 (d) The importance of maintenance of function and independence for older  
27 persons.

28 6. The Board shall require each person licensed as an advanced practice  
29 registered nurse to receive as a portion of his or her continuing education at least 2  
30 hours of instruction every 4 years on evidence-based suicide prevention and  
31 awareness or another course of instruction on suicide prevention and awareness that  
32 is approved by the Board which the Board has determined to be effective and  
33 appropriate.

34 7. The Board shall encourage each person licensed as an advanced practice  
35 registered nurse to receive, as a portion of his or her continuing education, training  
36 and education in the diagnosis of rare diseases, including, without limitation:

37 (a) Recognizing the symptoms of pediatric cancer; and

38 (b) Interpreting family history to determine whether such symptoms indicate a  
39 normal childhood illness or a condition that requires additional examination.

53 (d) Submit all information required to complete the renewal.

1           2. In addition to the requirements of subsection 1, to renew registration as a  
2 registered behavior technician for the third time and every third renewal thereafter,  
3 a person must submit to an investigation of his or her criminal history in the manner  
4 prescribed in paragraph (b) of subsection 1 of NRS 641D.300.

5           3. The Board shall adopt regulations that require, as a prerequisite for the  
6 renewal of a license as a behavior analyst or assistant behavior analyst, each holder  
7 to complete continuing education, which must:

8           (a) Be consistent with nationally recognized standards for the continuing  
9 education of behavior analysts or assistant behavior analysts, as applicable.

10           (b) Include, without limitation, a requirement that the holder of a license  
11 receive at least 2 hours of instruction on evidence-based suicide prevention and  
12 awareness.

13           (c) Include, without limitation, a requirement that the holder of a license as a  
14 behavior analyst receive at least ~~4~~ 6 hours of instruction relating to cultural  
15 competency and diversity, equity and inclusion. Such instruction:

16           (1) May include the training provided pursuant to NRS 449.103, where  
17 applicable.

18           (2) Must be based upon a range of research from diverse sources.

19           (3) Must address persons of different cultural backgrounds, including,  
20 without limitation:

21           (I) Persons from various gender, racial and ethnic backgrounds;

22           (II) Persons from various religious backgrounds;

23           (III) Lesbian, gay, bisexual, transgender and questioning persons;

24           (IV) Children and senior citizens;

25           (V) Veterans;

26           (VI) Persons with a mental illness;

27           (VII) Persons with an intellectual disability, developmental disability  
28 or physical disability; and

29           (VIII) Persons who are part of any other population that a behavior  
30 analyst may need to better understand, as determined by the Board.

31           4. The Board shall not adopt regulations requiring a registered behavior  
32 technician to receive continuing education.

33           **Sec. 9.5.** The provisions of subsection 1 of NRS 218D.380 do not apply to  
34 any provision of this act which adds or revises a requirement to submit a report to  
35 the Legislature.

36           **Sec. 10.** 1. This section becomes effective upon passage and approval.

37           2. Sections 1 to 9.5, inclusive, of this act become effective:

38           (a) Upon passage and approval for the purpose of adopting any regulations and  
39 performing any other preparatory administrative tasks that are necessary to carry  
40 out the provisions of this act; and

41           (b) On January 1, 2024, for all other purposes.
