AN ACT relating to health care; providing for the limited licensure of certain graduates of a foreign medical school; providing for the licensure of associate physicians and associate osteopathic physicians; prescribing the conditions under which a limited licensee, associate physician or associate osteopathic physician is authorized to practice medicine; updating certain references; authorizing an associate physician or associate osteopathic physician to register to possess, administer, prescribe or dispense controlled substances; requiring certain insurers to cover medical services provided by an associate physician or associate osteopathic physician; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

Existing law provides for the licensing of physicians and physician assistants by the Board of Medical Examiners and for the licensing of osteopathic physicians by the State Board of Osteopathic Medicine. (NRS 630.160-630.1607, 630.258-630.2665, 630.271-630.2755, 633.305-633.469) Existing law also authorizes a graduate of a foreign medical school to obtain a restricted license to teach, research or practice medicine at a medical facility, medical research facility or medical school by completing certain requirements that are less stringent than the requirements to obtain an unrestricted license. (NRS 630.2645) If the holder of such a restricted license wishes to obtain an unrestricted license, existing law requires the holder to meet all of the qualifications ordinarily required to obtain an unrestricted license. (NRS 630.160, 630.2645)

**Sections 3-13 and 23-30** of this bill create special license types that authorize certain medical school graduates to engage in the supervised practice of medicine in a medically underserved area of this State. **Sections 2 and 22** of this bill define the term “medically underserved area” for those purposes. **Sections 14 and 31** of this bill make conforming changes to indicate the appropriate placement of **sections 2 and 22**, respectively, in the Nevada Revised Statutes.

17 **Section 3** authorizes the Board of Medical Examiners to issue a limited license to practice  
18 medicine to a graduate of a foreign medical school who agrees to practice in a medically  
19 underserved area and possesses certain other qualifications related to the practice of medicine.  
20 **Section 4** of this bill requires the holder of a limited license to practice medicine only under  
21 the supervision of a physician who holds an unrestricted license and with whom the holder of  
22 the limited license has entered into a practice agreement. **Section 5** of this bill: (1) provides  
23 for the expiration and renewal of a limited license; **and** (2) ~~authorizes a limited licensee to~~  
24 ~~apply for an unrestricted license upon completion of certain requirements; and (3)~~ requires  
25 the Board of Medical Examiners to adopt regulations governing the limited license. **Sections**  
26 **16, 17, 19 and 20** of this bill update references to certification by the Educational  
27 Commission for Foreign Medical Graduates in existing law to reflect the current practices of  
28 the Commission. **Sections 32 and 33** of this bill make revisions to reflect that internships for  
29 osteopathic physicians are currently approved by the Accreditation Council for Graduate  
30 Medical Education.

31 **Sections 6 and 23** of this bill authorize the Board of Medical Examiners and State Board  
32 of Osteopathic Medicine, respectively, to issue a limited license as an associate physician or  
33 associate osteopathic physician to an applicant who: (1) has graduated from certain medical  
34 schools in the United States or Canada; (2) agrees to perform medical services in a medically  
35 underserved area in this State; and (3) possesses certain other qualifications. **Sections 7 and**  
36 **24** of this bill limit the practice of an associate physician or associate osteopathic physician to:  
37 (1) certain primary care services that are within the skill, training and competence of the  
38 associate physician or associate osteopathic physician; and (2) practicing under the  
39 supervision and control of a supervising physician or supervising osteopathic physician and in  
40 a medically underserved area. **Sections 7 and 24:** (1) deem an associate physician or associate  
41 osteopathic physician working in a rural health clinic to be a physician assistant for certain  
42 purposes under federal law; and (2) exempt such an associate physician or associate  
43 osteopathic physician and his or her supervising physician or supervising osteopathic  
44 physician from state requirements governing supervision that are more stringent than federal  
45 law and regulations.

46 **Sections 7 and 24** require an associate physician or associate osteopathic physician to  
47 enter into a collaborative practice agreement with his or her supervising physician or  
48 supervising osteopathic physician. **Sections 7 and 24** require a supervising physician or  
49 supervising osteopathic physician to be on the same premises and available to assist an  
50 associate physician or associate osteopathic physician **who is practicing in a medically**  
51 **underserved urban area** for the first 30 days of supervision. **Sections 7 and 24 require a**  
52 **supervising physician or supervising osteopathic physician, or a designee thereof, to be**  
53 **on the same premises and available to assist an associate physician or associate**  
54 **osteopathic physician, as applicable, who is practicing in a medically underserved rural**  
55 **area at all times. Sections 7 and 24 also require the employer of an associate physician or**  
56 **associate osteopathic physician to credential and bill for services rendered by an**  
57 **associate physician or associate osteopathic physician in the same manner as a physician**  
58 **assistant.** **Sections 8 and 25** of this bill require a supervising physician and associate  
59 physician or supervising osteopathic physician and associate osteopathic physician to take  
60 certain measures to notify the public of their respective statuses and their relationship.  
61 **Sections 9 and 26** of this bill prescribe the required qualifications of a supervising physician  
62 or supervising osteopathic physician. **Sections 9 and 26** also: (1) provide that a supervising  
63 physician or supervising osteopathic physician is responsible for the practice of medicine or  
64 osteopathic medicine by the associate physician or associate osteopathic physician that he or  
65 she is supervising; and (2) require a supervising physician or supervising osteopathic  
66 physician to maintain liability insurance that covers malpractice by an associate physician or  
67 associate osteopathic physician. **Sections 9 and 26** prohibit a supervising physician or  
68 supervising osteopathic physician from entering into a collaborative practice agreement with  
69 more than three associate physicians or associate osteopathic physicians. **Sections 9 and 26**  
70 additionally prohibit the Board of Medical Examiners and the State Board of Osteopathic  
71 Medicine from disciplining a supervising physician or supervising osteopathic physician for  
72 legal activity of an associate physician or associate osteopathic physician that is within the  
73 scope of the relevant collaborative practice agreement. **Sections 10 and 27** of this bill  
74 prescribe the required provisions of a collaborative practice agreement. **Sections 18 and 34** of  
75 this bill require a physician or osteopathic physician to biennially submit to the Board of

76 Medical Examiners or the State Board of Osteopathic Medicine, as applicable, a list of the  
 77 names of each associate physician or associate osteopathic physician supervised by the  
 78 physician or osteopathic physician.

79 **Sections 11 and 28** of this bill authorize an associate physician or associate osteopathic  
 80 physician to prescribe or dispense certain controlled substances and establish the conditions  
 81 under which an associate physician or associate osteopathic physician may prescribe or  
 82 dispense such controlled substances. **Existing law: (1) authorizes the State Board of**  
 83 **Pharmacy to issue a registration certificate to authorize a physician assistant to possess,**  
 84 **administer, prescribe or dispense controlled substances, poisons, dangerous drugs or**  
 85 **devices in or out of the presence of his or her supervising physician; and (2) requires the**  
 86 **Board to adopt regulations governing the storage, security, recordkeeping and**  
 87 **transportation of controlled substances, poisons, dangerous drugs or devices by a**  
 88 **physician assistant. (NRS 639.1373) Section 34.5 of this bill authorizes the State Board of**  
 89 **Pharmacy to additionally issue such a registration certificate to associate physicians and**  
 90 **associate osteopathic physicians and to regulate associate physicians and associate**  
 91 **osteopathic physicians with such a certificate in the same manner as physician assistants.**  
 92 **Sections 12 and 29** of this bill provide for the expiration and renewal of the licenses. **Sections**  
 93 **13 and 30** of this bill require the Board of Medical Examiners and the State Board of  
 94 Osteopathic Medicine to: (1) adopt regulations to carry out the provisions of law governing  
 95 associate physicians and associate osteopathic physicians; and (2) work with medical schools  
 96 in this State to develop and implement a program for associate physicians and associate  
 97 osteopathic physicians to gain knowledge and experience that may count as credit towards a  
 98 residency program in this State.

99 **Sections 15 and 33** of this bill make conforming changes to ensure that the limited  
 100 licenses created by this bill are treated the same as other special licenses for physicians or  
 101 osteopathic physicians, as applicable. **Section 35** of this bill makes a conforming change to  
 102 clarify the meaning of the terms “associate physician” and “associate osteopathic physician.”

103 Existing law requires public and private policies of insurance regulated under Nevada law  
 104 to include certain coverage. (NRS 287.010, 287.04335, 422.2712-422.27241, 689A.04033-  
 105 689A.0465, 689B.0303-689B.0379, 689C.1655-689C.169, 689C.194-689C.195, 695A.184-  
 106 689A.1875, 695B.1901-695B.1949, 695C.1691-695C.176, 695G.162-695G.177) Existing law  
 107 also requires employers to provide certain benefits to employees, including the coverage  
 108 required of health insurers, if the employer provides health benefits for its employees. (NRS  
 109 608.1555) **Sections 37-40, 42, 43, 45-48 and 50** of this bill require public and private health  
 110 plans, including Medicaid, to provide coverage for medical services provided by an associate  
 111 physician or associate osteopathic physician, if the health plan covers the same medical  
 112 services when performed by a different provider of health care. **Sections 36, 41 and 44** of this  
 113 bill make conforming changes to indicate the proper placement of **sections 39, 40 and 43**  
 114 in the Nevada Revised Statutes. **Section 49** of this bill authorizes the Commissioner of Insurance  
 115 to suspend or revoke the certificate of a health maintenance organization that fails to comply  
 116 with the requirement of **section 47** of this bill to cover medical services provided by an  
 117 associate physician or associate osteopathic physician. The Commissioner would also be  
 118 authorized to take such actions against other health insurers who fail to comply with the  
 119 requirements of **sections 40, 42, 43, 45, 46 and 50**.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
 SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 630 of NRS is hereby amended by adding thereto the  
 2 provisions set forth in sections 2 to 13, inclusive, of this act.

3 **Sec. 2. “Medically underserved area” means an area designated as:**

4 **1. A health professional shortage area for primary care by the United States**  
 5 **Secretary of Health and Human Services pursuant to 42 U.S.C. § 254e; or**

6 **2. An area with a medically underserved population by the United States**  
 7 **Secretary of Health and Human Services pursuant to 42 U.S.C. § 254b.**

1       **Sec. 3.** *Except as otherwise provided in NRS 630.161, the Board may issue*  
2 *a limited license to practice medicine to an applicant who:*

3       1. *Is a graduate of a foreign medical school and is certified by the*  
4 *Educational Commission for Foreign Medical Graduates;*

5       2. *Has passed the Step 1 Exam and Step 2 CK Exam of the United States*  
6 *Medical Licensing Examination; and*

7       3. *Commits to serving at least ~~1~~ 2 years in a medically underserved area of*  
8 *this State.*

9       **Sec. 4.** 1. *The holder of a limited license issued pursuant to section 3 of*  
10 *this act shall not practice medicine except:*

11       (a) *Under the supervision and control of a physician who holds an active*  
12 *unrestricted license to practice medicine in this State and practices in the same or*  
13 *a substantially similar medical specialty; and*

14       (b) *In a facility or office or for an organization that has authorized the*  
15 *licensee to practice medicine in the facility or office or for the organization, as*  
16 *applicable.*

17       2. *The holder of a limited license issued pursuant to section 3 of this act*  
18 *shall file with the Board a written practice agreement between the limited licensee*  
19 *and the physician supervising him or her pursuant to paragraph (a) of subsection*  
20 *1.*

21       3. *A physician supervising a limited licensee pursuant to paragraph (a) of*  
22 *subsection 1:*

23       (a) *Is responsible for any act that constitutes the practice of medicine by the*  
24 *limited licensee; and*

25       (b) *Must have insurance that includes coverage for any claim of malpractice*  
26 *against the limited licensee.*

27       **Sec. 5.** 1. *A limited license issued pursuant to section 3 of this act expires*  
28 *2 years after it is issued. The Board may renew the license upon application by*  
29 *the limited licensee.*

30       2. ~~*The Board may issue an unrestricted license to practice medicine upon*~~  
31 ~~*the submission of an application by the holder of a limited license issued*~~  
32 ~~*pursuant to section 3 of this act who has*~~

33 ~~*(a) Completed at least 3 years of practice as a full-time physician under the*~~  
34 ~~*limited license;*~~

35 ~~*(b) Fulfilled all other statutory requirements for licensure pursuant to NRS*~~  
36 ~~*630.160 except the requirements of paragraph (c) of subsection 2 of NRS*~~  
37 ~~*630.160; and*~~

38 ~~*(c) Not been the subject of disciplinary action by a medical board in any*~~

40 ~~*3.*~~ *The Board shall adopt regulations necessary to carry out the provisions*  
41 *of this section and sections 3 and 4 of this act, including, without limitation:*

42       (a) *Any additional requirements for the issuance or renewal of a limited*  
43 *license to which this section and sections 3 and 4 of this act apply;*

44       (b) *The required fees for the issuance and renewal of such a limited license;*  
45 *and*

46       (c) *The required provisions of a practice agreement between a limited*  
47 *licensee and his or her supervising physician pursuant to subsection 2 of section*  
48 *4 of this act.*

49       **Sec. 6.** 1. *Except as otherwise provided in NRS 630.161, the Board may*  
50 *issue a limited license for a person to practice medicine as an associate physician*  
51 *if the applicant:*

52       (a) *Has received the degree of doctor of medicine from a medical school in*  
53 *the United States or Canada:*

1 (1) *Approved by the Liaison Committee on Medical Education of the*  
2 *American Medical Association and Association of American Medical Colleges;*  
3 *or*

4 (2) *Which provides a course of professional instruction equivalent to that*  
5 *provided in medical schools in the United States approved by the Liaison*  
6 *Committee on Medical Education;*

7 (b) *Except as otherwise provided in subsection 2, has passed the Step 1 Exam*  
8 *and Step 2 CK Exam of the United States Medical Licensing Examination or an*  
9 *examination deemed equivalent by the Board, not earlier than:*

10 (1) *Three years before receiving the degree of doctor of medicine, if the*  
11 *applicant received the degree of doctor of medicine within 3 years before applying*  
12 *for licensure; or*

13 (2) *Three years before applying for licensure, in all other cases;*

14 (c) *Commits to practicing in a medically underserved area of this State; and*

15 (d) *Is proficient in the English language.*

16 2. *An applicant who has passed the examinations required by paragraph (b)*  
17 *of subsection 1 at any time is otherwise exempt from the requirements of that*  
18 *paragraph if the applicant:*

19 (a) *Served as a resident in a program described in sub-subparagraph (1) of*  
20 *subparagraph (1) of paragraph (c) of subsection 2 of NRS 630.160 within 30 days*  
21 *before applying for licensure under this section; and*

22 (b) *Served continuously as such a resident beginning on or before the most*  
23 *recent date on which the applicant met the requirements of paragraph (b) of*  
24 *subsection 1.*

25 **Sec. 7. 1. An associate physician shall only practice medicine:**

26 (a) *In the areas of family medicine, pediatrics, internal medicine, psychiatry*  
27 *and obstetrics and gynecology;*

28 (b) *Under the supervision and control of a physician:*

29 (1) *Who meets the requirements of section 9 of this act; and*

30 (2) *With whom the associate physician has entered into a collaborative*  
31 *practice agreement that meets the requirements of section 10 of this act; and*

32 (c) *In a medically underserved area of this State.*

33 2. *An associate physician shall not practice medicine in a manner that*  
34 *exceeds the skill, training and competence of the associate physician or his or her*  
35 *supervising physician.*

36 3. *For the first 30 days during which an associate physician practices*  
37 *medicine in a medically underserved urban area under the supervision of a new*  
38 *supervising physician, the supervising physician must be physically present on*  
39 *the same premises and available to assist the associate physician.*

40 4. *An associate physician shall not practice medicine in a medically*  
41 *underserved rural area unless the supervising physician or another physician*  
42 *designated by the supervising physician is physically present on the same*  
43 *premises and available to assist the associate physician.*

44 5. *An associate physician working in a rural health clinic, as defined in 42*  
45 *U.S.C. § 1395x(aa)(2), shall be considered to be a physician assistant for the*  
46 *purposes of the regulations of the Centers for Medicare and Medicaid Services of*  
47 *the United States Department of Health and Human Services. Such an associate*  
48 *physician and his or her supervising physician are not required to comply with*  
49 *the requirements of any regulations adopted pursuant to section 13 of this act*  
50 *governing the supervision of an associate physician that are more stringent than*  
51 *the requirements of federal law and regulations.*

52 6. *A person or entity that employs an associate physician shall credential*  
53 *the associate physician and bill for services rendered by the associate physician in*

1 the same manner as the person or entity credentials and bills for the services of a  
2 physician assistant.

3 7. As used in this section:

4 (a) "Medically underserved rural area" means a medically underserved area  
5 in a county whose population is less than 100,000.

6 (b) "Medically underserved urban area" means a medically underserved  
7 area that is located in a county whose population is 100,000 or more.

8 **Sec. 8. 1.** *The supervising physician of an associate physician shall*  
9 *prominently display a disclosure at every office where the associate physician*  
10 *practices medicine explaining to patients that the patient may be seen by an*  
11 *associate physician and the patient may instead request to be seen by the*  
12 *supervising physician.*

13 *2. An associate physician shall clearly identify himself or herself as an*  
14 *associate physician, including, without limitation, by wearing an identification*  
15 *badge that clearly identifies the person as an associate physician. An associate*  
16 *physician may identify himself or herself as a doctor.*

17 *3. While acting as the supervising physician of an associate physician, a*  
18 *physician shall wear an identification badge that clearly identifies the person as a*  
19 *supervising physician of an associate physician.*

20 **Sec. 9. 1.** *A physician shall not serve as the supervising physician of an*  
21 *associate physician pursuant to paragraph (b) of subsection 1 of section 7 of this*  
22 *act or the designee of a supervising physician pursuant to subsection 4 of section*  
23 *7 of this act unless the physician:*

24 *(a) Holds an active unrestricted license to practice medicine in this State;*  
25 *and*

26 *(b) Practices in the same specialty area as the associate physician or a*  
27 *substantially similar specialty area as the associate physician.*

28 *2. The supervising physician of an associate physician:*

29 *(a) Is responsible for any act that constitutes the practice of medicine by the*  
30 *associate physician;*

31 *(b) Must have insurance that includes coverage for any claim of malpractice*  
32 *against the associate physician; and*

33 *(c) May not enter into a collaborative practice agreement with more than*  
34 *three associate physicians.*

35 *3. The Board may not deny, revoke, suspend or take any other disciplinary*  
36 *action against the supervising physician of an associate physician for any act*  
37 *performed by the associate physician that:*

38 *(a) Is performed in accordance with the collaborative practice agreement*  
39 *entered into pursuant to section 7 of this act; and*

40 *(b) Does not violate applicable federal, state or local laws or the regulations*  
41 *of the Board.*

42 **Sec. 10. 1.** *A collaborative practice agreement entered into pursuant to*  
43 *section 7 of this act must be in writing and must include, without limitation:*

44 *(a) The names, home and business addresses and telephone numbers of the*  
45 *supervising physician and associate physician;*

46 *(b) A list of each location where the associate physician may practice*  
47 *medicine, including, without limitation, the prescribing and dispensing of*  
48 *controlled substances;*

49 *(c) Any specialty or board certification held by the supervising physician;*

50 *(d) Any certification held by the associate physician;*

51 *(e) Requirements governing collaboration between the supervising physician*  
52 *and the associate physician, including, without limitation;*



1 (1) The geographic proximity which ~~f, except as otherwise provided in~~  
2 ~~subsection 4.]~~ must exist between the supervising physician and the associate  
3 physician while the associate physician is practicing medicine; and

4 (2) A plan for alternative supervision if the supervising physician is  
5 absent, incapacitated or otherwise unavailable;

6 (f) Any controlled substance the supervising physician authorizes the  
7 associate physician to prescribe or dispense in accordance with section 11 of this  
8 act;

9 (g) The procedure by which the supervising physician will review the  
10 standard of care the associate physician is providing to patients, ~~[including,~~  
11 ~~without limitation, a requirement that, at least every 14 days, the associate~~  
12 ~~physician submit to the supervising physician]~~

13 ~~(1) At least 10 percent of the charts for patients whom the associate~~  
14 ~~physician cared for and did not prescribe or dispense a controlled substance; and~~

15 ~~(2) At least 20 percent of the charts for patients whom the associate~~  
16 ~~physician cared for and prescribed or dispensed a controlled substance.]~~ which  
17 must comply with the regulations adopted pursuant to section 13 of this act;

18 (h) The duration of the collaborative practice agreement; and

19 (i) A statement of any other collaborative practice agreements into which:

20 (1) The supervising physician has entered into with another associate  
21 physician; and

22 (2) The associate physician has entered into with another supervising  
23 physician.

24 2. Upon entering into a new collaborative practice agreement with an  
25 associate physician, a supervising physician shall file with the Board:

26 (a) A copy of the agreement; and

27 (b) Proof that any controlled substance listed pursuant to paragraph (f) of  
28 subsection 1 is within the skill, training and competence of the associate  
29 physician and his or her supervising physician to prescribe and dispense.

30 3. A supervising physician or associate physician may terminate a  
31 collaborative practice agreement or a relationship with a supervising physician or  
32 an associate physician, as applicable, at any time. Any provision of a  
33 collaborative practice agreement or any other agreement that limits the authority  
34 of a supervising physician or an associate physician to terminate a collaborative  
35 practice agreement or such a relationship is void.

48 **Sec. 11. 1. An associate physician may prescribe or dispense the**
