SUMMARY—Revises provisions relating to sidewalk vendors. (BDR 20-53)

AN ACT relating to sidewalk vendors; establishing certain requirements for the regulation of sidewalk vendors by the governing body of certain counties and cities; requiring a local board of health to adopt certain regulations relating to sidewalk vendors who sell food; creating the Task Force on Safe Sidewalk Vending; setting forth the membership and duties of the Task Force on Safe Sidewalk Vending; providing penalties; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Existing law grants a governing body of a county or city all powers necessary and proper to address matters of local concern. (NRS 244.146, 268.0035) **Sections 1-11 and 15-24.5** of this bill set forth various requirements for the licensing and regulation of sidewalk vendors of food by the governing body of certain counties and cities.

Sections 2 and 16 of this bill provide that the provisions of **sections 1-10 and 15-25** of this bill apply only to a county whose population is 100,000 or more (currently Clark and Washoe Counties) or to a city in a county whose population is 100,000 or more.

Sections 3 and 17 of this bill define the term “sidewalk vendor.”

Sections 7 and 21 of this bill: (1) authorize a governing body of a county or city to adopt an ordinance regulating sidewalk vendors; and (2) require the governing body of a county or city that adopts such an ordinance to post on its Internet website a map of the areas where a person may engage in the act of sidewalk vending. **Sections 7 and 21** also prohibit a governing body of a county or city from, with certain exceptions: (1) enforcing or enacting a complete prohibition on sidewalk vending; (2) imposing criminal penalties for the act of sidewalk vending in a residential area; or (3) regulating sidewalk vendors, except in compliance or substantial compliance with the provisions of this bill.

Sections 7.5 and 21.5 of this bill prohibit a person, with certain exceptions, from selling food, beverages or merchandise upon a public sidewalk or pedestrian path from a conveyance within 1,500 feet of: (1) a resort hotel; (2) certain event facilities; (3) certain convention facilities; and (4) a median of a highway, if the median is adjacent to a parking lot. **Sections 7.5 and 21.5** authorize, with certain exceptions, a person to sell food, beverages or

22 merchandise within 1,500 feet of such a location if the area is zoned exclusively for residential
 23 use.
 24 **Sections 8 and 22** of this bill authorize a governing body of a county or city to require
 25 that a sidewalk vendor: (1) hold certain state and local permits or licenses; and (2) submit
 26 certain information to the county or city.
 27 **Sections 9 and 23** of this bill provide that an ordinance adopted by a governing body of a
 28 county or city may, with certain exceptions, impose additional requirements regulating the
 29 time, place and manner of sidewalk vending.
 30 **Sections 10 and 24** of this bill authorize a governing body of a county or city to impose
 31 by ordinance certain penalties and fines for a violation of the provisions of the ordinance
 32 regulating sidewalk vendors or for operating without any required license or permit for
 33 sidewalk vendors.
 34 **Sections 10.5 and 24.5** of this bill provide that the provisions of this bill governing the
 35 regulation of sidewalk vendors by a governing body of a county or city shall not be construed
 36 to: (1) exempt a person from complying with any state or local law or regulation; (2) provide a
 37 defense to any criminal act that is not related to the act of sidewalk vending; or (3) affect
 38 certain rights of a private property owner to use or authorize or limit the use of a privately
 39 owned sidewalk.
 40 **Section 11** of this bill makes a conforming change to create an exception to the authority
 41 of a board of county commissioners to regulate all character of lawful trades, callings,
 42 industries, occupations, professions and business.
 43 Existing law authorizes a local board of health to adopt regulations relating to food
 44 establishments. (NRS 446.940) **Section 25** of this bill requires a local board of health to adopt
 45 regulations to establish a process for a person to apply for a permit, license or other
 46 authorization from the local board of health to operate as a sidewalk vendor and that allow a
 47 person applying for any such authorization to operate as a sidewalk vendor to: (1) pay any
 48 fees required by the local board of health using a payment plan; and (2) obtain any necessary
 49 certification as a food handler if the person does not have a driver's license or identification
 50 card.
 51 **Section 13** of this bill creates the Task Force on Safe Sidewalk Vending in the Office of
 52 the Secretary of State and requires the Secretary of State to appoint nine members to the Task
 53 Force. **Section 14** of this bill requires the Task Force to review existing laws governing
 54 sidewalk vending and recommend approaches to improve the laws of this State and cities and
 55 counties of this State governing sidewalk vending.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
 SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 244 of NRS is hereby amended by adding thereto the
 2 provisions set forth as sections 2 to 10.5, inclusive, of this act.
 3 **Sec. 2.** *The provisions of sections 2 to 10.5, inclusive, of this act apply only*
 4 *to a county whose population is 100,000 or more.*
 5 **Sec. 3.** *As used in sections 2 to 10.5, inclusive, of this act, unless the*
 6 *context otherwise requires, "sidewalk vendor" means a person who sells food*
 7 *upon a public sidewalk or other pedestrian path from a conveyance, including,*
 8 *without limitation, a pushcart, stand, display, pedal-driven cart, wagon, showcase*
 9 *or rack. The term includes, without limitation, a nonstationary sidewalk vendor*
 10 *and a stationary sidewalk vendor.*
 11 **Sec. 4.** (Deleted by amendment.)
 12 **Sec. 5.** (Deleted by amendment.)
 13 **Sec. 6.** (Deleted by amendment.)
 14 **Sec. 7.** *1. A board of county commissioners may adopt an ordinance*
 15 *regulating sidewalk vendors in accordance with the requirements of sections 2 to*
 16 *10.5, inclusive, of this act.*

1 2. Except as otherwise provided in sections 2 to 10.5, inclusive, of this act, a
2 board of county commissioners shall not:

3 (a) Enact or enforce a complete prohibition on sidewalk vendors.

4 (b) Impose a criminal penalty on the act of sidewalk vending in a residential
5 area.

6 3. A board of county commissioners that does not adopt an ordinance that
7 complies or substantially complies with sections 2 to 10.5, inclusive, of this act,
8 shall not cite, fine or prosecute a sidewalk vendor for a violation of any rule or
9 regulation that is inconsistent with the provisions of sections 2 to 10.5, inclusive,
10 of this act.

11 4. If a board of county commissioners adopts an ordinance pursuant to this
12 section, the board of county commissioners shall post on its Internet website a
13 map of the zones where a person may engage in the act of sidewalk vending.

14 **Sec. 7.5.** 1. Except as otherwise provided in subsection 4, a person shall
15 not sell food, beverages or merchandise upon a public sidewalk or pedestrian
16 path from a conveyance, including, without limitation, a pushcart, stand, display,
17 pedal-driven cart, wagon, showcase or rack, within 1,500 feet of:

18 (a) A resort hotel, as defined in NRS 463.01865;

19 (b) An event facility that has seating capacity for at least 20,000 people and is
20 constructed to accommodate a major or minor league sports team;

21 (c) A convention facility operated by a county fair and recreation board; or

22 (d) A median of a highway, if the median is adjacent to a parking lot.

23 2. For any violation of subsection 1, a board of county commissioners may
24 impose a criminal, civil or administrative penalty in accordance with an
25 ordinance adopted by the board of county commissioners pursuant to section 7 of
26 this act. The maximum criminal penalty that may be specified in an ordinance
27 adopted pursuant to section 7 of this act is a misdemeanor. A violation of
28 subsection 1 or such an ordinance does not constitute a crime of moral turpitude.

29 3. Nothing in this section authorizes a person to sell merchandise 1,500 feet
30 or more from:

31 (a) A resort hotel, as defined in NRS 463.01865;

32 (b) An event facility that has seating capacity for at least 20,000 people and is
33 constructed to accommodate a major or minor league sports team;

34 (c) A convention facility operated by a county fair and recreation board; or

35 (d) A median of a highway that is adjacent to a parking lot.

36 4. A person may sell food, beverages or merchandise within 1,500 feet of a
37 location described in subsection 1 if the conveyance from which the person is
38 selling food, beverages or merchandise is located in an area which is zoned
39 exclusively for residential use, unless the area is on a public sidewalk or
40 pedestrian path that is immediately adjacent to a location described in subsection
41 1.

42 **Sec. 8.** An ordinance adopted by a board of county commissioners
43 regulating sidewalk vendors pursuant to section 7 of this act may require that a
44 sidewalk vendor:

45 1. Hold:

46 (a) A permit or license for sidewalk vending;

47 (b) A state business license; and

48 (c) Any other licenses issued by a state or local governmental agency to the
49 extent otherwise required by law.

50 ↪ Nothing in this section shall be construed to authorize a sidewalk vendor to not
51 comply with any requirement to obtain a state business license or other license
52 issued by a state agency or any permit or license issued by a local government,
53 agency or board of health to the extent otherwise required by law.

1 2. *Submit information to the designated representative of the county*
2 *relating to his or her operations, including, without limitation:*

3 (a) *The name and current mailing address of the sidewalk vendor;*

4 (b) *If the sidewalk vendor is an agent of an individual, company, partnership*
5 *or corporation, the name and business address of the principal office;*

6 (c) *A description of the food offered for sale; and*

7 (d) *A certification by the sidewalk vendor that, to the best of his or her*
8 *knowledge and belief, the information submitted pursuant to this section is true.*

9 **Sec. 9. 1.** *In addition to the provisions of section 8 of this act, an*
10 *ordinance adopted by a board of county commissioners that regulates sidewalk*
11 *vendors may:*

12 (a) *Adopt requirements regulating the time, place and manner of sidewalk*
13 *vending if the requirements are objectively and directly related to the health,*
14 *safety or welfare concerns of the public, which may include, without limitation:*

15 (1) *Restrictions on the hours of operation of a sidewalk vendor, which*
16 *may not be more restrictive than any restriction imposed by any applicable*
17 *ordinance regulating noise or any restriction on the hours of operation imposed*
18 *on home-based businesses that are similar to sidewalk vending; and*

19 (2) *Requirements to:*

20 (I) *Maintain sanitary conditions and comply with the regulations*
21 *adopted by a local board of health pursuant to section 25 of this act.*

22 (II) *Ensure compliance with the Americans with Disabilities Act of*
23 *1990, 42 U.S.C. §§ 12101 et seq.*

24 (b) *Restrict or prohibit sidewalk vendors from operating:*

25 (1) *In areas located within the immediate vicinity of a farmers' market*
26 *licensed pursuant to NRS 244.337 during the operating hours of the farmers'*
27 *market.*

28 (2) *Within the immediate vicinity of an area designated for a temporary*
29 *special event by the board of county commissioners, provided that any notice or*
30 *other right provided to affected businesses or property owners during the*
31 *temporary special event is also provided to any sidewalk vendors permitted to*
32 *operate in the area, if applicable. A prohibition of sidewalk vendors pursuant to*
33 *this subparagraph must only be effective for the limited duration of the temporary*
34 *special event.*

35 (3) *Within a set distance established by the board of county*
36 *commissioners of:*

37 (I) *Except as otherwise provided in section 7.5 of this act, an*
38 *establishment that holds a nonrestricted gaming license described in subsection 1*
39 *or 2 of NRS 463.0177;*

40 (II) *A food establishment;*

41 (III) *A school, child care facility, community center, polling place,*
42 *religious institution or place of worship or park or recreational facility owned by*
43 *the county; or*

44 (IV) *A highly trafficked pedestrian mall, convention center or*
45 *designated entertainment district.*

46 (4) *In residential areas, but must not prohibit nonstationary sidewalk*
47 *vendors from operating in such areas.*

48 2. *As used in this section:*

49 (a) *"Entertainment district" means a contiguous area located within a*
50 *county that:*

51 (1) *Is zoned for or customarily used for commercial purposes; and*

1 (2) *Contains any number and combination of restaurants, bars,*
2 *entertainment establishments, music venues, theaters, art galleries or studios,*
3 *dance studios or athletic stadiums.*

4 (b) *“Pedestrian mall” has the meaning ascribed to it in NRS 268.811.*

5 **Sec. 10.** *1. In accordance with an ordinance adopted pursuant to sections*
6 *2 to 10.5, inclusive, of this act, a board of county commissioners or its designee*
7 *may:*

8 (a) *Suspend or revoke any permit or license for sidewalk vending for any*
9 *violation of the ordinance or the terms or conditions of the permit or license in*
10 *the same manner as such suspensions or revocations are imposed for other types*
11 *of businesses;*

12 (b) *Impose a civil penalty on the holder of a permit or license for sidewalk*
13 *vending that engages in sidewalk vending in a prohibited residential area or for*
14 *any violation of the terms or conditions of the permit or license in accordance*
15 *with the schedule of civil penalties set forth in the ordinance, if any;*

16 (c) *Impose a civil penalty on a person who engages in sidewalk vending*
17 *without holding a permit or license for sidewalk vending required by the*
18 *ordinance in accordance with the schedule of civil penalties set forth in the*
19 *ordinance, if any; and*

20 (d) *Authorize any other action to prevent the sale or consumption of any food*
21 *or drink that violates any requirements established by a local board of health*
22 *pursuant to section 25 of this act.*

23 2. *For any person who engages in sidewalk vending without holding a*
24 *permit or license for sidewalk vending or who engages in sidewalk vending in a*
25 *prohibited area, a board of county commissioners or its designee may also take*
26 *any other action authorized under existing law to enforce any prohibition on*
27 *unlicensed business activities, including, without limitation, any action*
28 *authorized pursuant to section 7.5 of this act.*

29 **Sec. 10.5.** *The provisions of sections 2 to 10.5, inclusive, of this act shall*
30 *not be construed to:*

31 1. *Exempt a person from complying with any state or local law or*
32 *regulation;*

33 2. *Provide a defense to any criminal charge unrelated to the act of sidewalk*
34 *vending; or*

35 3. *Affect the rights of a private property owner to use or authorize or limit*
36 *the use of a sidewalk that is owned by the private property owner, including,*
37 *without limitation, a privately owned sidewalk that is subject to an easement for*
38 *public access.*

39 **Sec. 11.** NRS 244.335 is hereby amended to read as follows:

40 244.335 1. Except as otherwise provided in subsections 2, 3, 4 and 9, and
41 NRS 244.33501, 244.35253, 244.3535 and 244.35351 to 244.35359, inclusive, a
42 board of county commissioners may:

43 (a) Except as otherwise provided in NRS 244.331 to 244.3345, inclusive,
44 598D.150 and 640C.100, *and sections 2 to 10.5, inclusive, of this act*, regulate all
45 character of lawful trades, callings, industries, occupations, professions and
46 business conducted in its county outside of the limits of incorporated cities and
47 towns.

48 (b) Except as otherwise provided in NRS 244.3359 and 576.128, fix, impose
49 and collect a license tax for revenue or for regulation, or for both revenue and
50 regulation, on such trades, callings, industries, occupations, professions and
51 business.

52 2. The county license boards have the exclusive power in their respective
53 counties to regulate entertainers employed by an entertainment by referral service

1 and the business of conducting a dancing hall, escort service, entertainment by
2 referral service or gambling game or device permitted by law, outside of an
3 incorporated city. The county license boards may fix, impose and collect license
4 taxes for revenue or for regulation, or for both revenue and regulation, on such
5 employment and businesses.

6 3. A board of county commissioners shall not require that a person who is
7 licensed as a contractor pursuant to chapter 624 of NRS obtain more than one
8 license to engage in the business of contracting or pay more than one license tax
9 related to engaging in the business of contracting, regardless of the number of
10 classifications or subclassifications of licensing for which the person is licensed
11 pursuant to chapter 624 of NRS.

12 4. The board of county commissioners or county license board shall not
13 require a person to obtain a license or pay a license tax on the sole basis that the
14 person is a professional. As used in this subsection, "professional" means a person
15 who:

16 (a) Holds a license, certificate, registration, permit or similar type of
17 authorization issued by a regulatory body as defined in NRS 622.060 or who is
18 regulated pursuant to the Nevada Supreme Court Rules; and

19 (b) Practices his or her profession for any type of compensation as an
20 employee.

21 5. The county license board shall provide upon request an application for a
22 state business license pursuant to chapter 76 of NRS. No license to engage in any
23 type of business may be granted unless the applicant for the license:

24 (a) Signs an affidavit affirming that the business has complied with the
25 provisions of chapter 76 of NRS; or

26 (b) Provides to the county license board the business identification number of
27 the applicant assigned by the Secretary of State pursuant to NRS 225.082 which the
28 county may use to validate that the applicant is currently in good standing with the
29 State and has complied with the provisions of chapter 76 of NRS.

30 6. No license to engage in business as a seller of tangible personal property
31 may be granted unless the applicant for the license:

32 (a) Presents written evidence that:

33 (1) The Department of Taxation has issued or will issue a permit for this
34 activity, and this evidence clearly identifies the business by name; or

35 (2) Another regulatory agency of the State has issued or will issue a license
36 required for this activity; or

37 (b) Provides to the county license board the business identification number of
38 the applicant assigned by the Secretary of State pursuant to NRS 225.082 which the
39 county may use to validate that the applicant is currently in good standing with the
40 State and has complied with the provisions of paragraph (a).

41 7. Any license tax levied for the purposes of NRS 244.3358 or 244A.597 to
42 244A.655, inclusive, constitutes a lien upon the real and personal property of the
43 business upon which the tax was levied until the tax is paid. The lien has the same
44 priority as a lien for general taxes. The lien must be enforced:

45 (a) By recording in the office of the county recorder, within 6 months after the
46 date on which the tax became delinquent or was otherwise determined to be due
47 and owing, a notice of the tax lien containing the following:

48 (1) The amount of tax due and the appropriate year;

49 (2) The name of the record owner of the property;

50 (3) A description of the property sufficient for identification; and

51 (4) A verification by the oath of any member of the board of county
52 commissioners or the county fair and recreation board; and

1 (b) By an action for foreclosure against the property in the same manner as an
2 action for foreclosure of any other lien, commenced within 2 years after the date of
3 recording of the notice of the tax lien, and accompanied by appropriate notice to
4 other lienholders.

5 8. The board of county commissioners may delegate the authority to enforce
6 liens from taxes levied for the purposes of NRS 244A.597 to 244A.655, inclusive,
7 to the county fair and recreation board. If the authority is so delegated, the board of
8 county commissioners shall revoke or suspend the license of a business upon
9 certification by the county fair and recreation board that the license tax has become
10 delinquent, and shall not reinstate the license until the tax is paid. Except as
11 otherwise provided in NRS 239.0115 and 244.3357, all information concerning
12 license taxes levied by an ordinance authorized by this section or other information
13 concerning the business affairs or operation of any licensee obtained as a result of
14 the payment of such license taxes or as the result of any audit or examination of the
15 books by any authorized employee of a county fair and recreation board of the
16 county for any license tax levied for the purpose of NRS 244A.597 to 244A.655,
17 inclusive, is confidential and must not be disclosed by any member, officer or
18 employee of the county fair and recreation board or the county imposing the license
19 tax unless the disclosure is authorized by the affirmative action of a majority of the
20 members of the appropriate county fair and recreation board. Continuing disclosure
21 may be so authorized under an agreement with the Department of Taxation or
22 Secretary of State for the exchange of information concerning taxpayers.

23 9. Except as otherwise provided by regulations adopted by the Cannabis
24 Compliance Board pursuant to NRS 678B.645, a board of county commissioners
25 shall not license or otherwise allow a person to operate a business that allows
26 cannabis, as defined in NRS 678A.085, or cannabis products, as defined in NRS
27 678A.120, to be consumed on the premises of the business, other than a cannabis
28 consumption lounge, as defined in NRS 678A.087, in accordance with the
29 provisions of chapter 678B of NRS.

30 **Sec. 12.** Chapter 225 of NRS is hereby amended by adding thereto the
31 provisions set forth as sections 13 and 14 of this act.

32 **Sec. 13. 1. *The Task Force on Safe Sidewalk Vending is hereby created***
33 ***within the Office of the Secretary of State.***

34 **2. *The Task Force consists of the following nine members appointed by the***
35 ***Secretary of State:***

36 ***(a) A representative of a health district in a county whose population is***
37 ***100,000 or more;***

38 ***(b) A representative employed by a county or city whose primary duties are***
39 ***the performance of tasks related to business licensing;***

40 ***(c) A representative of the gaming or restaurant industries in this State;***

41 ***(d) A representative from a law enforcement agency in a county whose***
42 ***population is 100,000 or more;***

43 ***(e) A representative from the Office of the Secretary of State; and***

44 ***(f) Four members at large chosen by the Secretary of State, with priority***
45 ***given to persons who are sidewalk vendors or are affiliated with a community***
46 ***organization that represents and affiliates with sidewalk vendors.***

47 **3. *The members of the Task Force:***

48 ***(a) Shall serve terms of 3 years. A member may be reappointed to the Task***
49 ***Force and any vacancy must be filled in the same manner as the original***
50 ***appointment.***

51 ***(b) Serve without compensation.***

1 4. A majority of the members of the Task Force constitutes a quorum for
2 the transaction of business, and a majority of these members present at the
3 meeting is sufficient for any official action taken by the Task Force.

4 5. To support the activities of the Task Force, the Secretary of State may
5 establish an advisory board composed of representatives of counties, cities and
6 businesses, including, without limitation, a member of a health department or
7 health district.

8 6. The Task Force may apply for and accept any gift, donation, bequest,
9 grant or other source of money to carry out the duties of the Task Force.

10 **Sec. 14.** 1. The Task Force on Safe Sidewalk Vending created by section
11 13 of this act shall:

12 (a) Review the existing laws of this State, the cities and counties in this State
13 and those of other states and municipalities relating to sidewalk vending; and

14 (b) Recommend approaches to improve the laws of this State and the cities
15 and counties of this State to:

16 (1) Legalize sidewalk vending;

17 (2) Simplify and standardize the laws governing sidewalk vending;

18 (3) Remove unnecessary barriers to sidewalk vending;

19 (4) Protect the public health, safety and welfare by ensuring sidewalk
20 vendors follow clear and narrowly tailored laws which address demonstrable
21 health, safety and welfare risks; and

22 (5) Develop enforcement mechanisms, including, without limitation, civil
23 penalties for sidewalk vendors that operate in authorized areas.

24 2. On or before September 1 of each even-numbered year, the Task Force
25 shall submit to the Director of the Legislative Counsel Bureau for submission to
26 the Legislative Commission a written report. The report must include, without
27 limitation, a summary of the work of the Task Force and any recommendations
28 for legislation and regulations.

29 **Sec. 15.** Chapter 268 of NRS is hereby amended by adding thereto the
30 provisions set forth as sections 16 to 24.5, inclusive, of this act.

31 **Sec. 16.** The provisions of sections 16 to 24.5, inclusive, of this act apply
32 only to a city in a county whose population is 100,000 or more.

33 **Sec. 17.** As used in sections 16 to 24.5, inclusive, of this act, unless the
34 context otherwise requires, "sidewalk vendor" means a person who sells food
35 upon a public sidewalk or other pedestrian path from a conveyance, including,
36 without limitation, a pushcart, stand, display, pedal-driven cart, wagon, showcase
37 or rack. The term includes, without limitation, a nonstationary sidewalk vendor
38 and a stationary sidewalk vendor.

42 **Sec. 21.** 1. A city council or other governing body of an incorporated city
43 may adopt an ordinance regulating sidewalk vendors in accordance with the
44 requirements of sections 16 to 24.5, inclusive, of this act.

45 2. Except as otherwise provided in sections 16 to 24.5, inclusive, of this act,
46 a city council or other governing body of an incorporated city shall not:

47 (a) Enact or enforce a complete prohibition on sidewalk vendors.

48 (b) Impose a criminal penalty on the act of sidewalk vending in a residential
49 area.

50 3. A city council or other governing body of an incorporated city that does
51 not adopt an ordinance that complies or substantially complies with sections 16 to
52 24.5, inclusive, of this act, shall not cite, fine or prosecute a sidewalk vendor for a

1 violation of any rule or regulation that is inconsistent with the provisions of
2 sections 16 to 24.5, inclusive, of this act.

3 4. If a city council or other governing body of an incorporated city adopts
4 an ordinance pursuant to this section, the city council or other governing body
5 shall post on its Internet website a map of the zones where a person may engage
6 in the act of sidewalk vending.

7 **Sec. 21.5.** 1. Except as otherwise provided in subsection 4, a person shall
8 not sell food, beverages or merchandise upon a public sidewalk or pedestrian
9 path from a conveyance, including, without limitation, a pushcart, stand, display,
10 pedal-driven cart, wagon, showcase or rack, within 1,500 feet of:

11 (a) A resort hotel, as defined in NRS 463.01865;

12 (b) An event facility that has seating capacity for at least 20,000 people and is
13 constructed to accommodate a major or minor league sports team;

14 (c) A convention facility operated by a county fair and recreation board; or

15 (d) A median of a highway, if the median is adjacent to a parking lot.

16 2. For any violation of subsection 1, a city council or other governing body
17 of an incorporated city may impose a criminal, civil or administrative penalty in
18 accordance with an ordinance adopted by the city council or other governing
19 body of an incorporated city pursuant to section 21 of this act. The maximum
20 criminal penalty that may be specified in an ordinance adopted pursuant to
21 section 21 of this act is a misdemeanor. A violation of subsection 1 or such an
22 ordinance does not constitute a crime of moral turpitude.

23 3. Nothing in this section authorizes a person to sell merchandise 1,500 feet
24 or more from:

25 (a) A resort hotel, as defined in NRS 463.01865;

26 (b) An event facility that has seating capacity for at least 20,000 people and is
27 constructed to accommodate a major or minor league sports team;

28 (c) A convention facility operated by a county fair and recreation board; or

29 (d) A median of a highway that is adjacent to a parking lot.

30 4. A person may sell food, beverages or merchandise within 1,500 feet of a
31 location described in subsection 1 if the conveyance from which the person is
32 selling food, beverages or merchandise is located in an area which is zoned
33 exclusively for residential use, unless the area is on a public sidewalk or
34 pedestrian path that is immediately adjacent to a location described in subsection
35 1.

36 **Sec. 22.** An ordinance adopted by a city council or other governing body of
37 an incorporated city regulating sidewalk vendors pursuant to section 21 of this
38 act may require that a sidewalk vendor:

39 1. Hold:

40 (a) A permit or license for sidewalk vending;

41 (b) A state business license; and

42 (c) Any other licenses issued by a state or local governmental agency to the
43 extent otherwise required by law.

44 ↪ Nothing in this section shall be construed to authorize a sidewalk vendor to not
45 comply with any requirement to obtain a state business license or other license
46 issued by a state agency or any permit or license issued by a local government,
47 agency or board of health to the extent otherwise required by law.

48 2. Submit information to the designated representative of the city relating to
49 his or her operations, including, without limitation:

50 (a) The name and current mailing address of the sidewalk vendor;

51 (b) If the sidewalk vendor is an agent of an individual, company, partnership
52 or corporation, the name and business address of the principal office;

53 (c) A description of the food offered for sale; and

1 (d) *A certification by the sidewalk vendor that, to the best of his or her*
2 *knowledge and belief, the information submitted pursuant to this section is true.*

3 **Sec. 23.** *1. In addition to the provisions of section 22 of this act, an*
4 *ordinance adopted by a city council or other governing body of an incorporated*
5 *city that regulates sidewalk vendors may:*

6 (a) *Adopt requirements regulating the time, place and manner of sidewalk*
7 *vending if the requirements are objectively and directly related to the health,*
8 *safety or welfare concerns of the public, which may include, without limitation:*

9 (1) *Restrictions on the hours of operation of a sidewalk vendor, which*
10 *may not be more restrictive than any restriction imposed by any applicable*
11 *ordinance regulating noise or any restriction on the hours of operation imposed*
12 *on home-based businesses that are similar to sidewalk vending; and*

13 (2) *Requirements to:*

14 (I) *Maintain sanitary conditions and comply with the regulations*
15 *adopted by a local board of health pursuant to section 25 of this act.*

16 (II) *Ensure compliance with the Americans with Disabilities Act of*
17 *1990, 42 U.S.C. §§ 12101 et seq.*

18 (b) *Restrict or prohibit sidewalk vendors from operating:*

19 (1) *In areas located within the immediate vicinity of a farmers' market*
20 *licensed pursuant to NRS 268.092 during the operating hours of the farmers'*
21 *market.*

22 (2) *Within the immediate vicinity of an area designated for a temporary*
23 *special event by the city council or other governing body of an incorporated city,*
24 *provided that any notice or other right provided to affected businesses or property*
25 *owners during the temporary special event is also provided to any sidewalk*
26 *vendors permitted to operate in the area, if applicable. A prohibition of sidewalk*
27 *vendors pursuant to this subparagraph must only be effective for the limited*
28 *duration of the temporary special event.*

29 (3) *Within a set distance established by the city council or other*
30 *governing body of an incorporated city of:*

31 (I) *Except as otherwise provided in section 21.5 of this act, an*
32 *establishment that holds a nonrestricted gaming license described in subsection 1*
33 *or 2 of NRS 463.0177;*

34 (II) *A food establishment;*

35 (III) *A school, child care facility, community center, polling place,*
36 *religious institution or place of worship or a park or recreational facility owned*
37 *by the city; or*

38 (IV) *A highly trafficked pedestrian mall, convention center or*
39 *designated entertainment district.*

40 (4) *In residential areas, but must not prohibit nonstationary sidewalk*
41 *vendors from operating in such areas.*

42 2. *As used in this section:*

43 (a) *"Entertainment district" means a contiguous area located within a city*
44 *that:*

45 (1) *Is zoned for or customarily used for commercial purposes; and*

46 (2) *Contains any number and combination of restaurants, bars,*
47 *entertainment establishments, music venues, theaters, art galleries or studios,*
48 *dance studios or athletic stadiums.*

49 (b) *"Pedestrian mall" has the meaning ascribed to it in NRS 268.811.*

50 **Sec. 24.** *1. In accordance with an ordinance adopted pursuant to sections*
51 *16 to 24.5, inclusive, of this act, a city council or other governing body of an*
52 *incorporated city, or a designee of the city council or other governing body, may:*

1 (a) *Suspend or revoke any permit or license for sidewalk vending for any*
2 *violation of the ordinance or the terms or conditions of the permit or license in*
3 *the same manner as such suspensions or revocations are imposed for other types*
4 *of businesses;*

5 (b) *Impose a civil penalty on the holder of a permit or license for sidewalk*
6 *vending that engages in sidewalk vending in a prohibited residential area or for*
7 *any violation of the terms or conditions of the permit or license in accordance*
8 *with the schedule of civil penalties set forth in the ordinance, if any;*

9 (c) *Impose a civil penalty on a person who engages in sidewalk vending*
10 *without holding a permit or license for sidewalk vending required by the*
11 *ordinance in accordance with the schedule of civil penalties set forth in the*
12 *ordinance, if any; and*

13 (d) *Authorize any other action to prevent the sale or consumption of any food*
14 *or drink that violates any requirements established by a local board of health*
15 *pursuant to section 25 of this act.*

16 2. *For any person who engages in sidewalk vending without holding a*
17 *permit or license for sidewalk vending or who engages in sidewalk vending in a*
18 *prohibited area, a city council or other governing body of an incorporated city, or*
19 *a designee of the city council or other governing body, may also take any other*
20 *action authorized under existing law to enforce any prohibition on unlicensed*
21 *business activities, including, without limitation, any action authorized pursuant*
22 *to section 21.5 of this act.*

49 (d) *Include any other regulation determined to be necessary by the Task*
50 *Force on Safe Sidewalk Vending pursuant to section 14 of this act.*

51 2. *As used in this section, "sidewalk vendor" means a person who sells food*
52 *upon a public sidewalk or other pedestrian path from a conveyance, including,*
53 *without limitation, a pushcart, stand, display, pedal-driven cart, wagon, showcase*

1 *or rack. The term includes a nonstationary sidewalk vendor and a stationary*
2 *sidewalk vendor.*

3 **Sec. 26.** Any ordinance, regulation or rule of a county or city which conflicts
4 with the provisions of this act is void and unenforceable.

5 **Sec. 26.5.** Each local board of health in a county whose population is
6 100,000 or more and local board of health of a city in a county whose population is
7 100,000 or more shall adopt the regulations required by section 25 of this act on or
8 before December 31, 2025.

10 **Sec. 27.5.** The amendatory provisions of this section and sections 2 to 11,
11 inclusive, and 16 to 26.5, inclusive, of this act are not severable. If any provision of

13 application thereof to any person, thing or circumstance is held invalid, the other
14 provisions of this section and sections 2 to 11, inclusive, and 16 to 26.5, inclusive,

22 (a) Upon passage and approval for the purpose of appointing members of the
23 Task Force on Safe Sidewalk Vending and performing any other preparatory
24 administrative tasks that are necessary to carry out the provisions of sections 12, 13
25 and 14 of this act; and

26 (b) On January 1, 2024, for all other purposes.

27 3. Sections 7.5, 21.5 and 26 of this act become effective:

28 (a) Upon passage and approval for the purpose of performing any preparatory
29 administrative tasks that are necessary to carry out the provisions of this act; and

30 (b) On October 15, 2023, for all other purposes.

31 4. Sections 1 to 7, inclusive, 8, 10, 11, 15 to 22, inclusive, 24, 24.5 and 25 of
32 this act become effective on January 1, 2024.

33 5. Sections 9 and 23 of this act become effective:

34 (a) Upon passage and approval for the purpose of performing any preparatory
35 administrative tasks that are necessary to carry out the provisions of this act; and

36 (b) On July 1, 2024, for all other purposes.
