Comment: BDR 28-217 requires the State Public Works Board submit before October 1 of each even numbered year its recommendations for projects for capital improvements in the next biennium. The recommendations must, to the extent practicable, provide that each project which exceeds \$10,000,000 be scheduled to receive funding for designing and planning during one biennium and funding for construction in the subsequent biennium. The new language requires the Public Works Board to consider the long-term plan to address the future need for suitable office space for the departments and agencies of this State. The language require the Dental Board, and other departments and agencies, to cooperate with the Public works board to implement implementing and maintaining a long-term plan that addresses the future need for suitable office spaces.

The Nevada State Board of Dental Examiners already entered into a lease approved by the Board of Examiners effective September 1, 2021 through August 31, 2026 with an option to extend the lease through August 31, 2028 at the same terms of the initial lease. Given a relatively flat number of applicants/renewals the Board receives each year/biennium, the Board does not anticipate the need for larger office space through 2028 and the foreseeable future. The monthly rent began at \$4,704.00 and increases at 3% per annum on September 1 of each successive year.
