INTRODUCTION, FIRST READING AND REFERENCE

By Assemblymen O'Neill, Gray, Kasama, DeLong, Dickman, Gallant, Gurr, Hansen, Hibbetts and Koenig:

Assembly Bill No. 158—AN ACT relating to emergency medical services; ratifying the Recognition of Emergency Medical Services Personnel Licensure Interstate Compact; and providing other matters properly relating thereto.

Assemblywoman Marzola moved that the bill be referred to the Committee on Commerce and Labor.

By Assemblymen O'Neill, Dickman, Kasama, Considine, Hardy, Anderson, DeLong, Gallant, Gray, Gurr, Hansen and Hibbetts:

Assembly Bill No. 159—AN ACT relating to offenders; adding certain offenses relating to cruelty to animals to the list of offenses for which credits earned by offenders may not be deducted from the minimum term or the minimum aggregate term imposed by a sentence; adding certain offenses relating to cruelty to animals to the list of offenses for which a court may not defer judgment; revising the maximum period for which a court may set or

extend probation or suspension of a sentence for certain offenses; adding certain offenses relating to cruelty to animals to the list of offenses a person must not be convicted of to be eligible for a petition for early discharge; and providing other matters properly relating thereto.

Assemblywoman Brittney Miller moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 160—AN ACT relating to criminal records; providing for the automatic sealing of criminal records relating to certain convictions of a person and certain charges against a person; revising provisions relating to a petition to seal criminal records relating to certain charges brought against a person; and providing other matters properly relating thereto.

Assemblywoman Brittney Miller moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 161—AN ACT relating to drivers' licenses; requiring, under certain circumstances, that the Department of Motor Vehicles place a designation on a driver's license for certain persons with autism; and providing other matters properly relating thereto.

Assembly Bill No. 162—AN ACT relating to pesticides; requiring the Director of the State Department of Agriculture to classify neonicotinoid pesticides as restricted-use pesticides; prohibiting the use of neonicotinoid pesticides on state lands; establishing certain exceptions for neonicotinoid pesticides to certain fees relating to restricted-use pesticides; providing a penalty; and providing other matters properly relating thereto.

Assemblywoman Cohen moved that the bill be referred to the Committee on Natural Resources.

Assembly Bill No. 163—AN ACT relating to employment; providing for hours of leave, under certain circumstances, if an employee is a victim of an act which constitutes sexual assault; prohibiting the Administrator of the

Employment Security Division of the Department of Employment, Training and Rehabilitation from denying certain persons unemployment benefits under certain circumstances; requiring employers to provide reasonable accommodations under certain circumstances; prohibiting an employer from taking certain actions against an employee; and providing other matters properly relating thereto.

Assemblywoman Marzola moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 164—AN ACT relating to outdoor recreation; requiring the Division of Outdoor Recreation in the State Department of Conservation and Natural Resources to establish an Outdoor Education Advisory Working Group during the 2023-2024 interim to study approaches to incorporate outdoor recreation into the curriculum of the public education system in this State; prescribing the membership and duties of the Outdoor Education Advisory Working Group; and providing other matters properly relating thereto.
