Mr. Speaker appointed a Committee on Escort consisting of Senator Nguyen and Assemblywoman Cohen to wait upon United States Senator Jacky Rosen and escort her to the Assembly Chamber.

The Committee on Escort, in company with The Honorable Jacky Rosen, United States Senator from Nevada, appeared before the bar of the Assembly.

The Committee on Escort escorted the Senator to the rostrum.

The Speaker of the Assembly welcomed United States Senator Jacky Rosen and invited her to deliver her message.

United States Senator Jacky Rosen delivered her message as follows:

MESSAGE TO THE LEGISLATURE OF NEVADA  
EIGHTY-SECOND SESSION, 2023

Hello, everyone. It is cold, but it is good to be here. It is good to see all of you, and it is always good to be home in Nevada with friends, family, neighbors, and everyone who cares so much about our state. I want to start by thanking Majority Leader Cannizzaro and Speaker Yeager for the opportunity to address all of you in the Nevada Legislature today. I want to thank everyone who is in attendance: Governor Lombardo, thank you so much for being here; Lieutenant Governor Anthony, I see you behind me; Minority Leaders SeEVERS Gansert and O'Neill, thank you; members of the Legislature; all of our constitutional officers, I see you here; and Justices of the Nevada Supreme Court, thank you. I would be remiss if I did not thank the amazing staff who serve Nevadans day in and day out working at the Legislature. Thank you for all that you do.

For the last six years, it has truly been my honor to represent our great state, and I am grateful to be here in person to tell you about all the work I have been doing in Washington on behalf of all of us who call Nevada home. Since I last addressed the Nevada Legislature, a lot has changed, starting with the voices in this room. We have the first female-majority legislature, and we continue to make gains. I am so proud that we now have the largest majority of women legislators of any state nationwide. We can applaud that. Session after session, our Legislature's membership becomes more and more diverse and representative of our great state. We have incredible leaders, including Assemblywoman Daniele Monroe-Moreno, leading the Black Legislative Caucus; Senator Fabian Doñate, leading the Latino Legislative Caucus; Assemblywoman Erica Mosca, leading the AANHPI [Asian American, Native Hawaiian, and Pacific Islander] Caucus; and Senator Dallas Harris, leading the LGBTQ+ [lesbian, gay, bisexual, transgender, queer/questioning, plus] Caucus. Each and every one of you is helping lead the way for a more inclusive Nevada.

We know that when our state is open and welcoming, we foster an environment where Nevadans are best able to live, work, and raise a family. It is where our economy can grow and thrive. Tonight, I would like to take some time to give you an update on a couple of things. First, I want to share with you what we have accomplished in Congress over the past two years, which

were some of the most productive ever. So much of our work—my work—was bipartisan. As a result, we have gotten real, meaningful, historic things done for Nevada.

We took action to jump-start economic growth and prepare our workers for great jobs. I took a leading role in helping to write and pass the bipartisan infrastructure law. As a result, we are now making a once-in-a-generation investment in our country. Thanks to our work, we are bringing millions of dollars to Nevada to rebuild, revamp, and expand our airports, our roads, and our bridges and improve our broadband access, all while creating good-paying jobs.

As we create more jobs, we must make sure our workforce has the training needed to take advantage of these new opportunities. I led a bipartisan initiative included in the CHIPS [Creating Helpful Incentives to Produce Semiconductors] and Science law. This initiative is to support workforce development for advanced manufacturing. This initiative is going to make sure workers have the skills that they need as we grow our domestic manufacturing industry. The CHIPS and Science law will also make historic investments in STEM [science, technology, engineering, and mathematics] education in our rural communities. This will make sure that we are training the workforce of the future in every single part of our state.

While we are on the subject of historic investments, I am proud to report that we made history by investing record amounts toward renewable energy thanks to the Inflation Reduction Act. Nevada is home to more solar jobs per capita in the nation, and we are a national leader in geothermal energy as well. This law is now making critical investments in our state and across the country to support all those clean energy jobs, lower energy costs, and combat climate change. It provides \$4 billion to tackle the extreme drought that we are facing here in the West. That is an historic investment.

I am very proud that we also took action to support our men and women in uniform. I had the great honor of helping to pass a bipartisan law that will provide benefits and health care access to all veterans who were exposed to toxins while serving our country and who are now, unfortunately, suffering from illness. I believe we must always protect those who protected us, so it was about time that we got that done.

We took action to make communities safer. I do not have to tell any of you here how much gun violence has affected our communities and our state. For the first time in more than 30 years, Congress took action in a bipartisan way to address the epidemic of gun violence and make historic investments in school safety and mental health. I am very proud of that. Mental health for our kids really matters.

We took action to help make health care more affordable and accessible for families. Through the Inflation Reduction Act, as I mentioned earlier, we are lowering health care premiums through a key provision that I pushed to include. This law also takes significant steps to reduce the outrageously high cost of prescription drugs. After years of obstruction, Medicare can finally negotiate lower prescription drug costs for our seniors. We capped the cost of insulin for those on Medicare to just \$35 a month. As a result, private companies are taking notice and are now lowering the cost for everyone else. We made a difference. We broke through that critical barrier, and I am ready to do even more to bring down those health care costs.

As we work to lower the costs, we must also take action to make care more accessible, especially when some Nevadans, particularly those in our rural areas, cannot even see a doctor. That is why I introduced and passed my MOBILE [Maximizing Outcomes through Better Investments in Lifesaving Equipment] health law. This law will make it easier for mobile health units to bring care directly into communities in need, wherever they are, up and down our state. It is going to keep people healthy.

We took action to support Nevada. One of the pieces of legislation that I am most proud of is my comprehensive, bipartisan travel and tourism legislative package. Signed into law at the end of last year, it creates, for the first time ever, a federal position focused solely on what is best for America's travel and tourism industry. This federal position is tasked with developing and implementing a national tourism strategy. This is a major victory for a state like ours. I serve as Chair of the Subcommittee on Tourism, Trade, and Export Promotion, so I am going to work to see that the person who fills this role understands the specific needs of our communities—for our urban communities and for our rural communities, for our dark skies in the center of the state, where you can see those great stars. You can also see the stars going up and down the Las Vegas Strip. We have to protect it all, and I am going to make sure that they understand that. We know

that we have a few more exciting things coming to southern Nevada: Formula One and, of course, the Super Bowl.

I have also worked to bring resources and funding to help enact specific projects that our local governments and communities actually need. The federal funding that I worked on with Senator Cortez Masto over the past two years is going toward projects that support our local law enforcement, increase affordable housing access, deliver clean drinking water, make medical care more accessible, invest in our workforce development, and so much more.

In all, more than 90 percent of the legislation I introduced last Congress was bipartisan, and many of those bills were signed into law. Despite only being in my first term, I have been ranked as one of the top ten most bipartisan Senators and one of the top ten most effective Democrats in the Senate, getting things done by working across the aisle. I am proud of these ratings because it reflects, as I said, that I worked across the aisle to find commonsense, bipartisan solutions that get things done for the people of Nevada. As we work to implement these laws, I will keep working in Washington to make sure that Nevada gets its fair share of funding so all of you here can put it to good use for our hardworking families. For their kids, for their parents, and for our small business owners, it makes a difference. Last session was truly historic. We got a lot done, but significant work still remains.

That brings me to my second point. We are still facing so many challenges, and I promise that I will spend every single day over the next two years working diligently for our state. I am going to keep up the fight for working families. Number one, what do we have to do? We have to fight inflation. Middle-class families are feeling the squeeze at the gas pump, at the grocery store, and when paying their monthly rent. It is real—you know it, and I know it. We need to work on it. We must keep lowering costs, whether it is the cost of housing, health care, or higher education. We have to continue creating jobs and supporting our workers. That means strengthening unions and their right to organize their workplaces for better working conditions. That is why I support the PRO [Protecting the Right to Organize] Act.

The next generation, our kids, are our hope and our future, so we must support our schools, our educators, and our students. That is the future of Nevada. It is exciting when we do that. I look at former Governor Sandoval—I know you are doing that every day. It means giving our teachers a raise. It means investing in our schools to make sure that the students and educators have the resources and supplies they need to excite the kids, teach them, and get them to learn and take on those challenges and opportunities they are going to face when they grow up. That is our job. We need to invest in them like someone invested in us. I know that Speaker Yeager and Majority Leader Cannizzaro have a funding bill that will accomplish just this, so thank you.

For the Nevadans who raised us—our parents, our grandparents, our seniors—we must keep our sacred promise by protecting Social Security and Medicare from harmful cuts. They worked hard. They earned their benefits. We need to take care of them.

Another group we need to take care of is small business, so I am going to keep up the fight for small business. I am a member of the Senate Committee on Small Business and Entrepreneurship. One thing I am working on is creating a centralized online hub, making it easier for small businesses to access the resources they need to grow and thrive. I know that we help small businesses when they get the tools they need to get up and running, when we help cut through some of that bureaucratic red tape, and when we invest in their success. They are the job creators. I am leading the efforts to open up federal loans and SBA [Small Business Administration] resources to other businesses as well, like our state-legal cannabis small businesses. They are big job creators in our state and in a growing number of states around the country.

I want to talk about safer communities. I am going to keep up the fight for safer communities with all of you because rising crime is a concern for our families. That is why I am working to support local law enforcement across the state with the funding, the tools, and the resources they need to keep our communities safe, including from dangerous drugs like fentanyl. I am glad to see bills like the one from the Attorney General to help stop fentanyl trafficking. Thank you. It is very important.

We are going to keep fighting for more accessible health care. We have to tackle Nevada's dire shortage of doctors and medical professionals. I introduced a package of bipartisan bills to incentivize doctors to complete their residencies here, stay here, and practice in communities in

our state that desperately need them. We need solutions at the state level, too, such as the bipartisan bill introduced by all four leaders to help expand Nevada's health care pipeline.

On that note, we have to continue to improve health care for Nevada's veterans. It is why I successfully pushed President Biden to include a new veterans hospital in Reno as part of his latest budget. I want you to know, I am not going to stop until this new hospital is done and it has opened its doors to Nevada's veterans. Speaking of veterans, I am also a member of the Senate Armed Services Committee, so I am going to continue to support our service members and Nevada's defense installations. In fact, that is what we are working on right now—passing our next national defense package. Nevada is really critical to the country's safety and security, and I am going to ensure we have the resources we need to keep our country safe and our world safe.

I am going to keep up the fight to make sure that every person in our state and in our nation is treated with dignity. We can never stop fighting for our rights. I do not have to tell many of you here, but we have to keep working to pass comprehensive, bipartisan immigration reform that treats people with respect, gives Dreamers a pathway to citizenship, supports our state's TPS [Temporary Protected Status] recipients, and ensures our borders are secure and protected. We have a lot of other rights we have to fight for. We have to keep defending the rights of our LGBTQ+ Nevadans, which is why I am going to continue to support and work to pass the Equality Act into law.

Last, but certainly not least, we must keep up the fight to restore and protect reproductive rights. The voters of Nevada care deeply about this, and they agree across party lines—decisions about a woman's body belong to that woman, not to politicians. That is why I strongly support Majority Leader Cannizzaro's efforts to make sure we enshrine reproductive freedom in our state's *Constitution*. I will always be a partner for reproductive freedom at the federal level.

A strong economy, safe communities, opportunity, and respect for all—these are bedrock values for Nevadans, for all of us, for everyone here. I know that. By focusing on the issues that matter, I believe we can take action that makes a real, meaningful difference in people's lives. All of us in this Chamber have the distinct honor of serving this great state and the privilege of helping Nevadans every single day. I do believe that we can find that common ground, that we can achieve great things together when we work together and talk to each other—Republicans and Democrats at the federal and state levels worrying about what makes Nevada's communities successful. That is where we will thrive, and that is where we will do good work. Tonight, I commit to work with all of you to make sure the next chapter of Nevada's story is a bright one. Thank you all for what you do every day. It was my honor to address you tonight.

Senator Flores moved that the Senate and Assembly in Joint Session extend a vote of thanks to Senator Rosen for her timely, able, and constructive message.
