

ASSEMBLY BILL NO. 156—ASSEMBLYMEMBER MOSCA

SUMMARY—Revises provisions governing the salary of members of the board of trustees of certain school districts. (BDR 34-689)

AN ACT relating to education; revising provisions governing the salaries of the members of the board of trustees of a school district in certain counties; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law establishes the salaries for the members of the board of trustees of
2 school districts based on the population of the county in which the school district is
3 located. Under existing law, the salary of a member of the board of trustees of a
4 school district in a county whose population is 100,000 or more (currently Clark
5 and Washoe Counties) is \$750 per month. (NRS 386.320) **Section 1** of this bill
6 increases the salary of a member of the board of trustees of a school district in a
7 county whose population is 700,000 or more (currently Clark County) to an amount
8 equal to the base salary of a county commissioner of that county. Existing law
9 establishes the base salary of such a county commissioner as an amount equal to
10 112.551 percent of the amount of the base annual salary for a county commissioner
11 that was in effect on January 1, 2015. (NRS 245.043) **Section 2** of this bill limits
12 the salary increase pursuant to **section 1** to members of the boards of trustees of the
13 school district who were elected or appointed to a term of office that begins on or
14 after January 1, 2027, including members who are reelected or reappointed to a
15 term of office that begins on or after that date.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 386.320 is hereby amended to read as follows:

2 386.320 1. Each member of the board of trustees of a school
3 district in a county whose population is less than 20,000 must
4 receive a salary of \$250 per month.

5 2. Each member of the board of trustees of a school district in a
6 county whose population is 20,000 or more but less than 100,000
7 must receive a salary of \$400 per month.

8 3. Each member of the board of trustees of a school district in a
9 county whose population is 100,000 or more *but less than 700,000*
10 must receive a salary of \$750 per month.

11 4. *Each member of the board of trustees of a school district in*
12 *a county whose population is 700,000 or more must receive an*
13 *annual salary that is equal to the annual salary for a county*
14 *commissioner in the county set forth in NRS 245.043.*

15 5. A member of the board of trustees of a school district who
16 receives a salary pursuant to this section may:

17 (a) Donate all or a part of the monthly salary that he or she
18 receives to a school within the school district or to the school
19 district; or

20 (b) In lieu of making a donation after the member receives the
21 salary, request that all or a part of his or her monthly salary be paid
22 directly to a school within the school district or to the school
23 district.

24 ~~5.~~ 6. The board of trustees may hire a stenographer to take
25 the minutes of the meetings of the board of trustees, and the
26 stenographer may be paid a reasonable fee for each meeting
27 attended.

28 **Sec. 2.** The amendatory provisions of this act apply only to a
29 member of the board of trustees of a school district who is elected or
30 appointed to a term of office that begins on or after January 1, 2027,
31 including, without limitation, a member who is reelected or
32 reappointed to a term that begins on or after that date.

33 **Sec. 3.** The provisions of NRS 354.599 do not apply to any
34 additional expenses of a local government that are related to the
35 provisions of this act.

36 **Sec. 4.** This act becomes effective on January 1, 2027.
