THE FIRST DAY.

CARSON CITY (Tuesday), January 14, 1908.

The Assembly was called to order by Secretary of State Douglass at 12 m.

The proclamation of Governor Sparks calling the Special Session was read.

Speaker Skaggs was called to the chair.

The roll was called by the Chief Clerk:

Prayer by the Chaplain, Rev. Charles H. Powell.

On motion of Mr. Folsom, committees were appointed to notify the Governor and the Senate that the Assembly had organized.

Mr. Speaker appointed Messrs. Folsom, Williams, and Bradley to notify the Governor, and Messrs. Syphus, Ray, and Baird to notify the Senate.

The committees reported that they had performed their duties, and that the Governor would at once send his message to the Assembly.

The committees were discharged.

A committee from the Senate notified the Assembly that the Senate had organized.

The Governor's Private Secretary then appeared with the Governor's message, which was read by the Clerk:

**GOVERNOR'S MESSAGE.**

*To the Honorable, the Senate and Assembly of the State of Nevada, in Extraordinary Session:*

GENTLEMEN: I have the honor, under the Constitution, to submit to your honorable bodies a statement of the purpose for which you have been convened, reserving the right to call your attention to other legislative business while in session.

As indicated in the call issued to the members, bearing date 30th of December, A. D.



1907, the object and purpose, now to be stated, is legislative action concerning contentions between labor unions and mine operators in the mining district of Goldfield in this State.

From statements presented by reliable citizens, representing both sides of the controversy, and from my own personal knowledge obtained from frequent visits to Goldfield, for the purpose of using such influence as I possessed, to prevent loss and trouble occasioned by strikes, a letter of inquiry was indicated by myself and Attorney-General Stoddard to President Roosevelt, explaining conditions according to information, and asking if he could consistently send United States troops to Goldfield for the purpose of suppressing riots or violence in case such should occur in said mining district. The President promptly and kindly replied that he would, providing a proper application be made, stating the requirements, which were complied with, and the troops came immediately, under instructions not to interfere with the civil authorities so long as they were able to preserve order. The policy has been continuously observed, to the satisfaction of a large percentage of the people of the State, as evidenced by the popular desire for a special session of the Legislature, expressing the hope that your honorable bodies would by petition prevail on the President to retain the troops at Goldfield temporarily, if not permanently; and, further, that a military post be established in this State, all of which, I believe, will meet the approval of a majority of our citizens.

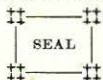
It is also apparent that a law should be enacted regulating the police power of the State, either on military lines or on enlarged civil power vested in the State Government, that will be equal to the protection of the rights of all the people and maintain the honor and dignity of a sovereign Commonwealth, which Nevada has a right to claim and enforce. This will be expensive, but with ordinary economy may be gradually accomplished. The necessary appropriation should be made to inaugurate whatever system may be adopted.

A Legislative Fund should be created in amount sufficient to cover the expenses of procuring supplies, clerical aid employed, salaries and mileage of members, extra expense incurred by State Printing Department, and such other allowances as are deemed necessary in the discharge of your duties.

Regarding the foregoing as a matter of paramount importance for the security and safety of valuable business interests, and calculated to relieve the anxiety of the people of this State, as well as many investors residing in other States, I respectfully present to your honorable bodies this subject as deserving of careful investigation, that equal and exact justice may be guaranteed to all respecters of law and order, and those who prefer to be violators may be held severely amenable.

I hope that your deliberations will result in harmonious action, and redound to the benefit of all concerned, by discarding from your minds political advantage and prejudice, and devote your strength to the promotion of public welfare and common good.

In recognition of President Roosevelt's liberal and generous favor extended to Nevada, by his willing desire to accommodate us in the solution of our present difficulties and furnishing Federal troops to preserve law and order, I recommend that you extend to him a special vote of thanks.

On motion of Mr. O'Brien, Miss Jennie Smail was nominated as Committee Clerk, and elected.

On motion of Mr. Trimble, Miss Venie Robert was nominated as Committee Clerk, and elected.

The resignation of Miss Lucy Fitzpatrick as Assistant Minute Clerk was received and accepted.

## MESSAGES FROM THE SENATE.

SENATE CHAMBER,  
CARSON CITY, NEVADA, January 14, 1908.

*To the Honorable the Assembly:*

I have the honor herewith to present for the consideration of your honorable body Senate Bill No. 1—An Act to create a Legislative Fund—which passed the Senate by the following vote: Yeas, 17; nays, none.

On motion of Mr. Folsom, Senate Bill No. 1 was taken up out of order, rules suspended, reading so far had considered first reading, rules further suspended, bill read second time by title, and referred to Committee of the Whole.

On motion of Mr. Reid, the House resolved itself into Committee of the Whole for the consideration of Senate Bill No. 1.

The motion carried.

Mr. Reid was called to the chair.

Mr. Speaker called the House to order, and Mr. Reid reported Senate Bill No. 1 from Committee of the Whole favorably, with the recommendation that it do pass.

On motion of Mr. Folsom, rules were suspended, and Senate Bill No. 1 was taken up out of order for third reading and final passage, and passed by the following vote:

*Resolved*, That the Rules of the Twenty-third Session of the Nevada Assembly be adopted as the rules of the Assembly during this Extraordinary Session.

Mr. Huskey offered the following substitute, which was unanimously adopted:

*Resolved*, That, until further order, the Standing Rules of this Assembly at its last regular session be and the same are hereby adopted as the rules of this session, and the committees appointed at the last regular session consist of the same members as were then appointed upon such committees; *provided*, that all vacancies existing be filled by appointment by the Speaker.

Mr. Tighe was granted leave to introduce, out of order, the following resolution:

*Resolved*, That the Republican members of this House shall select five of their members, and that the Democratic members of the House shall select five of their members, the ten so selected to act with a committee selected by the Senate for a like purpose, viz., the consideration of all matters concerning Federal troops or forces, State police powers or military organizations, memorials to Congress or the President, or like matters recommended in the Governor's message; and that no resolutions or bills of the above-mentioned character shall be considered or introduced into this House without having been first submitted to and considered by said committee.

On motion of Mr. Ray, the resolution was adopted.

On motion of Mr. Hamilton, the House took a recess until 2 p. m.

### MEMORIAL TO THE HONORABLE ASSEMBLY AND SENATE OF NEVADA.

Your memorialist, Western Federation of Miners No. 121, of Tonopah, Nevada, does represent and allege:

That the Western Federation of Miners is now and always has been a legal association of honest, industrious and law-abiding citizens, organized solely for the purpose of attaining a greater efficiency for better compensation; settling disputes between individuals of the association and their employers; lending aid and support to destitute and afflicted miners, their wives and children; and for the accomplishment of a general betterment of the condition of humanity.

That the Governor of the State of Nevada was, in the opinion of this association, grossly, wilfully and maliciously deceived as to the true conditions existing in Goldfield prior to his call for United States troops.

That tales of inconceivable horror and diabolical character were undoubtedly painted by the Governor's deceivers for the purpose of accomplishing their illegal, dishonorable and heartless scheme.

That there did not then exist at Goldfield "demonstrations of violence and unlawful conspiracies."

That there was no general or concerted disorder, and no greater number of individual crimes committed than in any other similar camp.

That the lawfully constituted authorities were able and willing to preserve law and order, and were actually preserving law and order.

That the Western Federation of Miners No. 220, at Goldfield, Nevada, at all such times was peaceably attempting to arrange with the mine operators some plan whereby the miners could continue to work on some safe credit basis; and trouble was not suggested or thought of in such union.

That the stigma cast upon the Western Federation of Miners was unwarranted and was a base slander.

That the Mine Operators' Association of Goldfield, immediately on the arrival of the troops, declared that the Miners' Union had violated its contract, because the miners refused to work. This was only a subterfuge, and untrue. The wage contract required payment in money. The operators would only pay in unsecured bank script. The miners had offered to return to work if such script was secured by the mines. Such a proposition was supposedly being considered by the mine operators when the troops were called. Immediately after the troops arrived the operators not only cut wages lower than those in force at Tonopah, Nevada, but refused to treat with or recognize the Western Federation of Miners, or employ any miner of that union until he had stultified himself and surrendered the right of every free man to belong to any lawful association.

That the troops were not secured for Goldfield because there was any disturbance in existence or threatened, but because certain mine operators desired without arbitration or reason to reduce wages, to humiliate and intimidate union miners, and crush the association that protected them.

That this union, Tonopah No. 121, Western Federation of Miners, in August, 1906, entered into an agreement with the mine operators of Tonopah as to a wage and hour schedule; that said agreement has been faithfully maintained by both parties to the peace, good-will and benefit of the whole community.

That this union believes: That it is one of the inalienable rights of men to lawfully associate themselves together for mutual protection and good; that such associations are for the best interests of all; that all disputes between employer and employee should be settled by arbitration.

Wherefore, Western Federation of Miners No. 121 hereby respectfully protests against the calling and quartering of Federal troops in Goldfield as unwarranted by fact or law, and in contravention of the rights of citizens under the Constitution of the United States; and respectfully prays that your honorable bodies will act in fairness and without prejudice, and in accordance with the true facts and the law, and we respectfully urge the Legislature to make a full and complete investigation of the facts and causes leading to the present Goldfield misunderstanding.

GOLDFIELD, NEVADA, January 21, 1908.

*To the Nevada Assembly:*

We understand that there is a proposed bill before the honorable State Legislature to create a State constabulary or ranger system. We are opposed to this kind of legislation as class legislation, judging by similar legislation of other States, namely, Colorado, where the State military forces were farmed out to the Mine Owners' Association to persecute and deport workmen from their homes and families, contrary to all law and the Constitution of the United States; and also in Pennsylvania the State constabulary has proven itself a partial body in emergencies, directly or indirectly, in favor of the employers of labor.

We are led to believe that the proposed bill now being considered by your honorable body was introduced as a result of the present lockout of the mine owners against the miners of the Goldfield Mining District in Esmeralda County, Nevada, in which the Mine Owners' Association have attempted to reduce the wage scale one dollar per day in all cases, and in some crafts two dollars per day. The Mine Owners' Association has also adopted the black-list or card system, which is a violation of the State laws.

We believe that, should the proposed constabulary or ranger bill be passed by your honorable body, such a force created could be used by a partial Governor, or by partisan appointees of such, to disrupt organized labor in general and enforce the black-list or card system and the reduction of wages without the necessary reduction in living expenses.

Furthermore, we hold it as an economic truth that so long as the production of gold is on the increase that living expenses are bound to increase and, as the Goldfield District is solely a producer of gold, it will prove no exception to this rule.

Therefore, we, as law-abiding American citizens, unite and request that a fair and impartial commission be appointed by your honorable body to investigate thoroughly the present controversy now existing in the Goldfield Mining District between the mine owners and the Goldfield Miners' Union.

We have in the past and do at the present stand ready and willing to assist the civil authorities in maintaining law and order.

There is no disturbance in this district at this time, nor has there been in the past, that would require the intervention of an armed force. And we know of no reason for the creation of an armed force at an added expense to the taxpayers of the State, of which we are a considerable part.

We, therefore, believe that with justice to all we should be heard before the proposed legislation be put into effect. We, the Goldfield Miners' Union, in regular meeting assembled, utter our protest as above stated and submit it to your honorable body.

such time as my services shall be satisfactory and at the wages heretofore fixed by said company, and subject to the rules and regulations fixed by said company and by the Goldfield Mine Operators' Association relating to the employment of men in and around the mines of Goldfield Mining District, I hereby covenant and agree with said company that I am not now and will not be during the time I am working for said company a member of Goldfield Miners' Union No. 220 of the Western Federation of Miners, or of any other union in Goldfield, or elsewhere, that is directly or indirectly affiliated with or has any connection of any kind, nature or description with said Western Federation of Miners.

WHEREAS, It is claimed that this rule is contrary to the provisions of an Act of the Legislature of the State of Nevada entitled "An Act making it unlawful for employers to enter into agreement with their employees, or persons about to enter their employment, not to become or continue as members of labor organizations; and prescribing penalties for violation thereof," approved on the 17th day of March, 1903; and

WHEREAS, This Association believes said Act to be unconstitutional and void, and is in favor of observance of all laws and does not wish to stand accused even of violating a law that is unconstitutional; therefore, be it

*Resolved*, That on and after February 1, 1908, said Rule 3, as above set forth, be and is hereby abolished, and in lieu thereof the following be and is hereby adopted as Rule 3 of the Rules and Regulations of the Goldfield Mine Operators' Association:

RULE 3. All mines, mills and reduction plants operated by members of this Association shall be operated under the open-shop policy, and all men seeking employment from members of this Association shall only be required to satisfy the Secretary of this Association and their employers of their competency and reliability.
