Pursuant to the provisions of the Constitution and Statutes, the Special Session was called to order by Secretary of State John Koontz, at 12 noon.

Prayer by the Chaplain, Reverend J. L. Harvey.

The Secretary of State appointed John Nulty as temporary Sergeant-at-Arms.

Roll called.

MESSAGE OF GOVERNOR CHARLES H. RUSSELL TO THE LEGISLATURE OF NEVADA

(Special Session, 1954)

STATE OF NEVADA,
EXECUTIVE CHAMBER,

CARSON CITY, JANUARY 5, 1954.

To the Honorable, the Senate and Assembly of the State of Nevada in Extraordinary Session:

Under the power conferred upon me by Section 9, Article V of the Constitution of the State, which provides that the Governor may, on extraordinary occasions, convene the Legislature by proclamation, considering such an extraordinary occasion to exist as to warrant the exercise of this drastic power and authority, I did on the 23rd day of December 1953, issue my proclamation calling a special session of the Legislature of the State of Nevada to be convened at 12 o'clock noon on the fifth day of January 1954.

Now convened pursuant to said proclamation I have the duty and honor to advise you of the extraordinary circumstances that prompted my call and to define and limit the scope of your legislative endeavors. For in this respect Section 9, Article V of the Constitution states that when a special or extraordinary session of the Legislature is convened the Governor shall state to both houses, when organized, the purpose for which they have been convened, and the Legislature shall transact no legislative business except that for which they were especially convened, or such other business as the Governor may call to the attention of the Legislature while in session.

The circumstances which impelled me to call you into this special session were:

SCHOOL REVENUE

Enrollment in the schools of many counties has been increasing so rapidly during the last several years that collapse of the elementary and high school educational system, due to deficit spending, is a distinct threat.

The gravity of the situation in such counties, particularly in Clark and Washoe, is increasing daily to the extent that it has become mandatory that this emergency be met, at once, on a temporary basis.

The immediate, but admittedly temporary, solution of this critical problem can be reached through the simple expedient of disbursing State funds to the school districts on the basis of the current average daily attendance instead of on the average daily attendance of the year immediately past, as now provided by law.

A bill providing for this necessary change and making an appropriation to place the plan in effect has been prepared for introduction.

Funds necessary to effect the change are available, due partly to unexpected increases in State revenue and partly due to stringent economy measures imposed by the budget department.

I specifically limit your consideration of this phase of the school problem to such measure and advise you that no new revenue legislation may be considered.

Realizing that the broader aspects of the school problem and its ultimate solution require careful investigation and study by persons in all walks of life, I have asked the special committee which I appointed to make a careful survey as to the manner in which school monies now are spent; to report on the financial needs of the schools; and to recommend a program as to district and State responsibility.

I am requesting, in another measure prepared for introduction, that a fund of \$25,000 be made available for expenditure by the Governor's office to carry out the work of the school survey committee.

The survey will be completed and recommendations will be made by the committee so the 1955 regular legislative session may consider a long-range solution of the school problem.

I urge, with the utmost emphasis at my command, that these measures be enacted into law speedily. I repeat, that under this call, no other school legislation may be considered.

FISCAL ACTS

The 1953 Legislature passed a series of Acts designed to place the operation of the counties on a fiscal-year instead of a calendar-year basis.

That legislation was enacted after being endorsed and approved by many county and State officials who are familiar with and whose duty it is to deal with fiscal matters. The basic concept of these Acts was and is sound. The weakness is in the application.

I am recommending the adoption of bills, prepared for introduction, designed to correct these defects by placing personal property back on the tax rolls; eliminating the initial 18-month advance payment of automobile registration license fees and taxes; and permitting the payment of personal property taxes and license fees on an annual basis.

Other bills designed to make workable the highly advantageous Fiscal Act have been prepared for introduction. These concern Chapters 213 and 344, 1953 Statutes, and other interrelated Acts, together with amendments necessary to make the Motor Vehicle Act conform.

I am limiting your action on these measures to the consideration of the amendments proposed or proper modification thereof. However, if you, in your wisdom, should feel proper amendment is impossible you have authority to repeal and re-enact, so long as your efforts are confined to the same subject matter.

Sections of the law concerning irrigation districts were left unchanged by

the 1953 Legislature requiring such districts to continue to operate on a calendar-year basis instead of changing to the fiscal-year program.

Proper amendments to the Irrigation District Act, Chapter 64, Statutes of 1919, are being submitted to you to the end that they may be brought into conformity with Chapter 344, Statutes of 1953.

No other changes are to be made in the Irrigation District Act.

I also wish to direct your attention to the following matters which I hold of sufficient importance to require your affirmative action:

1. An authorization for the Governor to draw from the General Fund not to exceed \$30,000, when such action is approved by the State Board of Examiners, for use only in matching Federal Funds in the event of an emergency or disaster involving our basic livestock industry.

2. A bill validating a \$500,000 general obligation school bond issue approved by the voters of White Pine County.

3. A bill to amend Chapter 252, Statutes of Nevada 1953, which amendments would enable the East Ely sewer district to issue bonds for the installation of a sewer system.

4. A bill to amend Chapter 191, Statutes of Nevada 1943, authorizing the State to purchase special assessment district bonds of cities and bonds of sewer and sanitation districts organized under Chapter 138, Statutes of Nevada 1947, and Chapter 252, Statutes of Nevada 1953, and authorizing investments in city, county and district indebtedness authorized by Chapter 149, Statutes of Nevada 1917, and Chapter 335, Statutes of Nevada 1953.

5. A Legislative Fund for the purpose of defraying the expenses of this special session.

I also include at the request of the Advisory Personnel Commission, for your consideration, an appropriation of \$75,000 to put into operation, on July 1, 1954, the equal-pay-for-equal-work program authorized by the 1953 Legislature in the Personnel Act, a part of which called for uniform job and salary classifications. If you see fit to make this appropriation, I am asking that such sum be placed in a fund to be drawn upon for salaries only, and only upon the recommendation of the Personnel Director, approved by the State Board of Examiners.

It may be that amendments to other sections of the law will be necessary to bring about consistency and harmony with the 1953 fiscal and revenue Acts. If so, I will, from time to time, call your attention to such matters.

CONCLUSIONS

A Governor always is reluctant to convene an extraordinary session of the Legislature because it means that you, as men and women concerned with your respective private businesses and responsibilities, are called to come here at a considerable financial sacrifice. The small amount of money paid you by the State will not begin to compensate you for the time spent here, but even so the cost of this or any extraordinary session is an unexpected burden on every taxpayer.

Faced with the extraordinary situations and circumstances which I have outlined, all of which are of great importance to the welfare of the State of Nevada, and fully cognizant of your responsibilities, I know that you and all of us will perform our respective duties with skill and honor, and that we will not permit partisanship or politics to reflect upon nor lessen our integrity and loyalty to the people of Nevada.

Party politics have no place when the welfare of the State is at stake.

With this in mind, let each of us turn to his task with industry and determination to the end that we may accomplish the work before us in the shortest possible period of time and with the least possible expense to the taxpayers of Nevada, whom we serve.

WHEREAS, One of the stated purposes of that Act is to increase the efficiency and economy of the governmental departments and agencies by the improvement of methods of personnel administration; now, therefore, be it

Resolved by the Assembly of the State of Nevada, the Senate concurring, That the Director of the State Department of Personnel shall make a survey of jobs and work loads in the various State offices, departments, commissions, agencies and bureaus for the purpose of determining the possibility of effecting a reduction of force, a savings of money to the State of Nevada and other possible economies in personnel administration; and be it further

Resolved, That the Director of the State Department of Personnel shall report the results of his survey to the 47th Session of the Legislature of the State of Nevada.

"SEC. 2a. Due to the fact that the major portion of the \$1,100,000 Deficiency Fund "specially" allotted and herein provided for school expenses has been derived from licenses and taxes on gambling, liquor and cigarettes, and to some degree, directly and indirectly, from Nevada's six-weeks' residence divorce traffic, all of which are mainly supported by Federal funds spent in the current war and National defense effort, and because this United States Treasury fund-spending may at any time now begin to decline sharply—it is felt that it is incumbent upon this Assembly to urge the Governor to advise the heads of the Department of Education, to whom this special allotment has been granted, to exercise due care and the utmost wisdom in expending these funds and to so arrange the affairs of their department that, in the event there is a decline in revenue from the aforementioned lucrative realm of iniquity and that it should become necessary for the 1955 Legislature to institute rigid economy measures to meet such a revenue decline, the Nevada State Department of Education should do all in its power to be in the best possible financial

condition to meet the ensuing biennial needs and be prepared to carry their department through what may well be a long and hard period of depression.

"It appears that it would be unwise to overextend classroom construction at this time, as the decline of war spending will be accompanied by a decline in the population of the State, as employees in present war industries can be expected to migrate to other fields and leave many of the presently overcrowded classrooms bare. It would be far better to rent Sunday school rooms, auditoriums, and other vacant public buildings for kindergarten and save on construction costs now.

"In view of the fact that there is now a more sympathetic attitude in Washington toward the Western mining industry—an attitude which Western States miners and taxpayers are now uniting in an effort to capitalize upon—mining, the basic industry of the West, may soon be restored to its original position as a major factor in the economy of the West. As a consequence, approximately 20 billions of dollars of the now dormant Western mining industry may, within a few years, be restored to the active tax rolls of the West. Thus, the stability of the West and particularly of Nevada will not only obtain but will be assured of a continuity that will assure a sufficiency of tax returns to meet our future Educational Fund needs, if plans which are now in the making and others proposed are adopted and carried through.

"Since there is no other major industry in the State of Nevada which can carry our educational load, it is felt that every member of the educational system and every taxpayer of the State should now lend his full support to the present effort to re-establish our Western States mining industry. This can only be accomplished by the full, united will and support of every resident of the State.

"It is believed that the Department of Education should establish a Western mining history and development study course in each high school of the State in order that the students may learn the relationship of our State's mining industry to the soundness of Nevada's economy. It is further believed that essay contests should be arranged to stimulate the interest of students and their parents in this, our basic industry, and their State Government.

"A fair price for gold will do much to re-establish this great industry, and this fair price is, at this time, adjudged to be seventy dollars per ounce.

"To insure that steps shall immediately be taken to restore this badly needed 20 billion dollar Western mining industry, so that a future sound economy can be established to support the future needs of education in the State of Nevada, there is hereby allotted \$50,000 to be known as a Western States Mining Reactivating Fund to be expended as the Governor of Nevada may direct in the furtherance of this effort. The price of \$70 per ounce for domestic gold shall be its first objective."
