**NOTICE OF WORKSHOP TO SOLICIT COMMENTS  
ON PROPOSED REGULATIONS  
(DEFINITIONS)**

The Board of Homeopathic Medical Examiners, P.O. Box 34329, Las Vegas, Nevada 89133-4329, (702) 258-5487, is proposing the adoption of regulations pertaining to chapter 630A of the Nevada Administrative Code. A workshop has been set for 5:30 p.m., on December 4, 1997, by telephone conference call, at the Triad Medical Center, 4600 Kietzke Lane, M242, Reno, Nevada 89502, and the Renaissance Medical Center, 2810 West Charleston Blvd., F-55, Las Vegas, Nevada 89102. The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

Definitions of terms added to NRS chapter 630A by the Act of July 16, 1997, ch. 407, 1997 Nev Stat. 1417 (AB 286).

**PROPOSED REGULATION OF THE

EXPLANATION - Matter in *italics* is new; matter in bracket [ ] is material to be omitted.

AUTHORITY: NRS 630A.200

Add the following new sections to NAC chapter 630A:

*Neural therapy.* 1. *Neural therapy is the use of any or all local anesthetics, vitamins, minerals, homeopathic medications, herbal extracts or any other medicinal or pharmaceutical substance for intravenous injection, for injection into acupuncture, acupressure, or trigger points, or into nerve ganglia.*

2. *Neural therapy may be used for the control of pain or other beneficial effects that may be expected to result under the philosophy of the Homeopathic School of Medical Practice.*

*Herbal therapy.* 1. *Herbal therapy is the use of herbs, herbal extracts, plants, plant extracts, or any combination thereof for the treatment of any condition of the patient.*

2. *Herbal substances may be formulated by the homeopathic physician or by a herbalist, pharmacist, pharmacologist, or any other person who by training and experience is qualified to formulate such substances.*

*Neuromuscular integration.* *Neuromuscular integration means to progressively bring into harmony the body and the mind by:*

1. *Using specific hands-on soft tissue manipulation to structurally balance the body, and*

2. *Using Thought Field Therapy (TFT) to recondition the nervous system.*

*Orthomolecular therapy.* *Orthomolecular therapy is the treatment and prevention of disease by the expert of the body's natural chemical constituents on the molecular level, and includes:*

1. *The prescription of topical and oral supplements, pharmaceutical medicines, the intravenous infusion of various substances, including vitamins, amino acids, peptides, polypeptides, pharmaceutical medications, homeopathic medications, ozone and other bio-oxidative substances, chelating agents such as Disodium Ethylene Diamine Tetra Acetic Acid (EDTA), Sodium 2,3-Dimercaptopropane-1-Sulfonate (DMSO), Penicillamine and other substances.*

2. *This therapy is designed to detoxify and remove harmful substances such as heavy metals, vascular and arterial plaque buildup and toxic environmental factors such as pesticides, xenobiotics, bacteria, and fungi in order to enable the body to overcome*

*infection, malignancy, and degenerative illness, thereby assisting the body in balancing its natural chemicals.*

***Nutrition.*** *Nutrition includes the recognition, treatment and correction of the unique nutritional needs of the individual.*

- 1. A nutritional evaluation may include:
  - (a) Vitamin, mineral and/or amino acid analysis of blood, urine, or body tissue,*
  - (b) Functional Intracellular Analysis (FIA), and*
  - (c) Laboratory assisted analysis.**
- 2. Treatment must include dietary recommendations and may include supplement of vitamins, minerals, amino acids, and/or protomorphogens.*
