TEMPORARY REGULATION OF THE NEVADA STATE  
BARBERS' HEALTH AND SANITATION BOARD

The Nevada State Barbers' Health and Sanitation Board is proposing the Amendment of the following:

**Chapter 643 of NAC** is hereby amended as set forth in these regulations.

Explanation—Matter in bold print and underlined is new, matter in parenthesis ( ) is material to be omitted.

643.030 is hereby amended by adding thereto a new section to read as follows:

***643.030 Training required before taking examination***

1. An apprentice must complete 18 months of full-time apprenticeship under the direct supervision of a registered barber before taking the examination for a license as a registered barber.
2. To receive credit for full-time work, the apprentice must work at least 40 hours per week. Twelve working days in the 18-month period will be allowed for vacation, sickness or emergencies.
3. For the purposes of this section, "apprenticeship under the direct supervision" means work in a licensed barbershop with a registered barber who is in direct charge and operation of the shop as defined in NAC 643.300.
- 4. After an applicant has successfully passed the apprentice examination prescribed by the board, then he or she must immediately began to serve and complete 18 months of full time apprenticeship under the direct supervision of a registered barber in this state, then take the examination to be licensed as a registered barber. Failure to comply could cause an apprentice to loose his or her privilege to practice as an apprentice.**

643.050 is hereby amended by adding thereto a new section to read as follows:

***643.050 Apprentice required to take examination when apprenticeship expires.*** A registered apprentice shall come before the board at the expiration of his apprenticeship for examination to receive his certification to practice as a registered barber.

- 1. An apprentice shall test for his or hers registered barbers license after completion his or hers apprenticeship not to exceed 6 months or 2 regular exams after the apprenticeship has been completed or must surrender their apprentice license and submit to retest.**
- 2. Time allowed is not to exceed 6 months or 2 regular exams.**
- 3. Failure to comply with Sections 1 and 2 of 643.050 will cause his or hers apprenticeship license to become void.**
- 4. To restore an apprentice license that has been voided by failure to comply with 643.050 Sections 1 and 2, may have his or her apprentice license restored after submitting to and passing an apprentice examination.**

643.170 is hereby amended to read as follows:

***643.170 Fee for replacement of certificates or renewal applications.***

The board will replace a lost certificate of registration or a renewal application issued with a certificate upon the receipt of a fee of (\$5) \$20.

**643.181 Good cause for failure to appear for examination.**

**The board defines “good cause”: Personal illness, auto accident, death or severe illness in the immediate family or other severe physical or emotional hardship. Any condition to be considered good cause by the board must be verified in writing (i.e., letter from a physician, official accident report, obituary notice.)**

643.200 is hereby amended to read as follows.

***643.200 Fees for initial license, renewal of license and restoration of license.***

1. The fee for a license to operate a barbershop or to renew the license is (\$40) \$50 if the license is for 6 months or more. If the license is for less than 6 months, the fee is \$15.
2. A licensee whose license has expired may restore it by paying the license fee and a restoration fee of (\$40) \$50.

643.210 is hereby amended to read as follows:

***643.210 Fee for replacement of license or renewal applications.*** The board will replace a license to operate a barbershop or a renewal application issued with a license upon the receipt of a fee of (\$5) \$20.

643.230 is hereby amended to read as follows:

***643.230 Limitation on number of apprentices employed.*** Each barber may employ apprentices in the ratio of one apprentice to each registered barber working in the barbershop, but may not employ more than (two) six apprentices in a shop.

643.330 is hereby amended by adding thereto a new section to read as follows:

**643.330 Plumbing connections.** A barbershop must have suitable connections for the disposal or sewage.

**1. All barber shops must have wash basins within 3 feet of their work area immediately behind the barbers chair there must be a minimum of one wash basin for two barbers, and the wash basins can be located between the two.**

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) 643.

**1. A description of how public comment was solicited, a summary of the public response, and an explanation how other interested persons may obtain a copy of the summary.**

Notices concerning the adoption of proposed regulations were sent to all public libraries throughout the state at least 30 calendar days prior to the public workshop and hearing. The public workshop and hearing was also noticed in the Review Journal newspaper.

There was no comments from the public.

**The number of persons who:**

(a) **Attended each hearing;** 0

(b) **Testified at each hearing; and** 0

(c) **Submitted to the agency written statements:** There were no written statements submitted to the board.

**2. A description of how comment was solicited from affected businesses, a summary of their response, and an explanation how other interested persons obtain a copy of the summary.**

Notices concerning the adoption of proposed regulations were all posted, and the board received no comment from the public or any businesses. No written comments were received.

**3. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulations without change.**

No one submitted comments, therefore the board adopted the changes as posted.

**4. The estimated economic effect of the regulation on the business which it is to regulate and on the public. These must be stated separately, and in each case must include:**

(a) **Both adverse and beneficial effects; and**

(b) **Both immediate and long-term effects.**

Regulated Businesses: The estimated immediate economic effect would be an additional \$15 to replace a lost license, and an additional \$10 to operate a barbershop every other year.

Public: The businesses may pass some of its increased costs on to the consumer but it is estimated that the economic effect, either adverse or beneficial, immediate or long-term, would be minimal.

**5. The estimated cost to the agency for enforcement of the proposed regulations.**

There is no additional cost to the Board for enforcement of this regulation.

**6. A description of any regulations of other state or government agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. If the regulation overlaps or duplicates a federal regulation, the name of the regulating federal agency.**

There are no other state or government agency regulations which the proposed regulation duplicates.

**7. If the regulation includes provisions which are more stringent than a federal regulation which regulates the same activity, a summary of such provisions.**

The regulation contains no provisions which are more stringent than the federal regulation which regulates the same activity.

**8. If the regulation provides a new fee or increase an existing fee, the total annual amount the agency expects to collect and the manner in which the money will be used.**

Based on the number of lost licenses in 1997 the board expects to collect \$90 in 1999. For the increase in Barber Shop licenses, based on the number of barber shops that renewed in 1997 the board expects to collect \$2420.00 in 1999. The money will be used to defer the additional costs of day to day operations of the board.
