

**ADOPTED REGULATION OF THE COMMISSION ON
PROFESSIONAL STANDARDS IN EDUCATION**

Effective August 25, 2004

AUTHORITY: §1, NRS 391.019.

A REGULATION relating to educational personnel; requiring that a license issued or renewed by the Superintendent of Public Instruction be assigned a unique license number; and providing other matters properly relating thereto.

Section 1. Chapter 391 of NAC is hereby amended by adding thereto a new section to read as follows:

Any license issued or renewed by the Superintendent of Public Instruction must be assigned a unique identification number that is not based on the social security number of the licensee.

Notice of Workshop to Solicit Comments on Proposed Regulations was sent to approximately 100 individuals and educational organizations. One workshop was held on July 16, 2004. There were no comments from the public.

The Notice of Intent to Act Upon a Regulation for public hearing and adoption of the proposed revisions to NAC 391.305 were sent to approximately 100 individuals and educational organizations. The public hearing was conducted on July 16, 2004 to provide the opportunity for comments by affected parties and the public. There were no comments from the public. The Commission adopted the proposed regulation.

Comments were solicited through the workshop notice of June 16, 2004, and the public hearing notice of June 16, 2004. At the July 16, 2004 Workshop to Solicit Comments, there were no public comments to the proposed language revisions. At the July 16, 2004 Public Hearing there were no public comments to the proposed language.

Summary of Comments:

Workshop/Public Hearing Comments:

Donna Brothers, Department of Education Teacher Licensure, stated that this new regulation would protect the privacy of teachers and provide a random license number, previously social security numbers were placed on the license.

The Commission on Professional Standards in Public Education adopted the proposed regulation language at the public hearing held July 16, 2004. The reason for adopting the regulation is to protect the privacy of teachers and provide a random license number.

There is a beneficial economic effect for teachers is that their social security numbers will no longer be listed on their teaching license and the unique random number allows for privacy for the teacher. There is no estimated economic effect on the public, either adversely or beneficially, nor immediate or long term.

There is no additional cost to the agency for enforcement of this regulation.
