**ADOPTED TEMPORARY AMENDMENTS TO REGULATIONS OF  
CHECK-CASHING AND DEFERRED DEPOSIT SERVICES  
BY THE FINANCIAL INSTITUTIONS DIVISION**

**Purpose:** To amend chapter 604 of the Nevada Administrative Code to provide for the assessment for costs related to the performance, review and conduct of independent audits and examinations by the Division's employed certified public accountant pursuant to chapter 658.055 of the Nevada Revised Statutes.

**Section 1.** Chapter 604 of the NAC is hereby amended by adding thereto, the provisions set forth as section 2, inclusive, of this regulation.

**Section 2.** A new section is hereby added for the assessment for costs related to audits and examination to read as follows:

- 1. Each registrant shall pay to the division an annual assessment in an amount calculated in accordance with NAC 658.030 to cover the costs related to the employment of a certified public accountant and the performance, review or conduct of audits and examinations conducted by the division.*
- 2. The division shall bill each registrant for the assessment. The assessment must be paid within 30 calendar days after the date the bill is received.*
- 3. A charge of 10 percent of the assessment will be imposed on any registrant whose assessment is received by the division after the date on which the assessment is due. The commissioner may waive the penalty for good cause.*

The Division of Financial Institutions of the Department of Business and Industry adopted regulations assigned LCB File No. T015-04 which pertain to chapter 604 of the Nevada Administrative Code on October 20, 2004.

The following statement is submitted for adopted amendments to Nevada Administrative Code chapter 604.

Public comment was also solicited by posting notices of the workshop and hearing at public libraries throughout the state. The regulation was adopted with one grammatical change.

**A. Estimated economic effect on regulated business:**

**(a). Adverse and beneficial effects:**

It is estimated that the proposed regulations to be adopted and amended would have a negligible economic effect on registrants. An annual assessment to cover the costs related to the employment of a certified public accountant in the performance, review or conduct of audits and examinations conducted by the Division is statutorily required.

**(b). Immediate and long-term effects:**

The proposed regulations to be adopted and amended will have similar immediate and long-term effects for registrants.

**B. Estimated economic effect on the public:**

**(a). Adverse and beneficial effects:**

The annual assessment is levied upon registrants for duties performed by the Division's certified public accountant in the performance of his duties for the continued protection to consumers of the State and should therefore not have a negative economic effect on the public.

**(b). Immediate and long-term effects:**

The proposed regulations to be adopted and amended will have similar immediate and long-term effects for the public.

**6. The estimated cost to the agency for enforcement of the proposed regulation:**

The estimated cost to the Financial Institutions Division for enforcement of the proposed regulations should be negligible.

**7. A description of any regulations of the state or government agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. The proposed regulations do not overlap or duplicate any regulations of other state or local government agencies or of any federal agency.
