

**ADOPTED REGULATION OF THE
COMMISSIONER OF INSURANCE**

Effective June 28, 2006

AUTHORITY: §1, NRS 679B.130; §2, NRS 689A.740; §3, NRS 679B.130 and 689C.155.

A REGULATION relating to insurance; revising the address of the Division of Insurance of the Department of Business and Industry; and providing other matters properly relating thereto.

Section 1. NAC 686B.445 is hereby amended to read as follows:

686B.445 1. A filing by an insurer that refers to a reference filing of prospective loss costs made by a rate service organization must include, in the following order, a reference filing adoption form and a summary of supporting information.

2. The reference filing adoption form is available from the Department of Business and Industry, Division of Insurance, ~~[1665 Hot Springs Road,]~~ *788 Fairview Drive, Suite 300*, Carson City, Nevada ~~[89710.]~~ *89701*.

Sec. 2. NAC 689A.435 is hereby amended to read as follows:

689A.435 1. The Commissioner hereby adopts by reference “Bulletin No. 87-4, Policy and Form Filing Procedures,” excluding paragraphs (c), (d) and (e) of subsection 3 of the bulletin. A copy of the bulletin may be obtained at no cost from the Department of Business and Industry, Division of Insurance, ~~[1665 Hot Springs Road, No. 152,]~~ *788 Fairview Drive, Suite 300*, Carson City, Nevada ~~[89706.]~~ *89701*.

2. An individual carrier that is required to file with the Commissioner its basic health benefit plans and standard health benefit plans pursuant to NRS 689A.655 shall comply with the filing procedures set forth in the publication adopted in subsection 1 and shall stamp “HIPAA” on the FFD100 form which is required to be filed pursuant to that publication.

Sec. 3. NAC 689C.125 is hereby amended to read as follows:

689C.125 1. The Commissioner hereby adopts by reference “Bulletin No. 87-4, Policy and Form Filing Procedures,” excluding paragraphs (c), (d) and (e) of subsection 3 of the bulletin. A copy of the bulletin may be obtained at no cost from the Department of Business and Industry, Division of Insurance, ~~[1665 Hot Springs Road, No. 152,]~~ *788 Fairview Drive, Suite 300*, Carson City, Nevada ~~[89706.]~~ *89701*.

2. A carrier that is required to file with the Commissioner its basic health benefit plans and standard health benefit plans pursuant to NRS 689C.157 shall comply with the filing procedures set forth in the publication adopted in subsection 1 and shall stamp “HIPAA” on the FFD100 form which is required to be filed pursuant to that publication.

INFORMATIONAL STATEMENT

A hearing was held on May 18, 2006, at the offices of the Department of Business and Industry, Division of Insurance (Division), 788 Fairview Drive, Suite 300, Carson City, Nevada 89701, with a simultaneous video-conference conducted at the Bradley Building, 2501 E. Sahara Avenue, Manufactured Housing Division Conference Room, 2nd Floor, Las Vegas, Nevada 89104, regarding the adoption of the regulation concerning address change for the Division.

Public comment was solicited by posting notice of the hearing in the following public locations: 788 Fairview Drive, Legislative Counsel Bureau, Capitol Building Lobby, Blasdel Building, Carson City Courthouse, State Library, Clark County Library, Capitol Press Room and the Division's Las Vegas Office.

The Division maintains a list of interested parties, comprised mainly of insurance companies, agencies and other persons regulated by the Division. These persons were notified of the hearing and that copies of the regulation could be obtained from or examined at the offices of the Division in Carson City.

The hearing was attended by one individual. Oral testimony was provided by Van Mouradian, representing the Division. The Division did not receive any written comments.

The economic impact of the regulation is as follows:

The Division will not incur any additional expense to enforce this regulation.

The Division is not aware of any overlap or duplication of the regulation with any state, local or federal regulation.
