**ADOPTED TEMPORARY REGULATION OF

Adoption of Nevada Administrative Code 640B PROPOSED CHANGES IN FEES,

As required by NRS 640B.410 fees established by the Board are as follows:

1. *An applicant shall pay the following fees:*
 - a. *Initial application for licenses will be \$300.00 for a period of one licensing year or portion thereof.*
 - b. *Reinstatement of an expired license: \$300.00*
2. *A licensee shall pay the following fees:*
 - a. *Change of name on a license: \$25.00*
 - b. *Duplicate of a lost license: \$25.00*
 - c. *Failure to notify board of personal address change within 30 days of change: \$75.00*
 - d. *Failure to notify board of business address change within 30 days of change: \$75.00*
3. *License renewals*
 - a. *Annual renewal of a license occurs June 30 for a fee of \$150.00.*
 - b. *A late fee for annual renewals beyond the June 30 deadline is \$75.00.*
 - c. *If renewal is not made the license will expire.*
4. *General Fees*
 - a. *The fee for a list of business addresses of licensees is \$25.00*
 - b. *The fee for list of business addresses of licensees on mailing labels is \$100.00*
 - c. *The fee for a dishonored check is \$25.00*
5. *General Fee information*
 - a. *Fees shall not be refundable.*
 - b. *Necessary fees shall accompany applications or appropriate documentation.*

NOTICE OF ADOPTION OF TEMPORARY REGULATION

The Nevada State Board of Athletic Trainers adopted temporary regulations assigned LCB File No. T009-07 which pertain to chapter 640B of the Nevada Administrative Code on January 16, 2007.

INFORMATIONAL STATEMENT

The following informational statement is submitted for adopted amendments to Nevada Administrative Code (NAC) 640B.

1. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.

Public comment was solicited at a workshop held November 28, 2006. The Nevada State Board of Athletic Trainers held a public hearing at 9:00am., on January 16, 2007 at University of Nevada, 1664 N. Virginia St., Pennington Bldg. Room 20, Reno, NV 89557 and University of Nevada Las Vegas, 4505 Maryland Parkway, College of Education Bldg. Room 216, Las Vegas, NV 89154 to review the regulation to specify fee requirements for the licensing of athletic trainers. No members of the public were present at the public hearing.

The purpose of the hearing was to receive comments from all interested persons regarding the adoption of regulations that pertain to chapter **640B** of the Nevada Administrative Code.

A copy of this notice and the regulation to be adopted were on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the regulation to be adopted were made available at: The Nevada State Board of Athletic Trainers, P.O. Box 34296, Reno, NV 89533-4296 and in all counties in which an office of the agency is not maintained, at the main public library, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation were also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653 and on the Internet at <http://www.leg.state.nv.us>. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary. This does not apply to a public body subject to the Open Meeting Law.

The hearing was attended by four (4) board members, the Executive Secretary of the Board, a representative from the Attorney General's office (via teleconference). There were no members of the public present. There were no written comments submitted to the agency.

Persons wishing to comment upon the proposed action of the Nevada State Board of Athletic Trainers may appear at the scheduled public hearing or may address their comments, data, views, or arguments in written form to the Nevada State Board of Athletic Trainers, P.O. Box 34296, Reno, NV 89533-4296. Written submissions must be received by the Nevada State Board of Athletic Trainers on or before January 16, 2007 at 9:00am. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Nevada State Board of Athletic Trainers may proceed immediately to act upon any written submissions. There were no responses received from affected businesses.

4. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.

The regulation was adopted at the Nevada State Board of Athletic Trainers hearing on January 16, 2007 with changes to proposed amendments deferred by the Board.

5. The estimated economic effect of the adopted regulation on the businesses that it is to regulate and on the public. These must be stated separately, and each case must include:

This new regulation will generate funds to operate the Nevada State Board of Athletic Trainers. There will be no economic impact on businesses or the public.

The Board of Athletic Trainers is not aware of any similar regulations of other state or government agencies that the proposed regulation overlaps or duplicates.

The Board of Athletic Trainers is not aware of any similar regulations of the same activity in which the Federal regulation is more stringent.

The regulation does not increase existing fees. This new regulation will generate funds to operate the Nevada State Board of Athletic Trainers.
