**PROPOSED REGULATION OF
THE STATE CONTROLLER**

Notice of Workshop to Solicit Comments on Proposed Regulation

The Nevada State Controller, 101 N. Carson Street, Suite 5 Carson City, Nevada 89701 (775) 684-5750 is proposing the Amendment of regulations pertaining to chapter 353C of Nevada Administrative Code. A workshop has been set for 1:00 p.m., on August 11, 2009, at the State Capitol Annex 2nd floor, 101 N. Carson Street, Carson City, Nevada with a video conference link to the Grant Sawyer Building Governor's Office Conference Room, 555 E. Washington Ave, Suite 5100, Las Vegas, Nevada. Under NRS 353C.110, as amended by AB 87, the State Controller has authority to adopt regulations to carry out the provisions of that chapter. The State Controller is noticing a workshop to consider changes in the regulations of NAC Chapter 353C that are required or desirable in view of the enactment of AB 87. Topics of proposed regulations will include, but may not be limited to the following:

1. Procedures by which an agency may refuse to transact business with a person who owes a debt to the State of Nevada or any of its agencies, including clarification of whether the Controller can authorize agencies to send notices of offset to debtors, and persons who may be designated by the Controller to conduct offset hearings if requested by debtors.
2. Clarification of when a debt is "past due" for purposes of determining when a debt must be assigned to the State Controller for collection, or for other purposes under the amendments to Chapter 353C.
3. Changes in the Debt Collection Account Placement Format or other procedures by which debts are assigned or transferred to the State Controller for collection.
4. Procedures for writing off bad debts that have been assigned to the State Controller for collection.
5. Procedures by which an agency may request waiver or modification of the procedures for assigning debts to the State Controller for collection under NRS 353C.195, as amended.
6. Application of fees and costs to debts owed to the State or its agencies under the revised NRS 353C.135.
7. Procedures for calculation of the net amount of debts recovered by the State Controller, and transfer to the Debt Recovery Account, pursuant to Section 7 of AB 87.
8. Rates of interest to be used in agreements for installment payments under NRS 353C.130 and Section 7 of AB 87.
