The purpose of this workshop is to solicit comments from all interested persons on the following general topics that may be addressed in the proposed regulations:

Proposed Regulation of the Department of Motor Vehicles, LCB File No. R158-09:

This is a regulation relating to the Department of Motor Vehicles, amending Chapters 482 and 706 of the Nevada Administrative Code (NAC) to comply with Legislation (AB372) passed during the 2009 Legislative Session. The amendments proposed in this regulation allow a person who renews the registration of certain vehicles after conviction of an offense relating to vehicle weight, to request an adjustment to the declared gross weight; requiring certain interstate motor carriers to make payment of certain fees to the Department of Motor Vehicles by cash or certified funds; providing the amount and duration of a bond required of certain motor carriers upon finding of habitual delinquency in payments due the Department; and providing other matters properly relating thereto.

Proposed Regulation of the Department of Motor Vehicles, LCB File No. R159-09:

This is a regulation relating to the Department of Motor Vehicles, amending Chapter 482 of the Nevada Administrative Code (NAC) to comply with Legislation (SB199) passed during the 2009 Legislative Session. The amendments proposed in this regulation make various changes to dates for installment payments for the registration fees for certain fleets of vehicles; and providing other matters properly relating thereto.

Proposed Regulation of the Department of Motor Vehicles, LCB File No. R160-09:

This is a regulation relating to the Department of Motor Vehicles, amending Chapters 360A, and 366, of the Nevada Administrative Code (NAC) to comply with Legislation (SB332) passed during the 2009 Legislative Session. The amendments proposed in this regulation make special fuel manufacturers subject to provisions relating to the licensing, reporting requirements and tax obligations applicable to special fuel users, special fuel suppliers, and special fuel dealers. In addition, this regulation makes the imposition of administrative fines for violations of law mandatory and provides other matters properly relating thereto.

The purpose of this hearing is to receive comments from all interested persons regarding the amendment of regulations that pertain to Chapters 360A, 366, 482 and 706 of the Nevada Administrative Code (NAC).

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. The need for and the purpose of the proposed regulation or amendment:

Each of the proposed regulations pertains to the Department of Motor Vehicles and amends Chapters 360A, 366, 482 and 706 of Nevada Administrative Code (NAC) to

comply with legislation passed during the 2009 Legislative Session (Assembly Bill 372, Senate Bill 199 and Senate Bill 332).

Regulation R158-09: This is a regulation relating to the Department of Motor Vehicles, amending Chapters 482 and 706 of the Nevada Administrative Code (NAC) to comply with Legislation (AB372) passed during the 2009 Legislative Session. The amendments proposed in this regulation allow a person who renews the registration of certain vehicles after conviction of an offense relating to vehicle weight, to request an adjustment to the declared gross weight; requiring certain interstate motor carriers to make payment of certain fees to the Department of Motor Vehicles by cash or certified funds; providing the amount and duration of a bond required of certain motor carriers upon finding of habitual delinquency in payments due the Department; and providing other matters properly relating thereto.

Regulation R159-09: This is a regulation relating to the Department of Motor Vehicles, amending Chapter 482 of the Nevada Administrative Code (NAC) to comply with Legislation (SB199) passed during the 2009 Legislative Session. The amendments proposed in this regulation make various changes to dates for installment payments for the registration fees for certain fleets of vehicles; and provide other matters properly relating thereto.

Regulation R160-09: This is a regulation relating to the Department of Motor Vehicles, amending Chapters 360A, and 366, of the Nevada Administrative Code (NAC) to comply with Legislation (SB332) passed during the 2009 Legislative Session. The amendments proposed in this regulation make special fuel manufacturers subject to provisions relating to the licensing, reporting requirements and tax obligations applicable to special fuel users, special fuel suppliers, and special fuel dealers. In addition, this regulation makes the imposition of administrative fines for violations of law mandatory and provides other matters properly relating thereto.

2. Either the terms or the substance of the regulations to be adopted, amended or repealed, or a description of the subjects and issues involved:

The Department is required by statute to amend regulations relating to the administration, taxation and enforcement of:

Regulation R158-09: The Department is required by statute to amend regulations relating to the registration, administration, and enforcement of motor carrier vehicle registrations. This regulation allows a person who had previously been convicted of an offense relating to vehicle weight, to apply for an adjustment to their declared gross vehicle weight upon registration renewal. Secondly, this regulation provides for the remittance of certain payments imposed by the Motor Carrier Division to be paid using cash or certified funds. Lastly, this regulation also requires the imposition of a bond upon certain motor carriers found to be habitually delinquent.

Regulation R159-09: The Department is required by statute to amend regulations relating to the registration, administration, and enforcement of motor vehicle registrations. This regulation pertains to motor vehicle registrations, revising certain registration requirements for farm vehicles and revising dates for fleet installment payments.

Regulation R160-09: The Department is required by statute to amend regulations relating to the administration, taxation and enforcement of special fuels. This regulation pertains to special fuel manufacturers imposing provisions relating to licensing, reporting requirements and tax obligations applicable to special fuel users, special fuel suppliers, and special fuel dealers. In addition this regulation also provides for the imposition of administrative fines for law violations.

3. The estimated economic effect of the regulation on the business which it is to regulate and on the public. These must be stated separately and in each case must include:

(a) Both adverse and beneficial effects: (None) there are no anticipated adverse or beneficial economic effects resulting from the passage of these regulations.

(b) Both immediate and long-term effects: (None) there are no anticipated immediate or long-term economic effects resulting from the passage of these regulations.

4. The estimated cost to the agency for enforcement of the proposed regulation:

There is no cost to the agency in the enforcement of the proposed regulations.

5. A description of and citation to any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. If the proposed regulation overlaps or duplicates a federal regulation, the notice must include the name of the regulating federal agency:

The proposed amendments within these regulations do not overlap that of any other state, local, or federal governmental agency.

6. If the regulation is required pursuant to federal law, a citation and description of the federal law:

These regulations are not required pursuant to federal law.

7. If the regulation includes provisions which are more stringent than a federal regulation that regulates the same activity, a summary of such provisions:

The proposed amendment does not include provisions which are more stringent than a federal regulation.

8. Whether the proposed regulation establishes a new fee or increases an existing fee:

The proposed amendment does not establish a new fee or increase an existing fee.

Written submission must be received by Department of Motor Vehicles on or before **March 17, 2010**. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Department of Motor Vehicles may proceed immediately to act upon any written submissions.

A copy of this notice and the regulations to be adopted will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and regulations to be adopted will be available at each of the Department of Motor Vehicles listed, and at the main public libraries listed, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at <http://leg.state.nv.us/Register/>. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
