

**PROPOSED REGULATION OF THE
BOARD OF WILDLIFE COMMISSIONERS**

COMMISSION GENERAL REGULATION 375

EXPLANATION – Matter in *italics* is new; matter in brackets ~~omitted material~~ is material to be omitted.

AUTHORITY: NRS 501.105, 501.181, 502.030, 502.090, AB246, SB411

A REGULATION to establish provisions for and apprentice hunting license pursuant to the provisions of Assembly Bill No. 246, Senate Bill 411, CA24 of the 76th Legislative Session.

Notes:

Valid period: This is a “license” the valid period is defined in NRS 502.090 for licenses.

Parental signature: Since this is an annual license NRS 502.060 covers the requirement.

The signature line will display on the license like other licenses.

Much of this language was pulled from the resident and nonresident license requirements with some changes to fit this license.

Section 1. *Chapter 502 of NAC is hereby amended by adding thereto the provisions set forth as sections 2 and 12 of this regulation.*

Sec 2. *An application for an apprentice license is available to both residents and nonresidents of the State of Nevada pursuant to the provisions set forth in Assembly Bill No. 246, Senate Bill 411, CA 24 of the 75th Legislative Session and this regulation.*

Sec 3. *A license agent may require an applicant for an apprentice license to provide reasonable proof of the applicant’s identity before issuing an apprentice license to the applicant. Such proof may include, but is not limited to, a driver’s license or other identification containing a photograph of the applicant.*

Sec 4. *The license agent shall correctly enter the required information on the original and all copies of the apprentice license issued to the applicant. The information must include:*

(a) The applicant's legal name, mailing address, street address, city, county, state and zip code;

(b) The applicant's social security number, unless the applicant is a citizen of a country other than the United States;

(c) The month, day, year and time the apprentice license is issued to the applicant;

(d) A description of the applicant, including his height, weight, sex and date of birth;

(e) The license agent's account number and the initials of the person who issues the license or permit.

(f) A place for the applicant to acknowledge their eligibility for the apprentice license pursuant Assembly Bill No. 246, Senate Bill 411, CA 24 of the 76th Legislative Session and this regulation.

Sec 5. *The license agent shall enter on the license the number of the driver's license of the applicant and the state of its issuance if the applicant holds a driver's license.*

Sec 6. *In lieu of issuing an apprentice license, the Department may issue such a license in the form of a temporary authorization number pursuant to NAC 502.271. A temporary authorization number issued pursuant to this subsection may be used only:*

(a) By the person for whom it is issued; and

(b) On the dates of validity of the temporary authorization number.

Sec 7. *The apprentice hunter is limited to being accompanied and directly supervised by only one mentor in the field.*

Sec 8. *An application for a mentor hunter affidavit to supervise an apprentice license hunter is available to both residents and nonresidents of the State of Nevada pursuant to the*

provisions set forth in Assembly Bill No. 246, Senate Bill 411, CA 24 of the 76th Legislative Session and this regulation.

Sec 9. *The application form for a mentor hunter affidavit must include the following information:*

(a) The applicant's legal name, mailing address, street address, city, county, state and zip code;

(b) The month, day, year and time the affidavit is issued to the applicant;

(c) A description of the applicant, including his height, weight, sex and date of birth;

(d) The class and number of the current Nevada hunting license or permit which the applicant currently possesses. The hunting license must not be an apprentice hunting license.

(e) The license agent's account number and the initials of the person who issues the affidavit;

(f) The name of the apprentice license hunter they are accompanying and directly supervising.

(g) A place for the mentor hunter to sign the affidavit acknowledging their eligibility and responsibilities as a mentor hunter pursuant to Assembly Bill No. 246, Senate Bill 411, CA 24 of the 76th Legislative Session and this regulation.

Sec 10. *Once issued a mentor hunter affidavit is valid:*

(a) From the first day of March immediately following the date of issuance until the end of the next succeeding February; or

(b) From the date of issuance to the end of the next succeeding February.

(c) For one apprentice license holder.

Sec 11. *The mentor hunter must carry on their person while hunting the affidavit identifying the apprentice hunter they are accompanying and directly supervising.*

Sec. 12. *A mentor hunter may possess affidavits for more than one apprentice license hunter. The mentor hunter is limited to accompanying and directly supervising only one apprentice license hunter in the field.*
