STATE REGISTRAR OF VITAL STATISTICS**

PROPOSED AMENDMENT TO NAC 440 – VITAL STATISTICS

The Office of Vital Statistics within the Health Division’s Bureau of Health Statistics, Planning and Emergency Response is requesting approval to amend regulations for Chapter 440 Vital Statistics in response to the amendment of Nevada Revised Statutes (NRS) 440 – Vital Statistics during the 26th Special Legislative Session. Assembly Bill 6, Section 43 and Section 44 moved the fees for Vital Statistics functions from NRS 440 into NAC 440 with fees to be established and approved by the State Registrar. The current fee structure does not accurately reflect the cost of doing business and has not been updated since 1997. The new approval process will allow the Office of Vital Records to monitor, revise and establish the fees as indicated in NRS 440.175 and NRS 440.700.

The regulation establishes the fees a health district must remit to the Office of Vital Statistics for issuance and registration of records registered in their district and fees collected by the Office of Vital Statistics from the public for issuance and amendments of vital records.

Proposed Regulation:

Section 1.

- 1. A health district shall remit to the State Registrar:*
 - (a) For each registration of a birth or death in its district).....\$2*
 - (b) For each copy issued of a certificate of birth in its district, other than a copy issued pursuant to paragraph (a).....\$7*
 - (c) For each copy issued of a certificate of death in its district.....\$1*
- 2. Except as otherwise provided in NRS 440.700, the State Registrar shall charge and collect the following fees:*
 - (a) For searching the files for one name, if no copy is made.....\$10*
 - (b) For verifying a vital record.....\$10*
 - (c) For establishing and filing a record of paternity (other than a hospital-based paternity), and providing a certified copy of the new record.....\$40*
 - (d) For a certified copy of a record of birth.....\$20*
 - (e) For a certified copy of a record of death originating in a county in which the board of county commissioners has not created an account for the support of the office of the county coroner pursuant to NRS 259.025.....\$20*
 - (f) For a certified copy of a record of death originating in a county in which the board of county commissioners has created an account for the support of the office of the county coroner pursuant to NRS 259.025.....\$20*
 - (g) For correcting a record on file with the State Registrar and providing a certified copy of the corrected record.....\$40*

<i>(h) For replacing a record on file with the State Registrar and providing a certified copy of the new record.....</i>	<i>\$40</i>
<i>(i) For filing a delayed certificate of birth and providing a certified copy of the certificate.....</i>	<i>\$40</i>
<i>(j) For the services of a notary public, provided by the State Registrar.....</i>	<i>\$2</i>
<i>(k) For an index of records of marriage provided on microfiche to a person other than a county clerk or a county recorder of a county of this State.....</i>	<i>\$200</i>
<i>(l) For an index of records of divorce provided on microfiche to a person other than a county clerk or a county recorder of a county in this State.....</i>	<i>\$100</i>
<i>(m) For compiling data files which require specific changes in computer programming.....</i>	<i>\$500</i>
