

**PROPOSED REGULATION OF THE
COMMISSIONER OF INSURANCE**

A REGULATION relating to insurance; revising requirements relating to the filing of various rates, rules, forms or plans; revising requirements relating to the payment of various fees; and providing other matters properly relating thereto.

Section 1. NAC 686B.100 is hereby amended to read as follows:

686B.100 *1.* Any *rate, rule or form* required to be filed pursuant to the provisions of chapter 686B of NRS ~~[may]~~ *must* be filed in accordance with the System for Electronic Rate and Form Filing developed and implemented by the National Association of Insurance Commissioners.

2. Any fee required when filing a rate, rule or form pursuant to NRS 680B.010 must be paid using the Electronic Funds Transfer function within the System for Electronic Rate and Form Filing.

Sec. 2. NAC 687B.004 is hereby amended to read as follows:

687B.004 *1.* Any form required to be filed pursuant to the provisions of NRS 687B.120 ~~[-
1.—Must]~~ *must* be filed in accordance with ~~[the]~~ :

(a) The current bulletin issued by the Division that addresses life and health form filing procedures ; ~~[and with the National Association of Insurance Commissioners’ “Uniform Life,~~

~~Accident and Health, Annuity, Credit Transmittal Document,” which is required to be filed pursuant to that bulletin;]~~ and

~~[2. May be filed in accordance with the]~~ (b) *The* System for Electronic Rate and Form Filing developed and implemented by the National Association of Insurance Commissioners.

2. Any fee required when filing a rate, rule or form pursuant to NRS 680B.010 must be paid using the Electronic Funds Transfer function within the System for Electronic Rate and Form Filing.

Sec. 3. NAC 689A.435 is hereby amended to read as follows:

689A.435 An individual carrier that is required to file with the Commissioner its basic health benefit plans and standard health benefit plans pursuant to NRS 689A.655 shall comply with the filing procedures set forth in the current bulletin issued by the Division that addresses life and health form filing procedures . ~~[and shall stamp “HIPAA” on the National Association of Insurance Commissioners’ “Uniform Life, Accident and Health, Annuity, Credit Transmittal Document,” which is required to be filed pursuant to that bulletin.]~~

Sec. 4. NAC 689C.125 is hereby amended to read as follows:

689C.125 A carrier that is required to file with the Commissioner its basic health benefit plans and standard health benefit plans pursuant to NRS 689C.157 shall comply with the filing procedures set forth in the current bulletin issued by the Division that addresses life and health form filing procedures . ~~[and shall stamp “HIPAA” on the National Association of Insurance Commissioners’ “Uniform Life, Accident and Health, Annuity, Credit Transmittal Document,” which is required to be filed pursuant to that bulletin.]~~

Sec. 5. This regulation becomes effective on December 31, 2010.
