R026-10: Proposes to allow certain emissions test stations a method to request from the Department permission to revise their business days of operation; This workshop is scheduled to solicit comments from all interested persons on the proposed amendments addressed in NAC 445B.472, NAC 445B.480 and 482.760.

R027-10: Revising certain provisions governing violations of law by an approved inspector or other employee of an emissions test station; This workshop is scheduled to solicit comments from all interested persons on the proposed amendments addressed in NAC 445B.4985

subsection 1 and NAC 445B.7035 subsections 1 and 3. The proposed amendments will broaden the scope of the types of subsequent violations which are committed by a licensee of the Department and allow hand delivery of a preliminary notice.

R136-10: Proposes various changes to provisions relating to the Advisory Committee on the Control of Emissions from Motor Vehicles; This workshop is scheduled to solicit comments from all interested persons on the proposed amendments addressed in NAC 445B.853 subsection 2, NAC 445B.853 subsection 3 and NAC 445B.855 subsection 1(a). The proposed amendments will change the membership status of the committee, add a co-chair of the committee to regulation and also change expiration dates for member appointments.

R137-10: Proposes revisions for the requirements to access to the state electronic data transmission system by an approved inspector of emissions. This workshop is scheduled to solicit comments from all interested persons on the proposed amendment addressed in NAC 445B.493 subsection 6(b4), NAC 445B.4983 subsection 1, and subsection 2.
