NOTICE OF INTENT TO ACT UPON A REGULATION

**Notice of Hearing for the Amendment of Regulations of the
Committee on Testing for Intoxication.**

The Committee on Testing for Intoxication will hold a public hearing at 10:00am on Tuesday, January 11th, 2011 at the Nevada State Library and Archives, 100 N. Stewart St., Carson City, Nevada (Board Room, Main Floor). The purpose of the hearing is to receive comments from all interested persons regarding the Amendment of regulations that pertain to chapter 50 and 484 of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. NAC 50.010 and 50.015 are amended to specifically state a “court of record” in place of “District Court”. This amendment will match the language in Chapter 50 of NRS. (approved version attached)

NAC 484.596 amends the requirement for 24 semester hours of chemistry by adding the option of 18 semester hours of chemistry plus one year of full-time experience which has been approved by the Committee and is related to the forensic analysis of alcohol. (approved version attached)

2. The proposed regulation is a permanent regulation. The approved version of the text of the proposed regulation may be obtained by contacting John R. Johansen:

3. The proposed regulation applies to the two (2) law enforcement crime laboratories within the state, as such, there is no impact on small business and does not restrict the operation, formation, or expansion of small business.
4. There is no economic effect on the regulated laboratories.
5. There is no cost to enforcing the regulation.

6. There is no known overlap to other federal, state or local regulations.
7. The proposed regulation is not required by federal law.

9. This proposed regulation does not create a new fee or change in anyway existing fees.
