**Notice of Workshop to Solicit Comments on Proposed Regulation**

The Office of the Nevada Attorney General, 100 North Carson Street, Carson City, Nevada, (775) 684-1100, is proposing the amendment of regulations pertaining to chapter 205 of the Nevada Administrative Code. A workshop has been set for 2:00 p.m., on Monday, October 17, 2011, at the Nevada Attorney General's Office, 100 North Carson Street, Mock Courtroom, Carson City, Nevada, and via video conferencing at the Nevada Attorney General's Office, 555 East Washington Avenue, Room 4500, Las Vegas, Nevada. The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

To amend the existing regulations to reflect the change in the name of the Identity Theft Passport program to the Identity Theft Program Card, pursuant to NRS 205.4651.
