

**REVISED SMALL BUSINESS IMPACT STATEMENT AS REQUIRED BY
NRS 233B.0608/233B.0609**

- 1. A description of the manner in which comment was solicited from affected small businesses, a summary of their response and an explanation of the manner in which other interested persons may obtain a copy of the summary.**

This regulation change does not apply to small businesses. The Commission on Peace Officers' Standards and Training has authority to adopt regulations for the certification, decertification, training and selection of peace officers. The regulations apply to peace officers and the governmental agencies that employ them. This regulation requires a peace officer to satisfy certain requirements annually in order to maintain a basic or reserve certificate, including completion of in-service training.

On 02/09/2017 a Workshop was held to discuss the proposed changes. There were no public comments.

- 2. The manner in which the analysis was conducted, including the methods used to determine the impacts of the proposed regulation on small business, and reasons for the conclusions of the agency.**

There is no impact on small business or agencies. The Commission on Peace Officers' Standards and Training has authority to adopt regulations for the certification, decertification, training and selection of peace officers. The regulations apply to peace officers and the governmental agencies that employ them. The Commission does not regulate small businesses. The regulation provide clarity for the agencies. Specifically, by specifying that officers are required to show proficiency with each *type* of firearm they are authorized to carry and the requirements when an officer is hired, rehired or reinstated on or after July 1 of a reporting year.

- 3. The estimated economic effect of the proposed regulation on the small businesses which it is to regulate, including, without limitation:**

(a) Both adverse and beneficial effects; and

There is no adverse effects on small businesses as the regulations do not apply to small businesses. The benefits include a clear understanding of what the agencies must do when officers are showing proficiency with each *type* of firearm and is hired, rehired or reinstated on or after July 1 of a reporting year.

(b) Both direct and indirect effects.

There is no direct or indirect effect on small business as the regulations do not apply to small businesses. The direct effect is clear directions and interpretation of regulations for the agencies. The indirect effect would be few to no errors in the process.

There is no impact on small business. The impact on the agencies would be minor transitioning of the update information.
